Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Meddygol Cyffredinol) 1992 ("y prif Reoliadau") sy'n rheoleiddio'r telerau y mae meddygon yn darparu gwasanaethau meddygol cyffredinol o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977.

These Regulations further amend the National Health Service (General Medical Services) Regulations 1992 ("the principal Regulations") which regulate the terms on which doctors provide general medical services under the National Health Service Act 1977.

Mae rheoliad 2 yn diwygio'r rhestr yn Atodlen 10 i'r prif Reoliadau, sy'n rhestru cyffuriau a sylweddau eraill na cheir eu rhagnodi i'w cyflenwi tra'n darparu gwasanaethau fferyllol o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977, drwy dynnu cynhyrchion mwcolytig geneuol penodedig.

Regulation 2 amends the list in Schedule 10 to the principal Regulations, which lists drugs and other substances that may not be prescribed for supply in the course of pharmaceutical services provided under the National Health Service Act 1977, by removing specified oral mucolytic products.

Mae rheoliad 3 yn diwygio Atodlen 11 i'r prif Reoliadau, sy'n rhestru'r cyffuriau a'r sylweddau eraill y gellir eu rhagnodi mewn amgylchiadau penodol yn unig yng nghwrs gwasanaethau fferyllol a ddarperir o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977.

Regulation 3 amends Schedule 11 to the principal Regulations, which lists drugs and other substances that may only be prescribed in certain circumstances in the course of pharmaceutical services provided under the National Health Service Act 1977.

Mae Rheoliad 3(a) yn tynnu cynhyrchion mwcolytig geneuol penodedig oddi ar y rhestr yn Atodlen 11 ac mae rheoliad 3(b) yn ychwanegu Tadalafil (Cialis) ati.

Regulation 3(a) removes specified oral mucolytic products from, and regulation 3(b) adds Tadalafil (Cialis) to, the list in Schedule 11.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd iddo gan adrannau 29 a 126(4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(a) drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred upon it by sections 29 and 126(4) of the National Health Service Act 1977(a) hereby makes the following Regulations:

**Enwi, cychwyn a chymhwyso**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Meddygol Cyffredinol) (Diwygio) (Cymru) 2003, a deuant i rym ar 1 Chwefror 2003.

(2) Yn y Rheoliadau hyn ystyr "y prif Rheoliadau" (*"the Principal Regulations"*) yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Meddygol Cyffredinol) 1992(b).

**Citation, commencement and application**

1.-(1) These Regulations may be cited as the National Health Service (General Medical Services) (Amendment) (Wales) Regulations 2003 and shall come into force on 1st February 2003.

(2) In these Regulations "the principal Regulations" (*"y prif Rheoliadau"*) means the National Health Service (General Medical Services) Regulations 1992(b).

### **Amendment of Schedule 10 to the principal Regulations**

2. In Schedule 10 to the principal Regulations (drugs and other substances not to be prescribed for supply under pharmaceutical services) the following entries shall be omitted-

" Fabrol Granules  
Fluimucil Granules  
Methylcysteine Tablets 100mg  
Mucodyne Capsules  
Mucodyne Syrup  
Mucodyne Forte Syrup  
Mucodyne Forte Tablets  
Mucodyne Paediatric Syrup  
Visclair Tablets".

### **Amendment of Schedule 11 to the principal Regulations**

3. In Schedule 11 to the principal Regulations (drugs to be prescribed under pharmaceutical services only in certain circumstances) -

- (a) the entries relating to-
- (i) Acetylcysteine granules, and
  - (ii) Carbocisteine

shall be omitted, and

- (b) after "Apomorphine Hydrochloride (Uprima)" in columns 1 and 2 respectively, insert

", Tadalafil (Cialis)".
