Mae'r Rheoliadau hyn yn diwygio Rheoliadau Diogelu'r Amgylchedd (Dyletswydd Gofal) 1991 (O.S. 1991/2839) ("y prif Rheoliadau"), fel y'u diwygiwyd gan O.S. 1996/672 ac fel y'u diwygiwyd ymhellach, fel y maent yn gymwys i Gymru a Lloegr, gan O.S. 2000/1973 ac O.S. 2002/1559, i ganiatáu i awdurdodau casglu gwastraff gyflwyno i unrhyw berson y mae'n ofynnol iddo gadw disgrifiad ysgrifenedig o wastraff a nodyn trosglwyddo o dan y prif Rheoliadau hysbysiad sy'n ei gwneud yn ofynnol i'r person hwnnw roi i'r awdurdod casglu gwastraff yn ei swyddfa, o fewn cyfnod penodedig, y disgrifiadau ysgrifenedig hynny o'r gwastraff a'r nodiadau trosglwyddo a bennir yn yr hysbysiad hwnnw.

These Regulations amend the Environmental Protection (Duty of Care) Regulations 1991 (S.I. 1991/2839) ("the primary Regulations"), as amended by S.I. 1996/672 and as further amended, as they apply to England and Wales, by S.I. 2000/1973 and S.I. 2002/1559, to allow waste collection authorities to serve on any person who is required to keep a written description of waste and a transfer note under the primary Regulations a notice requiring that person to furnish to the waste collection authority at its office, within a specified period of time, such written descriptions of waste and transfer notes as are specified in that notice.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 34(5) o Ddeddf Diogelu'r Amgylchedd 1990(a) ac sydd yn awr yn arferadwy gan Gynulliad Cenedlaethol Cymru mewn perthynas â Chymru(b), drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred upon the Secretary of State by section 34(5) of the Environmental Protection Act 1990(a) and now exercisable by the National Assembly for Wales in relation to Wales(b), hereby makes the following Regulations:

Enwi, cychwyn a chymhwysio

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Diogelu'r Amgylchedd (Dyletswydd Gofal) (Diwygio) (Cymru) 2003 a deuant i rym ar 31 Gorffennaf 2003.

Citation , commencement and application

1.-(1) These Regulations may be cited as the Environmental Protection (Duty of Care) (Amendment) (Wales) Regulations 2003 and come into force on 31st July 2003.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru.

(2) The Regulations apply to Wales.

**Diwygio rheoliad 4 o Reoliadau Diogelu'r
Amgylchedd (Dyletswydd Gofal) 1991**

2. Yn rheoliad 4 o Reoliadau Diogelu'r Amgylchedd (Dyletswydd Gofal) 1991(c) -

- (a) yn lle'r geiriau "served by a waste regulation authority" rhodder "served by either a waste regulation authority or an authority which is a waste collection authority for the purposes of Part II of the 1990 Act"; a
- (b) yn lle'r geiriau "furnish the authority with a copy of it at the authority's office" rhodder "furnish that authority with a copy of it at that authority's office".

**Amendment of regulation 4 of the Environmental
Protection (Duty of Care) Regulations 1991**

2. In regulation 4 of the Environmental Protection (Duty of Care) Regulations 1991(c) -

- (a) for the words "served by a waste regulation authority" substitute "served by either a waste regulation authority or an authority which is a waste collection authority for the purposes of Part II of the 1990 Act"; and
- (b) for the words "furnish the authority with a copy of it at the authority's office" substitute "furnish that authority with a copy of it at that authority's office".

(b) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol i Gynulliad Cenedlaethol Cymru, mewn perthynas â Chymru, yn rhinwedd erthygl 2 ac Atodlen 1 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672).

(c) O.S. 1991/2839, fel y'i diwygiwyd gan reoliad 23 o O.S. 1996/972 ac, fel y mae'n gymwys i Gymru a Lloegr, gan reoliad 39 ac Atodlen 10, Rhan 2, paragraff 26 o O.S. 2000/1973 a rheoliad 19 o O.S. 2002/1559. Diwygiwyd y Rheoliadau hefyd, mewn perthynas â'r Alban, gan reoliad 36 o O.S.A. 2000/323, ac mewn perthynas â Lloegr, gan reoliad 3 o O.S. 2003/63.

(b) The functions of the Secretary of State were transferred to the National Assembly for Wales, in relation to Wales, by virtue of article 2 of and Schedule 1 to the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672).

(c) S.I. 1991/2839, as amended by regulation 23 of S.I. 1996/972 and, as it applies to England and Wales, by regulation 39 and Schedule 10, Part 2, paragraph 26 of S.I. 2000/1973 and regulation 19 of S.I. 2002/1559. The Regulations have also been amended, in relation to Scotland, by regulation 36 of S.S.I 2000/323 and, in relation to England, by regulation 3 of S.I. 2003/63.

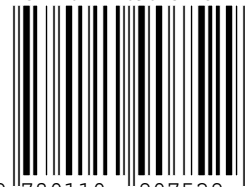
