O dan baragraffau 20 a 21 o Atodlen 5B i Ddeddf Gwasanaeth Iechyd Gwladol 1977 (1977 p.49), fel y'i diwygiwyd gan Atodlen 4 i Ddeddf Diwygio'r Gwasanaeth Iechyd Gwladol a Phroffesiynau Gofal Iechyd 2002 (2002 p.17), mae gan Gynulliad Cenedlaethol Cymru y pŵer i drosglwyddo (neu ddarparu ar gyfer trosglwyddo) unrhyw eiddo, hawliau a rhwymedigaethau sy'n perthyn i Awdurdod Iechyd neu i Ymddiriedolaeth Gwasanaeth Iechyd Gwladol yng Nghymru i Fwrdd Iechyd Lleol.

Mae'r Gorchymyn hwn yn trosglwyddo -

- (a) y tir a'r buddiannau yn y tir a nodir yn Atodlen 1 oddi wrth y perchenogion presennol i'r Byrddau Iechyd Lleol penodol a restrir yn yr Atodlen honno;
- (b) cynnwys yr adeiladau neu rannau o'r adeiladau a nodir yn Atodlen 2 i'r Byrddau Iechyd Lleol penodol a restrir yn yr Atodlen honno;
- (c) unrhyw eiddo hawliau a rhwymedigaethau eraill, yr awdurdodau iechyd Cymreig i Fwrdd Iechyd Lleol Powys; ac
- (ch)pob eiddo, hawl a rhwymedigaeth Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gofal Iechyd Powys a sefydlwyd gan Orchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gofal Iechyd Powys (Sefydlu) 1992 (O.S. 1992/2741) i Fwrdd Iechyd Lleol Powys.

The Local Health Boards (Transfer of Property, Rights and Liabilities) (Wales) Order  
2003

### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

Under paragraphs 20 and 21 of Schedule 5B to the National Health Service Act 1977 (1977 c.49), as amended by Schedule 4 of the National Health Service Reform and Health Care Professions Act 2002 (2002 c.17), the National Assembly for Wales has the power to transfer (or provide for the transfer of) any of the property, rights and liabilities of a Health Authority or a National Health Service Trust in Wales to a Local Health Board.

This Order transfers -

- (a) the land and interests in land set out in Schedule 1 from the present owners to the specific Local Health Boards listed in that Schedule;
- (b) the contents of buildings or parts of buildings set out in Schedule 2 to the specific Local Health Boards listed in that Schedule;
- (c) any other property, rights and liabilities of the Welsh health authorities to the Powys Local Health Board; and
- (d) all property, rights and liabilities of the Powys Health Care National Health Service Trust established by the Powys Health Care National Health Service Trust (Establishment) Order 1992 (S.I. 1992/2741) to the Powys Local Health Board.

Sefydlir Byrddau Iechyd Lleol gan Orchymyn Byrddau Iechyd Lleol (Sefydlu) 2003 (O.S. 2003/148, (Cy.18)).

Yn unol â pharagraff 20(2) o Atodlen 5B i Ddeddf 1977, dynodir yr eiddo, yr hawliau a'r rhwymedigaethau a drosglwyddir gan y Gorchymyn hwn drwy gytundebau rhwng yr awdurdodau gwasanaeth iechyd a'r Byrddau Iechyd Lleol y mae'r trosglwyddiadau'n effeithio arnynt.

Yn unol â'r gofynion ym mharagraff 21(3) o Atodlen 5B, mae'r Gorchymyn hwn yn cynnwys darpariaethau i ddiogelu buddiannau trydydd partïon, gan gynnwys, lle y bo'n briodol, ddarpariaeth ar gyfer talu swm a bennir gan gymrodeddwyr a benodir yn unol â Deddf Cymrodeddu 1996 yn iawndal.

Mae'r Gorchymyn hefyd yn darparu ar gyfer torri unrhyw anghydfodau rhwng awdurdodau gwasanaeth iechyd, sy'n deillio o ganlyniad i unrhyw drosglwyddo a weithredir gan neu o dan y Gorchymyn.

Local Health Boards are established by the Local Health Boards (Establishment) Order 2003 (S.I. 2003/148, (W.18)).

In accordance with paragraph 20(2) of Schedule 5B to the 1977 Act, the property, rights and liabilities transferred by this Order have been identified by agreement between the health service authorities and the Local Health Boards affected by the transfers.

In accordance with the requirements in paragraph 21(3) of Schedule 5B, this Order contains provisions to safeguard the interests of third parties including, where appropriate, provision for the payment of compensation of an amount determined by an arbitrator appointed in accordance with the Arbitration Act 1996.

The Order also provides for the resolution of any disputes between health service authorities arising as a result of any of the transfers effected by or under the Order.

The National Assembly for Wales, in exercise of the powers conferred by paragraphs 20 and 21 of Schedule 5B to the National Health Service Act 1977(a), and the property, rights and liabilities which are transferred by this Order having been identified by agreement between the health service authorities and Local Health Boards concerned pursuant to paragraph 20(2) of Schedule 5B to the 1977 Act, makes the following Order:

**Title, commencement and application**

1.-(1) The Order may be cited as the Local Health Boards (Transfer of Property, Rights and Liabilities) (Wales) Order 2003 and shall come into force on 1st April 2003.

(2) This Order applies to Wales only.

**Interpretation**

2.-(1) In this Order, unless the context otherwise requires -

"contents" ("cynnwys") shall mean any item or property of whatever description which is -

- (a) the property of a health service authority immediately prior to the transfer date; and
- (b) present in or on the land described in Schedule 2 on the transfer date,

including any vehicle or moveable property which is normally kept on such land when not in use;

ystyr "system gyfrifiadurol a rennir" ("shared computer system") yw cyfarpar cyfrifiadurol sy'n gweithredu fel rhan o system gyfrifiadurol integredig ac y mae, yn union cyn y dyddiad trosglwyddo, wedi'i leoli yn neu ar fwy nag un o'r parseli o dir a bennir yng ngholofn 1 i Atodlen 1 neu golofn 1 i Atodlen 2, ac sy'n cynnwys unrhyw wybodaeth a meddalwedd sy'n cael ei ddal ar system o'r fath neu mewn perthynas â hi;

(2) Dehonglir bod unrhyw ddarpariaeth yn y Gorchymyn hwn sy'n trosglwyddo eiddo, onid yw'r cyd-destun yn mynnu fel arall, yn cynnwys cyfeiriad at drosglwyddo unrhyw hawliau a rhwymedigaethau awdurdod gwasanaeth iechyd sy'n bodoli mewn perthynas â'r eiddo hwnnw yn union cyn y dyddiad trosglwyddo.

"Health service authority" ("awdurdod gwasanaeth iechyd") shall have the meaning given in section 20(5) of Schedule 5B to the National Health Service Act 1977;

"Land" ("tir") shall be construed in accordance with Schedule 1 to the Interpretation Act 1978, save that any reference to the transfer of land by virtue of this Order shall be construed as including the transfer of any contractual licence for the use of land;

"the Powys NHS Trust" ("Ymddiriedolaeth GIG Powys") means the Powys Health Care National Health Service Trust established by Powys Health Care National Health Service Trust (Establishment) Order 1992(a);

"Records" ("cofnodion") means any material in whatever form or medium which conveys or is capable of conveying information and which is structured by reference to -

- (a) individuals or to criteria relating to individuals, in such a way that specific information relating to a particular individual is readily accessible; or
- (b) any property, rights or liabilities of a health service authority, in such a way that specific information relating to particular property, rights or liabilities is readily accessible;

"Shared computer system" ("system gyfrifiadurol a rennir") means computer equipment which operates as part of a single integrated computer system and which is, immediately before the transfer date, situated in or on more than one of the parcels of land specified in column 1 to Schedule 1 or column 1 to Schedule 2, and includes any information and software held on or in relation to such a system;

"Third parties" ("trydydd partïon") shall have the meaning given in section 20(4) of Schedule 5B to the National Health Service Act 1977;

"the transfer date" ("y dyddiad trosglwyddo") means 1st April 2003; and

"Welsh health authority" ("awdurdod iechyd Cymreig") means a health authority established under the Health Authorities (Wales) Establishment Order 1996(b).

(2) Any provision in this Order transferring property shall be construed, unless the context otherwise requires, as including a reference to the transfer of any rights and liabilities of a health service authority which exist in respect of such property immediately before the transfer date.

(3) Mae unrhyw gyfeiriad yn y Gorchymyn hwn at unrhyw hawliau neu rwymedigaethau awdurdod gwasanaeth iechyd yn cynnwys cyfeiriad at hawliau neu rwymedigaethau a gafwyd neu a dynnwyd gan unrhyw ragflaenydd yr awdurdod hwnnw yn y teitl.

(4) Pan drosglwyddir eiddo, hawliau neu rwymedigaethau awdurdod gwasanaeth iechyd oddi wrth awdurdod gwasanaeth iechyd i Fwrdd Iechyd Lleol yn rhinwedd y Gorchymyn hwn, bydd unrhyw beth a wnaed gan yr awdurdod gwasanaeth iechyd neu mewn perthynas ag ef mewn cysylltiad â'r eiddo hwnnw, neu'r hawliau a'r rhwymedigaethau hynny yn cael ei drin fe pe bai wedi'i wneud gan y Bwrdd Iechyd Lleol hwnnw neu mewn perthynas ag ef.

### **Trosglwyddo tir awdurdodau gwasanaethau iechyd i Fyrddau Iechyd Lleol**

3. Gan fod yn effeithiol o'r dyddiad trosglwyddo ymlaen trosglwyddir y tir a ddisgrifir yng ngholofn 1 o Atodlen 1 oddi wrth yr awdurdod gwasanaeth iechyd a bennir yng ngholofn 2 o'r Atodlen honno i'r Bwrdd Iechyd Lleol a bennir yng ngholofn 3 o'r Atodlen honno.

### **Trosglwyddo cynnwys tir oddi wrth yr awdurdodau gwasanaethau iechyd i Fyrddau Iechyd Lleol**

4-(1)Ar wahân i'r eithriadau a nodir ym mharagraff (2), gan fod yn effeithiol o'r dyddiad trosglwyddo ymlaen trosglwyddir y cynnwys yn neu ar y tir a bennir yng ngholofn 1 o Atodlen 2 oddi wrth yr awdurdod gwasanaeth iechyd a bennir yng ngholofn 2 o'r Atodlen honno i'r Bwrdd Iechyd Lleol a bennir yng ngholofn 3 o'r Atodlen honno.

(2) Dyma'r eithriadau y cyfeirir atynt ym mharagraff (1) -

- (a) unrhyw gofnodion; a
- (b) unrhyw system gyfrifiadurol a rennir.

### **Trosglwyddo eiddo, hawliau a rhwymedigaethau Ymddiriedolaeth GIG Powys i Fwrdd Iechyd Lleol Powys**

5. Gan fod yn effeithiol o'r dyddiad trosglwyddo ymlaen trosglwyddir -

- (a) tir Ymddiriedolaeth GIG Powys a bennir yn Atodlen 3; a
- (b) pob eiddo, hawl a rhwymedigaeth arall, Ymddiriedolaeth GIG Powys i Fwrdd Iechyd Lleol Powys.

(3) Any reference in this Order to any rights or liabilities of a health service authority includes a reference to rights or liabilities acquired or incurred by any predecessor in title of such authority.

(4) Where property, rights or liabilities of a health service authority are transferred from a health service authority to a Local Health Board by virtue of this Order, anything done by or in relation to the health service authority in connection with such property, rights and liabilities shall be treated as if it had been done by or in relation to such Local Health Board.

### **Transfer of land of health service authorities to Local Health Boards**

3. With effect from the transfer date the land described in column 1 of Schedule 1 shall be transferred from the health service authority specified in column 2 of that Schedule to the Local Health Board specified in column 3 of that Schedule.

### **Transfer of contents of land from health service authorities to Local Health Boards**

4. -(1) Save for the exceptions set out in paragraph (2), with effect from the transfer date the contents in or on the land specified in column 1 of Schedule 2 shall be transferred from the health service authority specified in column 2 of that Schedule to the Local Health Board specified in column 3 of that Schedule.

(2) The exceptions to paragraph (1) are -

- (a) any records; and
- (b) any shared computer system.

### **Transfer of Powys NHS Trust property, rights and liabilities to the Powys Local Health Board**

5. With effect from the transfer date -

- (a) the land of the Powys NHS Trust specified in Schedule 3; and
- (b) all other property, rights and liabilities of the Powys NHS Trust  
shall be transferred to the Powys Local Health Board.

(2) Trosgwyddir pob eiddo, hawl a rhwymedigaeth y mae paragraff (1) uchod yn gymwys iddynt ar y dyddiad trosglwyddo oddi wrth yr awdurdodau iechyd Cymreig i Fwrdd Iechyd Lleol Powys.

**Torri anghydfodau rhwng awdurdodau gwasanaethau iechyd**

7.-(1) Os digwydd anghydfod o ganlyniad i unrhyw drosglwyddo a weithredir o dan y Gorchymyn hwn rhwng dau awdurdod gwasanaeth iechyd neu fwy, caiff unrhyw un o'r awdurdodau gwasanaeth iechyd hynny gyfeirio'r anghydfod at Gynulliad Cenedlaethol Cymru er mwyn iddo benderfynu arno.

(2) Pan gyfeirir anghydfod at Gynulliad Cenedlaethol Cymru o dan baragraff (1) uchod, caiff y Cynulliad ei hun benderfynu arno neu, os yw'n ystyried bod hynny'n briodol, benodi person i benderfynu'r anghydfod ar ei ran.

(3) Trwy benderfynu ar anghydfod a gyfeirir ato o dan baragraff (1) uchod, caiff y Cynulliad neu, yn ôl y digwydd, y person a benodir o dan baragraff (2) uchod ddatrys yr anghydfod a gosod telerau sy'n rhwymo ar yr awdurdodau gwasanaeth iechyd sy'n rhan o'r anghydfod.

(4) Caiff penderfyniad ar anghydfod a gyfeirir o dan baragraff (1) uchod gynnwys yr amodau hynny (gan gynnwys amodau yngylch talu) y bydd y Cynulliad neu, yn ôl y digwydd, y person a benodir o dan baragraff (2) uchod yn eu hystyried yn briodol er mwyn datrys y mater sy'n destun yr anghydfod.

**Hawliau trydydd parti**

8-(1) Os bydd trosglwyddiad yn rhinwedd y Gorchymyn hwn o unrhyw eiddo, hawliau neu rwymedigaethau yn gweithredu mewn modd sy'n effeithio'n andwyol ar hawliau unrhyw drydydd parti, bydd darpariaethau canlynol yr erthygl hon yn gymwys.

(2) Nid yw'r ffaith bod unrhyw eiddo, hawl neu rwymedigaeth wedi'i drosglwyddo neu ei throsglwyddo yn rhinwedd y Gorchymyn hwn yn ddigonol ynddi ei hun i brofi bod hawliau trydydd parti wedi cael eu heffeithio'n andwyol.

- (3) Penderfynir unrhyw anghydfod rhwng trydydd

**Transfer of residuary property, rights and liabilities from Welsh health authorities to the Powys Local Health Board**

6. -(1) This article applies to -
- (a) records;
  - (b) shared computer systems;
  - (c) any property, rights or liabilities of a Welsh health authority which are not transferred by virtue of any other provision of this Order.

(2) All property, rights and liabilities to which paragraph (1) above applies shall on the transfer date be transferred from the Welsh health authorities to the Powys Local Health Board.

**Determination of disputes between health service authorities**

7. -(1) Where a dispute arises as a result of any of the transfers effected under this Order between two or more health service authorities, any one of those health service authorities may refer the dispute to the National Assembly for Wales for determination.

(2) Where a reference is made to the National Assembly for Wales under paragraph (1) above, the Assembly may determine the dispute itself or, if it considers it appropriate, appoint a person to determine the dispute on its behalf.

(3) By its determination of a reference under paragraph (1) above, the Assembly or, as the case may be, the person appointed under paragraph (2) above may resolve the dispute and impose binding terms upon the health service authorities involved in the dispute.

(4) A determination of a reference under paragraph (1) above may contain such conditions (including conditions as to payment) as the Assembly or, as the case may be, the person appointed under paragraph (2) above considers appropriate to resolve the matter in dispute.

**Third party rights**

8. -(1) Where a transfer by virtue of this Order of any property, rights or liabilities operates so as to affect adversely the rights of any third party, the following provisions of this article shall apply.

(2) The fact that any property, right or liability has been transferred by virtue of this Order is not of itself sufficient to establish that the rights of a third party have been adversely affected.

- (3) Any dispute between a third party and a health

service authority, shall be determined in accordance with the provisions of the Arbitration Act 1996(a) by a sole arbitrator appointed by agreement between the third party and the health service authority, or in default of such agreement, under paragraph (4).

(4) If the third party and the health service authority fail to agree on the appointment of an arbitrator under paragraph (3), either of them may apply to the President for the time being of the Chartered Institute of Arbitrators (b) to appoint an arbitrator to resolve the dispute between them in accordance with the Arbitration Act 1996.
