**EXPLANATORY NOTE**

Mae adran 512(3)(a) o Ddeddf Addysg 1996 yn rhoi dylestwydd ar Awdurdodau Addysg Lleol i ddarparu ciniawau ysgol i ddisgyblion sydd yn gymwys i giniawau ysgol yn rhad ac am ddim, ar yr amod bod unrhyw ofynion rhagnodedig yn cael eu bodloni. Mae'r Gorchymyn hwn yn rhagnodi gofyniad o'r fath.

Section 512(3)(a) of the Education Act 1996 places a duty on Local Education Authorities to provide school lunches to pupils eligible for free school lunches, provided any prescribed requirements are met. This Order prescribes such a requirement.

Mae'r gofyniad yn cael ei osod allan yn Erthygl 3. Mae'n gymwys yn unig i ddisgyblion cofrestredig sydd yn derbyn addysg feithrin; rhaid eu bod yn derbyn addysg feithrin lawnamser.

The requirement is set out in Article 3. It only applies to registered pupils receiving nursery education; they must be receiving full-time nursery education.

Mae Erthygl 4 yn cynnwys darpariaeth drosiannol i atal disgyblion sydd yn derbyn addysg feithrin ran-amser mewn ysgolion a gynhelir, sydd yn derbyn ciniawau ysgol yn rhad ac am ddim, rhag colli yr hawl i giniawau o'r fath.

Article 4 contains a transitional provision, to prevent pupils undergoing part-time nursery education at maintained schools for whom free school lunches are already being provided when this Order comes into effect, from losing their entitlement to such lunches.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 512(3) a 568 o Ddeddf Addysg 1996(a) ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru(b).

The National Assembly for Wales makes the following Order in exercise of the powers conferred on the Secretary of State by sections 512(3) and 568 of the Education Act 1996(a) and now vested in the National Assembly for Wales(b).

**Enw, cychwyn a chymwysu****Name, commencement and application**

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Addysg (Ciniawau Ysgol) (Gofyniad Rhagnodedig) (Cymru) 2003 a daw i rym ar 1 Ebrill 2003.

1.-(1) This Order is called the Education (School Lunches) (Prescribed Requirement) (Wales) Order 2003 and shall come into force on 1st April 2003.

(2) Mae'r Gorchymyn hwn yn gymwys mewn perthynas â Chymru.

(2) This Order applies in relation to Wales.

**Dehongli****Interpretation****2. Yn y Gorchymyn hwn -****2. In this Order -**

ystyr "Deddf 1996" ("*the 1996 Act*") yw Deddf Addysg 1996;

"the 1996 Act" ("*Deddf 1996*") means the Education Act 1996;

ystyr "addysg feithrin" ("*nursery education*") yw addysg lawnamser neu ran-amser sydd yn addas ar gyfer plant nad ydynt wedi cyrraedd oedran ysgol orfodol;

"nursery education" ("*addysg feithrin*") means full-time or part-time education suitable for children who have not attained compulsory school age;

mae'r cyfeiriad at ysgol a gynhelir yn gyfeiriad at ysgol a gynhelir gan awdurdod addysg lleol o fewn ystyr adran 512(6) o Ddeddf 1996.

the reference to a maintained school is a reference to a school maintained by a local education authority within the meaning of section 512(6) of the 1996 Act.

For the meaning of "prescribed" see section 512(6).

### **Gofyniad rhagnodedig ar gyfer ciniawau ysgol**

3.-(1) Rhagnodir y gofyniad canlynol at ddiben adran 512(3)(a) o Ddeddf 1996.

(2) Rhaid bod disgybl cofrestredig sydd yn derbyn addysg feithrin yn derbyn addysg lawnamser.

### **Darpariaeth drosiannol**

4. Bydd disgybl sydd yn derbyn addysg feithrin mewn ysgol a gynhelir y mae cinio ysgol yn cael ei ddarparu iddo neu iddi hi yn union cyn 1 Ebrill 2003, yn cael ei drin fel pe na bai unrhyw ofynion rhagnodedig yn gymwys i'r plentyn hwnnw dan adran 512(3)(a) o Ddeddf 1996; hyd nes y bydd yn gorffen derbyn addysg feithrin.

### **Prescribed requirement for school lunches**

3.-(1) The following requirement is prescribed for the purpose of section 512(3)(a) of the 1996 Act.

(2) A registered pupil who is receiving nursery education must be receiving full-time education.

### **Transitional Provision**

4. A pupil receiving nursery education at a maintained school for whom school lunches are being provided immediately before 1st April 2003 shall, until that pupil ceases to receive nursery education, be treated as if there were no prescribed requirements applying to that pupil under section 512(3)(a) of the 1996 Act.
