Mae'r Gorchymyn hwn yn trosglwyddo (ac yn gwneud darpariaeth gysylltiedig) eiddo ymddiriedolaeth yr hen Awdurdod Iechyd Dyfed Powys i Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre, ac mae'n trosglwyddo (ac yn gwneud darpariaeth gysylltiedig) eiddo ymddiriedolaeth yr hen Awdurdod Iechyd Gwent i Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre ac i Fyrddau Iechyd Lleol Blaenau Gwent, Caerffili, Sir Fynwy, Casnewydd, Tor-faen a Phowys.

This Order transfers (and makes related provision) to the Velindre National Health Service Trust, trust property of the former Dyfed Powys Health Authority and transfers (and makes related provision) to the Velindre National Health Service Trust and to the Blaenau Gwent, Caerphilly, Monmouthshire, Newport, Torfaen and Powys Local Health Boards, trust property of the former Gwent Health Authority.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd iddo gan adrannau 92(1), (4) a 126(4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977(a) ar ôl rhoi sylw i newidiadau yn y trefniadau ar gyfer gweinyddu'r gwasanaeth iechyd yn ardaloedd Awdurdod Iechyd Dyfed Powys ac Awdurdod Iechyd Gwent, drwy hyn yn gwneud y Gorchymyn canlynol:

The National Assembly for Wales, in exercise of powers conferred on it by section 92(1), (4) and 126(4) of the National Health Service Act 1977(a) having had regard to changes in the arrangements for the administration of the health service in the areas of the Dyfed Powys Health Authority and the Gwent Health Authority, hereby makes the following Order:

**Enwi, cychwyn a dehongli.**

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Awdurdod Iechyd Dyfed Powys ac Awdurdod Iechyd Gwent (Trosglwyddo Eiddo Ymddiriedolaeth) 2004 a daw i rym ar 30 Mehefin 2004.

**Citation, commencement and interpretation**

1.-(1) This order may be cited as the Dyfed Powys Health Authority and Gwent Health Authority (Transfer of Trust Property) Order 2004 and comes into force on 30 June 2004.

(2) Yn y Gorchymyn hwn -

(2) In this order -

ystyr "eiddo ymddiriedolaeth Dyfed Powys" ("*Dyfed Powys trust property*") yw'r eiddo a bennir yn Atodlen 1;

"Dyfed Powys trust property" ("*eiddo ymddiriedolaeth Dyfed Powys*") means the property specified in Schedule 1 hereto;

ystyr "eiddo ymddiriedolaeth Gwent" ("*Gwent trust property*") yw'r eiddo a bennir yng Ngholofn 1 o Atodlen 2.

"Gwent trust property" ("*eiddo ymddiriedolaeth Gwent*") means the property specified in Column 1 of Schedule 2 hereto.

Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adrannau 92 a 126(4) o Ddeddf y Gwasanaeth Iechyd Gwladol 1977 ("Deddf 1977") i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 O.S. 1999/672, erthygl 2 ac Atodlen 1.

Section 92 was amended by section 11(5) of the National Health Service and Community Care Act 1990 (c.19) ("the 1990 Act"), by paragraph 44 of Schedule 1 to the Health Authorities Act 1995 (c.17) and by paragraph 28 of Schedule 4 to the Health Act 1999 (c.8) ("the 1999 Act"); section 126(4) was amended by section 65(2) of the 1990 Act and by paragraph 37(6) of Schedule 4 to the 1999 Act. The functions of the Secretary of State under sections 92 and 126(4) of the National Health Service Act 1977 ("the 1977 Act") were transferred to the National Assembly for Wales by the National Assembly (Transfer of Functions) Order 1999 S.I. 1999/672, article 2 and Schedule 1.

### **Trosglwyddo eiddo ymddiriedolaeth Dyfed Powys**

2.-(1) Ar 1 Gorffennaf 2004 trosglwyddir eiddo ymddiriedolaeth Dyfed Powys ynghyd ag unrhyw hawliau a rhwymedigaethau sy'n codi ohono(a) i Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre(b).

(2) Mewn unrhyw offeryn ymddiriedolaeth sy'n ymwneud ag eiddo ymddiriedolaeth Dyfed Powys, rhaid dehongli unrhyw gyfeiriad at yr enw y mae ymddiriedolwyr eiddo ymddiriedolaeth Dyfed Powys i'w hadnabod wrtho fel cyfeiriad at Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre a rhaid dehongli unrhyw gyfeiriad at Awdurdod Iechyd Dyfed Powys yn yr enw y mae'r ymddiriedolaeth elusennol sy'n llywodraethu'r eiddo ymddiriedolaeth i'w hadnabod wrtho fel cyfeiriad at Ymddiriedolaeth Iechyd Gwasanaeth Iechyd Gwladol Felindre.

### **Trosglwyddo eiddo ymddiriedolaeth Gwent**

3.-(1) Ar 1 Gorffennaf 2004 dosrannir eiddo ymddiriedolaeth Gwent ynghyd ag unrhyw hawliau a rhwymedigaethau sy'n codi ohono a'u trosglwyddo i'r Byrddau Iechyd Lleol ac Ymddiriedolaeth y Gwasanaeth Iechyd Gwladol fel a bennir yng Ngholofn 2 o Atodlen 2(c).

(2) Mewn unrhyw offeryn ymddiriedolaeth sy'n ymwneud ag eiddo ymddiriedolaeth Gwent, rhaid dehongli unrhyw gyfeiriad at yr enw y mae ymddiriedolwyr eiddo ymddiriedolaeth Gwent i'w hadnabod wrtho fel cyfeiriad at y Bwrdd Iechyd Lleol neu Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre y mae eiddo ymddiriedolaeth Gwent wedi cael ei drosglwyddo iddo a rhaid dehongli unrhyw gyfeiriad at Awdurdod Iechyd Gwent yn yr enw y mae'r ymddiriedolaeth elusennol sy'n llywodraethu'r eiddo ymddiriedolaeth i'w hadnabod wrtho fel cyfeiriad at y Bwrdd Iechyd Lleol perthnasol neu Ymddiriedolaeth Iechyd Gwasanaeth Iechyd Gwladol Felindre.

### **Transfer of the Dyfed Powys trust property**

2.-(1) On 1 July 2004 the Dyfed Powys trust property and any rights and liabilities arising therefrom(a) are to be transferred to the Velindre National Health Service Trust(b).

(2) In any trust instrument relating to the Dyfed Powys trust property, any reference to the name by which the trustees of the Dyfed Powys trust property are to be known is to be construed as a reference to Velindre National Health Service Trust and any reference to Dyfed Powys Health Authority in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to Velindre National Health Service Trust.

### **Transfer of the Gwent trust property**

3.-(1) On 1 July 2004 the Gwent trust property and any rights and liabilities arising therefrom are to be apportioned and transferred to the Local Health Boards and National Health Service Trust as specified in Column 2 of Schedule 2 hereto(c).

(2) In any trust instrument relating to the Gwent trust property, any reference to the name by which the trustees of the Gwent trust property are to be known is to be construed as a reference to the Local Health Board or the Velindre National Health Service Trust to which the Gwent trust property has been transferred and any reference to the Gwent Health Authority in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to the relevant Local Health Board or the Velindre National Health Service Trust.

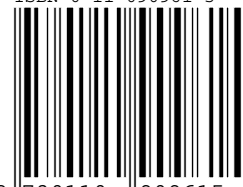
