O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol 1988(a) mae'n ofynnol i awdurdodau bilio yng Nghymru dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Gynulliad Cenedlaethol Cymru. Mae'r rheolau ar gyfer cyfrifo'r symiau hynny wedi'u cynnwys yn Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992(b) ("Rheoliadau 1992").

Under Part II of Schedule 8 to the Local Government Finance Act 1988(a), billing authorities in Wales are required to pay amounts (called non-domestic rating contributions) to the National Assembly for Wales. Rules for the calculation of those amounts are contained in the Non-Domestic Rating Contributions (Wales) Regulations 1992(b) ("the 1992 Regulations").

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 1992 drwy roi lluosydd newydd ym mharagraff 2(12) o Atodlen 2 (Rhagdybiaethau ynglŷn â'r swm gros), ac Atodlen 4 newydd (Ffigurau Poblogaeth Oedolion).

These Regulations amend the 1992 Regulations by substituting a new multiplier in paragraph 2(12) of Schedule 2 (Assumptions as to gross amount) and a new Schedule 4 (Adult Population Figures).

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd iddo gan adrannau 140(4), a 143(1) a (2) o Ddeddf Cyllid Llywodraeth Leol 1988(a) a pharagraffau 4 a 6 o Atodlen 8 iddi, drwy hyn yn gwneud y Rheoliadau canlynol:

The National Assembly for Wales, in exercise of the powers conferred upon it by sections 140(4) and 143(1) and (2) of, and paragraphs 4 and 6 of Schedule 8 to, the Local Government Finance Act 1988(a), hereby make the following Regulations:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfraniadau Ardrethu Annommestig (Cymru) (Diwygio) 2004 a deuant i rym ar 31 Rhagfyr 2004.

1.-(1) These Regulations are called the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2004 and come into force on 31 December 2004.

(2) Mae'r Rheoliadau hyn yn gymwys mewn perthynas â Chymru.

(2) These Regulations apply in relation to Wales.

Dehongli**Interpretation**

2. Yn y Rheoliadau hyn ystyr "Rheoliadau 1992" ("*the 1992 Regulations*") yw Rheoliadau Cyfraniadau Ardrethu Annommestig (Cymru) 1992(b).

2. In these Regulations "the 1992 Regulations" ("*Rheoliadau 1992*") means the Non-Domestic Rating Contributions (Wales) Regulations 1992(b).

Diwygio Rheoliadau 1992**Amendment of the 1992 Regulations**

3. O ran y blynyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2005, diwygir Atodlenni 2 a 4 i Rheoliadau 1992 fel a ganlyn:-

3. In relation to financial years beginning on or after 1 April 2005, Schedules 2 and 4 to the 1992 Regulations are amended as follows:-

The functions of the Secretary of State under sections 140(4) and 143(1) and (2) of, and paragraphs 4 and 6 of Schedule 8 to, the Local Government Finance Act 1988, are, so far as exercisable in relation to Wales, transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) to which there are amendments not relevant to these Regulations.

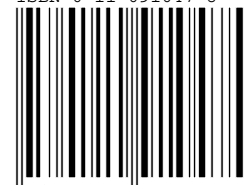
