EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae Rheoliadau Ardrethu Annomestig (Hysbysiadau Galw am Dalu) (Cymru) 1993 ("y prif Reoliadau") yn darparu ynghylch cynnwys hysbysiadau sy'n galw am dalu ardrethi ac a ddyroddir gan awdurdodau bilio yng Nghymru. Maent yn darparu hefyd ynghylch rhoi gwybodaeth esboniadol yn yr iaith briodol ar y cyd â'r hysbysiadau hynny.

The Non-Domestic Rating (Demand Notices) (Wales) Regulations 1993 ("the principal Regulations") provide for the contents of rate demand notices which are issued by billing authorities in Wales and for such notices to be accompanied by explanatory information in the appropriate language.

Mae'r Rheoliadau hyn yn diwygio'r wybodaeth esboniadol y mae'n rhaid i awdurdodau bilio yng Nghymru ei rhoi fel ei bod:

These Regulations, make amendments to the explanatory information which must be supplied by billing authorities in Wales so that it:

- yn cyfeirio at newidiadau i'r rheolau o ran gwneud cynigion neu apelau o dan y gwerthoedd ardrethol newydd;
- yn esbonio y bydd gwerthoedd ardrethol newydd yn cael eu defnyddio i gyfrifo ardrethi busnes;
- yn cyfeirio at gyflwyno'r rhyddhad ar ardrethi gorfodol i glybiau chwaraeon amatur cymunedol a gofrestrir gyda Chyllid y Wlad; ac
- yn dileu gwybodaeth a ddisodlwyd am "Trefniadau Trosiannol" a "Rhyddhad Rhag Trethi i Eiddo Bach".

- refers to changes to the rules surrounding the making of proposals or appeals under the new rateable values;
- explains that new rateable values will be used to calculate business rates;
- refers to the introduction of mandatory rate relief for community amateur sport clubs registered with the Inland Revenue; and
- removes obsolete information relating to "Transitional Arrangements" and "Small Property Relief".

Mae Cynulliad Cenedlaethol Cymru ("y Cynulliad Cenedlaethol"), drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan baragraffau 1 a 2(2) o Atodlen 9 i Ddeddf Cyllid Llywodraeth Leol 1988(1) ac adran 26(3) o Ddeddf yr Iaith Gymraeg 1993(2), ac sydd bellach yn arferadwy gan y Cynulliad Cenedlaethol o ran Cymru, drwy hyn yn gwneud y Rheoliadau a ganlyn:

The National Assembly for Wales ("the National Assembly"), in exercise of the powers conferred on the Secretary of State by paragraphs 1 and 2(2) of Schedule 9 to the Local Government Finance Act 1988(1) and section 26(3) of the Welsh Language Act 1993(2), and now exercisable by the National Assembly in relation to Wales, hereby make the following Regulations:

Enwi, cychwyn a chymhwysu

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Ardrethu Annomestig (Hysbysiadau Galw am Dalu) (Cymru) (Diwygio) 2005 a deuant i rym ar 25 Chwefror 2005.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru yn unig.

Name, commencement and application

1.-(1) These Regulations are called the Non-Domestic Rating (Demand Notices) (Wales) (Amendment) Regulations 2005 and come into force on 25 February 2005.

(2) These Regulations apply only in relation to Wales.

Dehongli

2. Yn y Rheoliadau hyn, ystyr "y prif Reoliadau" ("*the principal Regulations*") yw Rheoliadau Ardrethu Annomestig (Hysbysiadau Galw am Dalu) (Cymru) 1993(3).

Interpretation

2. In these Regulations "the principal Regulations" ("*y prif Reoliadau*") means the Non-Domestic Rating (Demand Notices) (Wales) Regulations 1993(3).

Amendment of the principal Regulations

(3) For the note headed "Backdating of proposals and appeals" substitute the following -

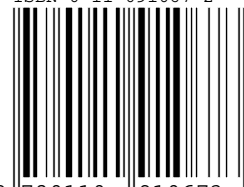
