1. Mae'r Rheoliadau hyn yn gymwys o ran Cymru ac maent yn cywiro camgymeriadau i Reoliadau Mêl 2003 O.S. 2003/2243, er mwyn sicrhau bod Cyfarwyddeb y Cyngor 2001/110/EC ynghylch mêl (OJ Rhif L10, 12.1.2002, t.47) yn cael ei throsi'n gywir.

1. These Regulations, which apply in relation to Wales, correct errors in the Honey Regulations 2003 S.I. 2003/2243, to ensure accurate transposition of Council Directive 2001/110/EC concerning honey (OJ No. L10, 12.1.2002, p.47).

2. Mae arfarniad rheoleiddiol llawn am yr effaith a gaiff y Rheoliadau hyn ar gostau busnes wedi'i baratoi yn unol ag adran 65 o Ddeddf Llywodraeth Cymru 1998 a'i osod yn llyfrgell Cynulliad Cenedlaethol Cymru. Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adrannau 16(1)(e), 17(1), 26(1) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1) ac sydd bellach wedi'u breinio ynddo(2), ar ôl rhoi sylw, yn unol ag adran 48(4A) o'r Ddeddf honno i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd, ac ar ôl ymghynghori fel sy'n ofynnol o dan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor(3) sy'n pennu egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn pennu gweithdrefnau o ran materion diogelwch bwyd, drwy hyn yn gwneud y Rheoliadau canlynol:

1. Enw'r Rheoliadau hyn yw Rheoliadau Mêl (Cymru) (Diwygio) 2005, maent yn gymwys o ran Cymru a deuant i rym ar 11 Tachwedd 2005.

2. Diwygir Rheoliadau Mêl (Cymru) 2003(4) yn unol â rheoliad 3.

3.- Yn Atodlen 1, Nodyn 1, yn lle'r geiriau "a 6" rhodder y geiriau-

The National Assembly for Wales, in exercise of the powers conferred by sections 16(1)(e), 17(1), 26(1) and (3) and 48(1) of the Food Safety Act 1990(1) and now vested in it(2), having had regard, in accordance with section 48(4A) of that Act to relevant advice given by the Food Standards Agency, and after consultation both as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(3) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety, hereby makes the following Regulations:

Title, application and commencement

1. The title of these Regulations is the Honey (Wales) (Amendment) Regulations 2005; they apply in relation to Wales and come into force on 11 November 2005.

Amendments to the Honey Regulations 2003

2. The Honey (Wales) Regulations 2003(4) are amended in accordance with regulation 3.

3.- In Schedule 1, Note 1, for the words "and 6" substitute-
