The Children Act 2004 (Commencement  
No. 5) (Wales) Order 2005

Made - - - - 6 December 2005

The National Assembly for Wales, in exercise of the powers conferred upon it by section 67(7)(e) of the Children Act 2004<sup>(1)</sup> hereby makes the following Order:

**Name, interpretation and application**

- 1.—(1) This Order is called the Children Act 2004 (Commencement No. 5) (Wales) Order 2005.
- (2) In this Order “the Act” (“*y Ddeddf*”) means the Children Act 2004.
- (3) This Order applies in relation to Wales.

**Appointed Day**

2. 30 December 2005 is the appointed day for the coming into force of section 57 of the Act (Fees payable to adoption review panel members).
