### **EXPLANATORY NOTE**

Mae atodlen 14 i Ddeddf Tai 2004 ("y Ddeddf") yn disgrifio tai nad ydynt yn dai amlfeddiannaeth ("HMOs") at ddibenion y Ddeddf (ac eithrio Rhan 1). Mae adran 254 o'r Ddeddf yn diffinio HMOs.

Schedule 14 to The Housing Act 2004 ("the Act") describes buildings that are not houses in multiple occupation ("HMOs") for the purposes of the Act (excluding Part 1). HMOs are defined by section 254 of the Act.

Mae paragraff 4 o Atodlen 14 i'r Ddeddf yn darparu nad yw adeilad yn HMO at ddibenion y Ddeddf (ac eithrio Rhan 1) os yw'n adeilad a feddiennir yn unig neu yn bennaf gan bersonau sy'n ei feddiannu at ddibenion dilyn cwrs amser llawn o addysg bellach mewn sefydliad penodedig neu mewn sefydliad o fath penodedig, a phan mai'r person sy'n ei reoli neu sydd â rheolaeth drosto yw'r sefydliad dan sylw neu berson penodedig neu berson o fath arbennig. Mae Rheoliad 2 o'r Rheoliadau hyn yn pennu sefydliadau o'r fath. Mae'r sefydliadau yn rhai penodedig os ydynt yn cael eu rhestru yn yr Atodlen i'r Rheoliadau hyn ac os ydynt hefyd yn cael eu rhestru fel rheolwr unrhyw adeilad a restrir mewn atodlen sy'n ffurfio rhan o'r naill neu'r llall o'r codau y cyfeirir atynt yn rheoliad 2(b).

Paragraph 4 of Schedule 14 to the Act provides that a building is not an HMO for the purposes of the Act (excluding Part 1) if it is a building which is occupied solely or principally by persons who occupy it for the purpose of undertaking a full-time course of further education at a specified establishment or at an establishment of a specified description, and where the person managing or controlling it is the establishment in question or a specified person or a person of a specified description. Regulation 2 of these Regulations specify such establishments. The establishments are specified if they are listed in the Schedule to these Regulations and are also listed as the manager of any building listed in a schedule forming part of either of the codes referred to in regulation 2(b).

The National Assembly for Wales, in exercise of the powers conferred by paragraph 4(2) of Schedule 14 to the Housing Act 2004(1), hereby makes the following Regulations:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Tai Amlfeddiannaeth (Sefydliadau Addysgol Penodedig) (Cymru) 2006 a deuant i rym ar 7 Gorffennaf 2006.

1.-(1) The title of these Regulations is The Houses in Multiple Occupation (Specified Educational Establishments) (Wales) Regulations 2006 and they come into force on 7 July 2006.

2. Mae sefydliad addysgol yn un penodedig at ddibenion paragraff 4 o Atodlen 14 i Ddeddf Tai 2004 os yw-

2. An educational establishment is specified for the purposes of paragraph 4 of Schedule 14 to the Housing Act 2004 where-

- (a) wedi ei restru yn yr Atodlen i'r Rheoliadau hyn; a
- (b) wedi ei restru fel y sefydliad addysgol perthnasol o ran adeilad-

- (a) it is listed in the Schedule to these Regulations; and
- (b) it is listed as the relevant educational establishment in respect of a building-
