**NODYN ESBONIADOL****EXPLANATORY NOTE**

Mae'r Gorchymyn hwn yn cymeradwyo tri cod ymarfer sy'n gosod safonau ar gyfer ymddygiad ac ymarfer sydd i'w dilyn parthed rheoli tai amlfeddiannaeth ("HMOs") ac adeiladau eraill a feddiennir yn unig neu yn bennaf gan fyfyrwyr amser llawn.

This Order approves three codes of practice laying down standards of conduct and practice to be followed with regard to the management of houses in multiple occupation ("HMOs") and other buildings that are occupied solely or principally by full-time students.

Yr adeiladau eraill a grybwyllir yw'r rheiny sy'n cwmpo o fewn paragraff 4 o Atodlen 14 i Ddeddf Tai 2004 (sy'n darparu ar gyfer math o adeilad a feddiennir gan fyfyrwyr nad yw yn HMO at ddibenion y Ddeddf honno). Yn achos yr adeiladau hynny, rhaid i fyfyrwyr sy'n eu meddiannu wneud hynny at y diben o ymgymryd â chysiau addysg amser llawn mewn sefydliadau addysgol penodedig. Mae Rheoliadau Tai Amlfeddiannaeth (Sefydliadau Addysgol Penodedig) (Cymru) ) 2006 wedi cael eu gwneud er mwyn pennu sefydliadau addysgol at ddibenion paragraff 4 o Atodlen 14.

The other buildings mentioned are those falling within paragraph 4 of Schedule 14 to the Housing Act 2004 (which provides for a description of building occupied by students which is not a HMO for the purposes of that Act). In the case of these buildings, students who occupy them must do so for the purpose of undertaking full-time education courses at specified educational establishments. The Houses in Multiple Occupation (Specified Educational Establishments) (Wales) Regulations 2006 has been made to specify educational establishments for the purpose of paragraph 4 of Schedule 14.

The National Assembly for Wales, in exercise of the powers conferred upon it by section 233(1) and (4) of the Housing Act 2004(1) and having taken reasonable steps to consult the persons mentioned in section 233(2) (a) and (b), and being satisfied with the publication arrangements in accordance with section 233(3), hereby makes the following Order:

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Tai (Cymeradwyo Codau Ymarfer Rheoli) (Llety Myfyrwyr) (Cymru) 2006 a a daw i rym ar 7 Gorffennaf 2006.

**Title, commencement and application**

1.-(1) The title of this Order is The Housing (Approval of Codes of Management Practice) (Student Accommodation) (Wales) Order 2006 and it comes into force on 7 July 2006.

(2) This Order applies in relation to premises in Wales.

**Cymeradwyo codau ymarfer**

2.-(1) Mae'r codau ymarfer a grybwyllir ym mharagraff (2) sy'n gosod safonau ar gyfer ymddygiad ac ymarfer sydd i'w dilyn parthed rheoli-

- (b) adeiladau sy'n cwmpo o fewn paragraff 4 o Atodlen 14 i Ddeddf Tai 2004 (adeiladau a feddiennir gan fyfyrwyr),

**Approval of codes of practice**

2.-(1) The codes of practice mentioned in paragraph (2) which lay down standards of conduct and practice to be followed with regard to the management of-

- (a) houses in multiple occupation that are occupied solely or principally by persons who occupy them for the purpose of undertaking a full-time course of further or higher education(2); or
- (b) buildings falling within paragraph 4 of Schedule 14 to the Housing Act 2004 (buildings occupied by students),
