Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Treuliau Teithio a Pheidio â Chodi Tâl) 1988 ("Rheoliadau 1988") i gymryd i ystyriaeth y newidiadau i'r ddarpariaeth, o ran cymorth ariannol i fyfyrwyr, a wneir gan Reoliadau Grantiau a Benthyciadau Dysgu y Cynulliad (Addysg Uwch) (Cymru) 2006 ("Rheoliadau Cymru 2006"), Rheoliadau Addysg (Cymorth i Fyfyrwyr) 2006 ("Rheoliadau Lloegr 2006"), a Rheoliadau Addysg (Cymorth i Fyfyrwyr) (Gogledd Iwerddon) 2006 ("Rheoliadau Gogledd Iwerddon 2006") a newidiadau canlyniadol i'r ffordd y cyfrifir hawl myfyriwr i gael cymhorthdal incwm.

Wrth gyfrifo adnoddau ac anghenion person o dan Reoliadau 1988 er mwyn canfod a all person hawlio'r hawl i beidio â thalu taliadau'r GIG a threuliau teithio'r GIG, defnyddir fersiwn wedi'i haddasu o Reoliadau Cymhorthdal Incwm (Cyffredinol) 1987 fel a geir yn Atodlen 1 i Reoliadau 1988 ("Atodlen 1").

Mae'r Rheoliadau hyn yn addasu ymhellach Atodlen 1 i ddarparu:

- bod unrhyw incwm grant sydd gan fyfyriwr yn cael ei ddosrannu dros gyfnod o 52 o wythnosau, yn hytrach na thros y cyfnod astudio mewn unrhyw un flwyddyn, ac eithrio yn y flwyddyn astudio olaf, neu yn ystod cwrs un flwyddyn pan fydd y cyfnod perthnasol yn cyfateb i'r cyfnod astudio, neu pan fydd y myfyriwr ar gwrs brechdan;

The National Health Service (Travelling Expenses and Remission of Charges) (Amendment) (No. 2) Regulations 2006

### **EXPLANATORY NOTE**

### (This note is not part of the Regulations)

These Regulations amend the National Health Service (Travelling Expenses and Remission of Charges) Regulations 1988 ("the 1988 Regulations") to take account of changes to the provision of financial support to students made by the Assembly Learning Grants and Loans (Higher Education) (Wales) Regulations 2006 ("the 2006 Wales Regulations"), the Education (Student Support) Regulations 2006 ("the 2006 England Regulations"), and the Education (Student Support) Regulations (Northern Ireland) 2006 ("the 2006 N.I. Regulations") and consequential changes to the way in which a student's entitlement to income support will be calculated.

In calculating a person's resources and requirements under the 1988 Regulations in order to establish whether a person can claim entitlement to the remission of NHS charges and the payment of NHS travel expenses, a modified version of the Income Support (General) Regulations 1987 is used as set out in Schedule 1 to the 1988 Regulations ("Schedule 1").

These Regulations further modify Schedule 1 to provide:

- that any grant income a student has is apportioned over a 52 week period, rather than over the period of study in any one year, except in the final year of study or during a one year course when the period of study is the relevant period, or when the student is on a sandwich course; - y dylid diystyru wrth gyfrifo incwm grant myfyriwr unrhyw swm sy'n ychwanegol at y swm a bennir yn rheoliad 33(4)(b) o Reoliadau Cymru 2006, ac a delir fel rhan o grant cynnal a chadw yn unol â rheoliad 29 o'r Rheoliadau hynny;

- y dylid diystyru wrth gyfrifo incwm grant myfyriwr unrhyw swm sy'n ychwanegol at y swm a bennir yn gyfanswm y grant cynnal a chadw ym mharagraffau (b), (c) neu (d) o reoliad 57(4) o Reoliadau Gogledd Iwerddon 2006 (bydd cyfansymiau'r grant yn gwahaniaethu yn unol â lefel y grant cynnal a chadw y bydd myfyriwr yn gymwys i'w gael o dan Reoliadau Gogledd Iwerddon 2006), ac a delir fel rhan o grant cynnal a chadw o dan reoliad 49 o'r Rheoliadau hynny; ac

- y dylid diystyru wrth gyfrifo incwm benthyciad myfyriwr unrhyw fenthyciad a delir o dan reoliad 10 o Reoliadau Addysg (Benthyciadau Myfyrwyr) (Yr Alban) 2000.

Mae Arfarniad Rheoliadol wedi'i baratoi mewn perthynas â'r Rheoliadau hyn a mae copi ohono wedi'i roi yn llyfrgell Cynulliad Cenedlaethol Cymru. Gellir gael copïau oddi wrth y Gyfarwyddiaeth Polisi Iechyd Cymunedol, Gofal Sylfaenol a Gwasanaethau Iechyd, Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ. - that any sum in excess of the sum set out in regulation 33(4)(b) of the 2006 Wales Regulations paid as part of a maintenance grant pursuant to regulation 29 of those Regulations should be disregarded in the calculation of a student's grant income;

- that any sum in excess of the sum set out in regulation 57(4)(b) of the 2006 England Regulations paid as part of a maintenance grant pursuant to regulation 48 of those Regulations should be disregarded in the calculation of a student's grant income;

- that any sum in excess of the sum set out as the maintenance grant amount in paragraphs (b), (c) or (d) of regulation 57(4) of the 2006 N.I. Regulations (the amounts of which will differ according to the level of maintenance grant a student qualifies for under the 2006 N.I. Regulations) paid as part of a maintenance grant under regulation 49 of those Regulations should be disregarded in the calculation of a student's grant income; and

- that any loan paid under regulation 10 of the Education (Student Loans) (Scotland) Regulations 2000 should be disregarded in the calculation of a student's loan income.

The National Health Service (Travelling Expenses and Remission of Charges) (Amendment) (No. 2) Regulations 2006

Coming into force	18 October 2006

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by sections 83A and 126(4) of the National Health Service Act 1977(1).

# Title, commencement, application and interpretation

**1**.-(1) The title of these Regulations is the National Health Service (Travelling Expenses and Remission of Charges) (Amendment) (No. 2) Regulations 2006 and they come into force on 18 October 2006.
