Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn darparu ar gyfer dirymu offerynnau penodedig a weithredai Benderfyniadau'r Comisiwn sy'n gosod amodau ar fewnforio cynhyrchion penodol a allai fod wedi'u halogi gan lefelau rhy uchel o aflatocsinau.

These Regulations, which apply in relation to Wales, provide for the revocation of specified instruments which implemented Commission Decisions imposing conditions on the import of specific products that could be contaminated with excessive levels of aflatoxins.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(1).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972(1).

Mae Cynulliad Cenedlaethol Cymru wedi'i ddynodi(2) at ddibenion yr adran honno mewn perthynas â mesurau sy'n gysylltiedig â bwyd (gan gynnwys diod) gan gynnwys cynhyrchu sylfaenol o ran bwyd.

The National Assembly for Wales has been designated(2) for the purposes of that section in relation to measures relating to food (including drink) including the primary production of food.

Cafwyd ymgynghori agored a thryloyw â'r cyhoedd yn ystod cyfnod paratoi'r Rheoliadau fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3).

There has been open and transparent public consultation during the preparation of the Regulations as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3).
