EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn gwneud mân ddiwygiadau i Reoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) 2003 ("Rheoliadau 2003") drwy wneud y canlynol-

These Regulations make minor amendments to the Education (Information About Individual Pupils) (Wales) Regulations 2003 ("the 2003 Regulations") by-

- (a) ychwanegu diffiniad o "ysgol", rhoi diffiniad newydd o "disgybl chweched dosbarth" yn lle'r hen un, ac ychwanegu diffiniad newydd o "blwyddyn ysgol";
- (b) newid ychydig eiriad paragraff 5 o Ran 1 o'r Atodlen i Reoliadau 2003 fel na fydd yn ofynnol mwyach i gorff llywodraethu ysgol ddatgan â phwy y mae disgybl yn siarad Cymraeg yn y cartref;
- (c) newid geiriad paragraff 1 o Ran 2 o'r Atodlen honno fel bod modd i'r wybodaeth y gall fod yn ofynnol i'r corff llywodraethu ei darparu am ddisgyblion chweched dosbarth gynnwys gwybodaeth am ddisgyblion sydd wedi gadael yr ysgol yn ystod y flwyddyn ysgol; ac
- (ch) newid ychydig eiriad paragraff 1(c) o'r Rhan honno fel y bydd yr wybodaeth y gall fod yn ofynnol ei darparu ynghylch anghenion disgyblion, o ran sgiliau sylfaenol, am lythrennedd a rhifedd yn cynnwys bellach anghenion disgyblion ar ddiwedd, yn ogystal ag ar ddechrau, eu rhaglen gweithgareddau dysgu.

- (a) adding a new definitions of "school", substituting a new definition of "sixth form pupil", and adding a new definition of "school year";
- (b) slightly altering the wording of paragraph 5 of Part 1 of the Schedule to the 2003 Regulations so that the governing body of a school will no longer be required to specify with whom a pupil speaks Welsh at home;
- (c) altering the wording of paragraph 1 of Part 2 of that Schedule so that information which the governing body may be required to provide about sixth form pupils can include information about pupils who have left the school during the course of the school year; and
- (d) slightly altering the wording of paragraph 21(c) of that Part so that the information which may be required about pupils' basic skills needs for literacy and numeracy will now include pupils' needs at the end, as well as at the beginning, of their learning activities programme.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol o dan adrannau 537A(1), (2) a (4) a 569(4) a (5) o Ddeddf Addysg 1996(1) ac sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru(2), mae Cynulliad Cenedlaethol Cymru drwy hyn yn gwneud y Rheoliadau canlynol:

In exercise of the powers conferred on the Secretary of State by sections 537A(1), (2) and (4) and 569(4) and (5) of the Education Act 1996(1) and now vested in the National Assembly for Wales(2), the National Assembly for Wales hereby make the following Regulations:

Enwi a chychwyn

1. Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) (Diwygio) 2006 a deuant i rym ar 11 Ionawr 2006.

Title and commencement

1. The title of these Regulations is the Education (Information About Individual Pupils) (Wales) (Amendment) Regulations 2006 and they come into force on 11 January 2006.

Diwygio Rheoliadau

2.-(1) Mae Rheoliadau Addysg (Gwybodaeth am Ddisgyblion Unigol) (Cymru) 2003(3) yn cael eu diwygio fel a ganlyn.

Amendment of Regulations

2.-(1) The Education (Information About Individual Pupils) (Wales) Regulations 2003(3) are amended as follows.

(2) Yn rheoliad 2, yn y man priodol yn ôl trefn yr wyddor, mewnosoder y diffiniadau newydd canlynol-

(2) In regulation 2, in the appropriate place in alphabetical order insert the following new definitions-

"ystyr "blwyddyn ysgol" ("*school year*") yw'r cyfnod sy'n dechrau gyda'r tymor ysgol cyntaf i ddechrau ar ôl Gorffennaf ac sy'n dod i ben ar ddechrau'r tymor cyntaf o'r fath i ddechrau ar ôl y Gorffennaf canlynol;"

""school" ("*ysgol*") means a school maintained by a local education authority, but does not include a pupil referral unit;

"ystyr "ysgol" ("*school*") yw ysgol a gynhelir gan awdurdod addysg lleol, ond nid yw'n cynnwys uned cyfeirio disgyblion;"

"school year" ("*blwyddyn ysgol*") means the period beginning with the first school term to begin after July and ending with the beginning of the first such term to begin after the following July;"

(3) Yn rheoliad 2, yn lle'r diffiniad o "disgybl chweched dosbarth" rhodder-

"ystyr "disgybl chweched dosbarth" ("*sixth form pupil*") yw disgybl mewn ysgol sy'n cael addysg addas ar gyfer anghenion disgyblion dros yr oedran ysgol gorfodol;"

(4) Yn Rhan 1 o'r Atodlen, ym mharagraff 5, hepgorer "ac, os felly, gyda phwy".

(5) Yn Rhan 2 o'r Atodlen, ym mharagraff 1 yn lle "disgybl chweched dosbarth yn yr ysgol" rhodder "person sydd, neu a oedd, ar unrhyw adeg blaenorol yn ystod y flwyddyn ysgol y cafodd y cais am yr wybodaeth ei wneud ynddi, yn ddisgybl yn chweched dosbarth yr ysgol".

(6) Yn Rhan 2 o'r Atodlen, ym mharagraff 1(c) ar ôl "ddechrau" mewnosoder "a diwedd".

(3) In regulation 2, for the definition of "sixth form pupil" substitute-

""sixth form pupil" ("*disgybl chweched dosbarth*") means a pupil at a school who is in receipt of education suitable to the requirements of pupils above compulsory school age;"

(4) In Part 1 of the Schedule, in paragraph 5, omit "and, if so, with whom".

(5) In Part 2 of the Schedule, in paragraph 1 for "sixth form pupil at the school" substitute "person who is, or was at any previous time during the school year in which the request for the information was made, a pupil in the school's sixth form".

(6) In Part 2 of the Schedule, in paragraph 1(c) after "beginning" insert "and end".
