EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyr) (Mân Dreuliau) 1997 ("Rheoliadau 1997") ymhellach.

These Regulations further amend the Education (Assisted Places) (Incidental Expenses) Regulations 1997 ("the 1997 Regulations").

Mae'r Rheoliadau hyn yn gymwys ynghylch cwestiynau o beidio â chasglu sy'n codi ym mlwyddyn ysgol 2006/07 ac nas penderfynwyd ar y dyddiad y daw'r Rheoliadau hyn i rym arno. Cwestiwn perthnasol yw cwestiwn sy'n ymwneud â hawl rhiant o dan Reoliadau 1997 i gael grant mewn perthynas â mân dreuliau cysylltiedig ag addysg plentyn a gynorthwyr mewn ysgol annibynnol.

The Regulations apply in relation to relevant questions that arise in respect of the 2006/07 school year and which have not been determined at the date on which these Regulations come into force. A relevant question is a question as to a parent's entitlement under the 1997 Regulations to a grant in respect of incidental expenses in connection with the education of an assisted pupil at an independent school.

Mae'r Rheoliadau hyn yn diwygio'r prawf moddion ariannol (a osodir yn rheoliad 2 o Reoliadau 1997) ar gyfer pennu hawl i grant gwisg ysgol ac yn cynyddu swm grant o'r fath sy'n daladwy ar gyfer gwariant ar ddillad sy'n codi yn y flwyddyn ysgol 2006/07. Mae £83 (yn hytrach nag £81 fel cynt) yn daladwy pan nad yw'r incwm perthnasol uwchlaw £12,470 (yn hytrach na £12,182) ac mae £43 (yn hytrach na £42) yn daladwy pan fo'r incwm perthnasol uwchlaw'r ffigwr hwnnw ond nad yw uwchlaw £13,431 (yn hytrach na £13,116).

These Regulations amend the means test (set out in regulation 2 of the 1997 Regulations) for determining eligibility to uniform grant and increase the amount of such grant payable in respect of clothing expenditure incurred in relation to the school year 2006/07. £83 (instead of £81 as previously) is payable where the relevant income does not exceed £12,470 (instead of £12,182) and £43 (instead of £42) is payable where the relevant income exceeds that figure but does not exceed £13,431 (instead of £13,116).

Mae'r Rheoliadau hyn yn diwygio'r prawf moddion ariannol (a osodir yn rheoliad 4 o Reoliadau 1997) ar gyfer pennu hawl i grant teithio ac yn cynyddu swm y grant sy'n daladwy ar gyfer gwariant teithio ysgol mewn perthynas â'r flwyddyn ysgol 2006/07. Pan nad yw'r incwm perthnasol uwchlaw £12,483 (yn hytrach na £12,195), bydd unrhyw grant teithio yn swm cyfatebol i'r gwariant teithio ysgol y mae'n berthnasol

These Regulations also amend the means test (set out in regulation 4 of the 1997 Regulations) for determining eligibility to travel grant, and increase the amount of grant payable in respect of school travel expenditure in relation to the school year 2006/07. Where the relevant income does not exceed £12,483 (instead of £12,195), any travel grant shall be an amount equal to the school travel expenditure to which

The National Assembly for Wales, having consulted, in accordance with section 3(7) of the Education (Schools) Act 1997(1), such bodies as appear to it to be appropriate and representative of schools which provide assisted places under section 2(1) of that Act, makes the following Regulations in exercise of the powers conferred on the Secretary of State by section 3(1), (3), (4), (5) and (9) of that Act(2):

Title, commencement and application

1.-(1) The title of these Regulations is the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2006 and they come into force on 23 November 2006.

(2) Regulation 3 applies in relation to Wales in respect of a relevant question.

(3) In paragraph (2) above, a "relevant question" means a question under the Education (Incidental Expenses) Regulations 1997(3) as to whether the parents of an assisted pupil are entitled to a uniform grant under Part II, or a travel grant under Part III, of those Regulations and which-

Amendment of the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2005

2. At the end of paragraph (3) of regulation 1 of the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2005(1), there is inserted "provided that the question is not one referred to in paragraph (3) of regulation 1 of the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2006".

Amendment of the Education (Assisted Places) (Incidental Expenses) Regulations 1997

3.-(1) The Education (Assisted Places) (Incidental Expenses) Regulations 1997 are amended as follows.

(2) In regulation 2-

- (a) in paragraph (2), substitute "£13,431" for "£13,116";
- (b) in paragraph (3), for sub-paragraphs (a) and (b) substitute-
 - "(a) £83 where the relevant income does not exceed £12,470; and
 - (b) £43 where that income exceeds £12,470, but does not exceed £13,431."

(3) In regulation 4-

- (a) in paragraph (3), substitute "£12,483" for "£12,195"; and
- (b) in paragraph (4) substitute-
 - (i) "£12,483" for "£12,195"; and
 - (ii) "£12,304" for "£12,016".
