EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau.)

(This note is not part of the Regulations)

1. Mae'r Rheoliadau hyn yn gwneud diwygiadau pellach i Reoliadau Bwydydd Anifeiliaid (Cymru) 2006 (OS 2006/116 (Cy.14) a ddiwygiwyd eisoes gan O.S. 2006/617 (Cy.69) ac O.S. 2006/2928 (Cy.263) ("y Rheoliadau Bwydydd Anifeiliaid"), ac maent hefyd yn diwygio Rheoliadau Bwyd Anifeiliaid (Hylendid a Gorfodi) (Cymru) Rheoliadau 2005 (O.S. 2005/3368 (Cy.265) ("y Rheoliadau Hylendid Bwyd Anifeiliaid").

1. These Regulations make further amendments to the Feeding Stuffs (Wales) Regulations 2006 (SI 2006/116 (W.14) as already amended by S.I. 2006/617 (W.69) and S.I. 2006/2928 (W.263) ("the Feeding Stuffs Regulations"), and also amend the Feed (Hygiene and Enforcement) (Wales) Regulations 2005 (S.I. 2005/3368 (W.265) ("the Feed Hygiene Regulations").

2. Mae'r Rheoliadau hyn yn darparu ar gyfer gweithredu'r Cyfarwyddebau CE a ganlyn-

2. These Regulations provide for the implementation of the following EC Directives-

- (a) Cyfarwyddeb y Comisiwn 2005/86/EC sy'n diwygio Atodiad I i Gyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor ar sylweddau annymunol mewn bwyd anifeiliaid o ran camffector (OJ Rhif L318, 6.12.2005, t.16);
- (b) Cyfarwyddeb y Comisiwn 2005/87/EC sy'n diwygio Cyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor ar sylweddau annymunol mewn bwyd anifeiliaid o ran plwm, fflworin a chadmiwm (OJ Rhif L318, 6.12.2005, t.19); ac
- (c) Cyfarwyddeb y Comisiwn 2006/13/EC sy'n diwygio Atodiadau I a II i Gyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor ar sylweddau annymunol mewn bwyd anifeiliaid o ran deuocsinau a PCBs o fath deuocsin (OJ Rhif L32, 4.2.2006, t.44).

- (a) Commission Directive 2005/86/EC amending Annex I to Directive 2002/32/EC of the European Parliament and of the Council on undesirable substances in animal feed as regards camphechlor (OJ No. L318, 6.12.2005, p.16);
- (b) Commission Directive 2005/87/EC amending Annex I to Directive 2002/32/EC of the European Parliament and of the Council on undesirable substances in animal feed as regards lead, fluorine and cadmium (OJ No. L318, 6.12.2005, p.19); and
- (c) Commission Directive 2006/13/EC amending Annexes I and II to Directive 2002/32/EC of the European Parliament and of the Council on undesirable substances in animal feed as regards dioxins and dioxin-like PCBs (OJ No. L32, 4.2.2006, p.44).

3. Mae'r Rheoliadau yn gweithredu hefyd ddarpariaeth a gynhwysir yng Nghyfarwyddeb y Cyngor 79/373/EEC ar gylchredu fwydydd anifeiliaid cyfansawdd (OJ Rhif L86, 6.4.1979, t.30), fel y'i diwygiwyd y Gyfarwyddeb honno ddiwethaf gan Reoliad y Cyngor (EC) Rhif 807/2003 (OJ Rhif L122, 16.5.2003, t.36). Mae'r darpariaeth hon yn perthyn i gyfyngiadau ar amrywio ar gyfer datganiad o gynnwys lleithedd Bwydydd Anifeiliaid ar gyfer Anifeiliad anwes.

4. Mae'r Rheoliadau'n diwygio'r Rheoliadau Bwydydd Anifeiliaid-

- (a) Yn Rhan B o Atodlen 4 drwy fewnosod cyfyngiadau ar amrywio ar gyfer datganiadau o gynnwys lleithedd bwydydd anifeiliaid cyfansawdd ar gyfer anifeiliaid anwes (rheoliad 2(2) ac Atodlen 1);
- (b) ym Mhennod A o Atodlen 5 drwy ddiwygio'r cofnodion presennol ar gyfer cadmiwm, deuocsinau, fflworin a phlwm, a thrwy ychwanegu cofnodion newydd at swm y deuocsinau a PCBs o fath deuocsin (rheoliad 2(2) a Rhan 1 o Atodlen 2 i'r Rheoliadau hyn); a
- (c) ym Mhennod D o Atodlen 5 drwy ddiwygiolr cofnodion presennol ar gyfer camffecloer (tocsaffen) (rheoliad 2(3) a Rhan 2 o Atodlen 2 i'r Rheoliadau hyn).

5. Mae'r Rheoliadau'n diwygio'r Rheoliadau Hylendid Bwyd Anifeiliaid-

- (a) drwy fewnosod rheoliad 24A newydd i roi i swyddogion awdurdodedig awdurdod bwyd anifeiliaid bwerau mynediad, samplu, arolygu a gweithgareddau cysylltiedig er mwyn cyflawni'r swyddogaethau ymchwil sy'n ofynnol gan Gyfarwyddeb 2002/32/EC fel y'i diwygiwyd gan Gyfarwyddeb y Comisiwn 2006/13/EC (rheoliad 3(2)); a
- (b) drwy ddiwygio rheoliad 27(4) (sy'n ymdrin â datgelu gwybodaeth ynghylch samplu) er mwyn ymestyn ei gymhwysiad i samplu a gynhelir o dan reoliad 24A (rheoliad 3(3)).

6. Mae arfarniad rheoliadol o'r effaith y bydd yr offeryn hwn yn ei gael ar gostau busnes wedi'i baratoi a'i osod yn llyfrgell Cynulliad Cenedlaethol Cymru. Gellir cael copïau gan yr Asiantaeth Safonau Bwyd, Llawr 11, Southgate House, Wood Street, Caerdydd, CF10 1EW.

3. The Regulations also implement a provision contained in Council Directive 79/373/EEC on the circulation of compound feedingstuffs (OJ No. L86, 6.4.1979, p30), as last amended by Council Regulation (EC) No. 807/2003 (OJ No. L122, 16.5.2003, p.36). This provision relates to the limits of variation for the declaration of the moisture content of compound pet foods.

4. The Regulations amend the Feeding Stuffs Regulations -

- (a) in Part B of Schedule 4 by inserting limits of variation for declarations of the moisture content of compound pet foods (regulation 2(2) and Schedule 1);
- (b) in Chapter A of Schedule 5 by amending the existing entries for cadmium, dioxin, fluorine and lead, and by adding new entries relating to the sum of dioxins and dioxin-like PCBs (regulation 2(3) and Part 1 of Schedule 2 to these Regulations); and
- (c) in Chapter D of Schedule 5 by amending the existing entries for camphechlor (toxaphene) (regulation 2(4) and Part 2 of Schedule 2 to these Regulations).

5. The Regulations amend the Feed Hygiene Regulations -

- (a) by inserting a new regulation 24A to give authorised officers of a feed authority powers of entry, sampling, inspection and associated activities in order to carry out the investigative functions required by Directive 2002/32/EC as amended by Commission Directive 2006/13/EC (regulation 3(2)); and
- (b) by amending regulation 27(4) (which deals with disclosure of information related to sampling) so as to extend its application to sampling conducted under regulation 24A (regulation 3(3)).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 66(1), 68(1), 69(1), 74A ac 84 o Ddeddf Amaethyddiaeth 1970(1).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by sections 66(1), 68(1), 69(1), 74A and 84 of the Agriculture Act 1970(1).

I'r graddau na ellir gwneud y Rheoliadau hyn o dan y pwerau yn y Ddeddf Amaethyddiaeth a bennir uchod, mae Cynulliad Cenedlaethol Cymru'n gwneud y Rheoliadau hyn yn rhinwedd y ffaith iddo gael ei ddynodi at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(2) o ran mesurau ym maes milfeddygaeth i ddiogelu iechyd y cyhoedd(3).

In so far as these Regulations cannot be made under the powers in the Agriculture Act specified above, the National Assembly for Wales makes these Regulations by virtue of being designated for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to measures in the veterinary field for the protection of public health(3).

There has been consultation during the preparation of these Regulations in accordance with the requirements of section 84(1) of the Agriculture Act 1970 or as appropriate of Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council(4) laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety.

(2) Yn Rhan B o Atodlen 4 (cyfyngiadau ar amrywiad), ar ôl y cofnodion sy'n ymwneud â methionin mewnosoder y cyfnodion ar gyfer lleithedd fel a nodir yn Atodlen 1 i'r Rheoliadau hyn.

(3) O ran y tabl ym Mhennod A o Atodlen 5 (cyfyngiadau rhagnodedig ar gyfer sylweddau annymunol)-

- (a) yn lle'r cofnodion yn y tabl hwnnw sy'n ymwneud â chadmiwm, deuocsin, flworin a phlwm yn eu trefn rhodder y cofnodion ar gyfer y sylweddau hynny fel a osodir yn y tabl yn Rhan 1 o Atodlen 2 i'r Rheoliadau hyn;
- (b) ar ôl y cofnodion ar gyfer deuocsin mewnosoder y cofnodion ar gyfer y swm o ddeuocsinau a PCBs o fath deuocsin fel a nodir yn y tabl yn Rhan 1 o Atodlen 2 i'r Rheoliadau hyn, ac

- (b) yn droednodyn i'r tabl hwnnw ychwaneger y troednodyn i'r tabl yn Rhan 2 o Atodlen 2 i'r Rheoliadau hyn.

Diwygiadau i Reoliadau Bwyd Anifeiliaid (Hylendid a Gorfodi) (Cymru) 2005

3.-(1) Diwygir Rheoliadau Bwyd Anifeiliaid (Hylendid a Gorfodi) (Cymru) 2005(2) yn unol â pharagraffau (2) a (3).

Title and Commencement

1. The title of these Regulations is the The Feed (Specified Undesirable Substances) (Wales) Regulations 2006 and they come into force on 26 December 2006.

Amendments to the Feeding Stuffs (Wales) Regulations 2006

2.-(1) The Feeding Stuffs (Wales) Regulations 2006(1) are amended in accordance with paragraphs (2) to (4).

(2) In Part B of Schedule 4 (limits of variation), after the entries relating to methionine insert the entries for moisture as set out in Schedule 1 to these Regulations.

(3) In relation to the table in Chapter A of Schedule 5 (prescribed limits for undesirable substances)-

- (a) for the entries in that table relating to cadmium, dioxin, fluorine and lead respectively substitute the entries for those substances as set out in the table in Part 1 of Schedule 2 to these Regulations;
- (b) after the entries for dioxin insert the entries for sum of dioxins and dioxin-like PCBs as set out in the table in Part 1 of Schedule 2 to these Regulations, and
- (c) as footnotes to that table add the footnotes to the table in Part 1 of Schedule 2 to these Regulations.

(4) In relation to the table in Chapter D of Schedule 5 -

- (a) for the entries in that table relating to campechlor (toxaphene) substitute the entries as set out in the table in Part 2 of Schedule 2 to these Regulations, and
- (b) as a footnote to that table add the footnote to the table in Part 2 of Schedule 2 to these Regulations.

Amendments to the Feed (Hygiene and Enforcement) (Wales) Regulations 2005

"24A.-(1) At ddibenion cyflawni ymchwiliadau, yn unol ag Erthygl 4.2 o Gyfarwyddeb 2002/32, er mwyn penderfynu ffynhonnell y sylweddau annymunol hynny a restrir yn Atodiad II i'r Gyfarwyddeb honno pan fydd trothwyon gweithredu a bennir yn yr Atodiad hwnnw wedi cael eu cyrraedd, caiff swyddog awdurdodedig, ar bob adeg resymol ac wrth ddangos, os gofynnir amdani, ddogfen a ddilyswyd yn briodol sy'n dangos ei awdurdod, fynd i mewn i unrhyw fangre (nad yw'n fangre a ddefnyddir fel annedd yn unig) lle mae gan y swyddog achos rhesymol dros greu bod bwyd anifeiliaid yn cael neu wedi cael ei weithgynhyrchu neu ei gynhyrchu, wedi'i roi ar y farchnad neu'n cael ei gadw er mwyn ei roi ar y farchnad, ei gynnwys mewn unrhyw gynnyrch arall neu ei ddefnyddio.

(2) Caiff swyddog awdurdodedig sy'n mynd i mewn i unrhyw fangre yn rhinwedd y rheoliad hwn -

- (a) mynd â'r personau eraill hynny gydag ef y mae'r swyddog yn tybio eu bod yn angenrheidiol ac unrhyw gyfarpar;
- (b) arolygu unrhyw beth y mae gan y swyddog hawl i'w arolygu o dan reoliad 24(5), ac
- (c) cymryd sampl yn y fangre honno o unrhyw ddeunydd y mae'n ymddangos i'r swyddog sy'n fwyd anifeiliaid a weithgynhyrchwyd, a gynhyrchwyd, a roddwyd ar y farchnad neu y bwriedir ei roi ar y farchnad neu sy'n ddeunydd a ddefnyddir neu y bwriedir ei ddefnyddio fel bwyd anifeiliaid.

(3) Os bydd swyddog awdurdodedig er mwyn cymryd sampl yn unol â pharagraff (2)(c) yn cymryd deunydd o un cynhwysydd neu fwy ohonynt y mae pob un ohonynt yn pwyso dim mwy na chwe chilogram, ac sydd wedi cael eu datgelu i'w gwerthu drwy fanwerthu, caiff perchennog y cynhwysydd neu'r cynwysyddion ei gwneud yn ofynnol i'r swyddog awdurdodedig brynu'r cynhwysydd neu'r cynwysyddion ar ran yr awdurdod y mae'r swyddog yn gweithio iddo.

(4) Mae gan swyddog awdurdodedig sy'n mynd i mewn i unrhyw fangre yn rhinwedd y rheoliad hwn yr un hawliau i gael gweld, arolygu a chopïo cofnodion, gan gynnwys cofnodion a gedwir ar gyfrifiadur neu a gynhyrchir ganddo, fel a bennir ym mharagraff (9)(a) a (b) a (10)(c) o reoliad 24.

(5) Mae paragraff (14) o reoliad 24 yn gymwys i'r pŵer mynediad o dan y rheoliad hwn fel y mae'n gymwys i'r cyfryw bwerau o dan y rheoliad hwnnw.

(2) After regulation 24, insert the following regulation -

"24A.-(1) For the purpose of carrying out investigations, in accordance with Article 4.2 of Directive 2002/32, to determine the source of those undesirable substances listed in Annex II to that Directive where action thresholds specified in that Annex have been reached, an authorised officer may, at all reasonable times and on producing if requested some duly authenticated document showing his or her authority, enter any premises (not being premises used only as a dwelling) on which the officer has reasonable cause to believe that feed has been or is being manufactured or produced, has been placed on the market or is being kept for the purpose of being placed on the market, incorporated into another product or used.

(2) An authorised officer entering any premises by virtue of this regulation may -

- (a) take with him or her such other persons and such equipment as may appear to the officer to be necessary;
- (b) inspect anything that the officer has the right to inspect under regulation 24(5), and
- (c) take on those premises a sample of any material appearing to the officer to be a feed manufactured, produced, placed on the market or intended to be placed on the market or to be material used or intended for use as feed.

(3) Where for the purposes of taking a sample pursuant to paragraph (2)(c) an authorised officer takes material from one or more containers each of which weighs no more than six kilograms, and which are exposed for sale by retail, the owner of the container or containers may require the authorised officer to purchase the container or containers on behalf of the authority for which the officer acts.

(4) An authorised officer entering any premises by virtue of this regulation has the same rights to production, inspection and copying of records, including records kept on or produced by a computer, as are specified in paragraphs (9)(a) and (b) and (10)(c) of regulation 24.

(5) Paragraph (14) of regulation 24 applies to the power of entry under this regulation as it does to such powers under that regulation.
