Mae'r Rheoliadau hyn yn diwygio ymhellach Reoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2001 ("y prif Reoliadau") sy'n darparu ar gyfer codi ac adennill ffioedd am gyffuriau a chyfarpar sy'n cael eu cyflenwi o dan Ddeddf y Gwasanaeth Iechyd Gwladol 1977.

Mae rheoliad 2 yn rhoi paragraff (1) newydd yn rheoliad 8 o'r prif Reoliadau (esemtiau) sy'n cynnwys darpariaeth i ddynodi terfyn i'r esemtiaid sydd ar gael rhag ffi ar gyfer y personau hynny o dan 25 oed i'r personau hynny sy'n cyflwyno ffurflen bresgripsiwn Gymreig neu swp-ddyroddiad ynglŷn â phresgripsiwn amlroddadwy Cymreig ar gyfer ei weinyddu yng Nghymru.

Mae'r diwygiadau eraill a wneir gan y Rheoliadau hyn yn ganlyniad i fewnosod y paragraff (1) newydd yn rheoliad 8 o'r prif Reoliadau.

### EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001 ("the principal Regulations") which provide for the making and recovery of charges for drugs and appliances supplied under the National Health Service Act 1977.

Regulation 2 substitutes a new paragraph (1) into regulation 8 of the principal Regulations (exemptions) which includes provision to limit the availability of the exemption from charge for those persons under the age of 25 years to those persons who present a Welsh prescription form or a batch issue relating to a Welsh repeatable prescription for dispensing in Wales.

The other amendments made by these Regulations are consequential upon the insertion of the new paragraph (1) into regulation 8 of the principal Regulations.

The National Assembly for Wales, in exercise of the  
powers conferred by sections 77, 83, 83A and 126(4)  
of the National Health Service Act 1977(1) hereby  
makes the following Regulations:

**1.-(1)** Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd am Gyffuriau a Chyfarpar) (Cymru) (Diwygio) 2006 a deuant i rym ar 1 Ebrill 2006.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

**2.-(1)** Diwygir rheoliad 8 o'r prif Reoliadau (esemtiau) fel a ganlyn.

"(1) Yn ddarostyngedig i baragraff (3), ni fydd ffi yn daladwy o dan reoliadau 3, 4, 6 neu 7 gan y canlynol-

- (a) person sydd o dan 16 oed;
- (b) person sydd o dan 19 oed sy'n derbyn addysg lawnamser gymwys o fewn ystyr paragraff 7 o Atodlen 12 i'r Ddeddf;
- (c) person sydd o dan 25 oed ac sy'n cyflwyno-
  - (i) ffurflen bresgripsiwn Gymreig, neu
  - (ii) swp-ddyroddiad sy'n ymwneud â phresgripsiwn amlroddadwy Cymreig;
- (ch) person sydd wedi cyrraedd 60 oed;
- (d) menyw sydd â thystysgrif esemptio ddilys a ddyroddwyd gan Fwrdd Iechyd Lleol ar y sail ei bod yn fam sy'n disgwyl neu sydd wedi rhoi genedigaeth yn ystod y deuddeg mis diwethaf i blentyn byw neu i blentyn y gellir cofrestru ei fod yn farwanedig o dan Ddeddf Cofrestru Genedigaethau a Marwolaethau 1953(2) neu sydd â thystysgrif esemptio ddilys a ddyroddwyd o dan drefniadau cyfatebol sy'n effeithiol yn Lloegr, yr Alban neu Ogledd Iwerddon;
- (dd) person sydd â thystysgrif esemptio ddilys a ddyroddwyd gan Fwrdd Iechyd Lleol ar y sail ei fod yn dioddef un neu fwy o'r cyflyrau canlynol-

## **Title, commencement application and interpretation**

**1.-(1)** The title of these Regulations is the National Health Service (Charges for Drugs and Appliances) (Wales) (Amendment) Regulations 2006 and they come into force on 1 April 2006.

(2) These Regulations apply in relation to Wales.

(3) In these Regulations "the principal Regulations" ("y prif Reoliadau") means the National Health Service (Charges for Drugs and Appliances) (Wales) Regulations 2001(1).

## **Amendment of regulation 8 of the principal Regulations**

**2.-(1)** Regulation 8 of the principal Regulations (exemptions) is amended as follows.

(2) For paragraph (1) substitute the following-

"(1) Subject to paragraph (3), no charge will be payable under regulations 3, 4, 6 or 7 by-

- (a) a person who is under 16 years of age;
- (b) a person who is under 19 years of age and who is receiving qualifying full-time education within the meaning of paragraph 7 of Schedule 12 to the Act;
- (c) a person who is under 25 years of age and who presents-
  - (i) a Welsh prescription form, or
  - (ii) a batch issue relating to a Welsh repeatable prescription;
- (d) a person who has attained the age of 60 years;
- (e) a woman with a valid exemption certificate issued by a Local Health Board on the ground that she is an expectant mother or has within the last twelve months given birth to a live child or a child registrable as still-born under the Births and Deaths Registration Act 1953(2) or with a valid exemption certificate issued under equivalent arrangements having effect in England, Scotland or Northern Ireland;
- (f) a person with a valid exemption certificate issued by a Local Health Board on the ground that he or she is suffering from one of more of the following conditions-

- (i) ffistwla parhaol (gan gynnwys caecostomi, colostomi, laryngostomi neu ileostomi) sy'n gwneud gorchuddion llawfeddygol neu gyfarpar yn ofynnol yn barhaol;
  - (ii) yr anhydlerau canlynol-
    - ffurfiau o hypoadrenaledd (gan gynnwys clefyd Addison) y mae therapi amnewid penodol yn hanfodol ar ei gyfer
    - diabetes insipidus a ffurfiau eraill o hypobidwitedd
    - diabetes mellitus - ac eithrio pan yw'r drinaeth drwy ddeiet yn unig
    - hypoarathyroidedd
    - myasthenia gravis
    - mycsoedema
  - (iii) epilepsi sy'n ei gwneud yn ofynnol i barhau â therapi gwrth-ddirdynnol;
  - (iv) anabledd corfforol parhaus sy'n rhwystro'r claf rhag gadael ei breswylfa heb gymorth person arall;
- neu gan berson sydd â thystysgrif esemptio ddilys a ddyroddwyd o dan drefniadau cyfatebol sy'n effeithiol yn Lloegr, yr Alban neu Ogledd Iwerddon;
- (e) person sydd â thystysgrif esemptio ddilys a ddyroddwyd gan y Cynulliad Cenedlaethol o ran cyflenwi cyffuriau a chyfarpar ar gyfer trin anabledd sydd wedi'i dderbyn, ond yn y naill achos neu'r llall dim ond o ran y cyflenwadau hynny y mae'r dystysgrif yn ymwneud â hwy;
  - (f) person sydd â thystysgrif ragdalu ddilys neu dystysgrif ragdalu ddilys a roddwyd o dan drefniadau cyfatebol sy'n effeithiol yn Lloegr, yr Alban neu Ogledd Iwerddon".

**(3) Ym mharagraff (2)-**

- (a) yn is-baragraff (a) yn lle "yn unrhyw un o is-baragraffau (a), (b) neu (d)" rhodder "yn unrhyw un o is-baragraffau (a) i (ch) neu (e)";
- (b) yn is-baragraff (b) yn lle "is-baragraffau (a) i (dd)" rhodder "is-baragraffau (a) i (f)".

**(4) Ym mharagraff (3A) yn lle "paragraff (1)(a) neu (b)" rhodder "paragraff (1)(a) i (ch)".**

**Diwygio rheoliad 9 o'r prif Reoliadau**

**3.-(1)** Diwygir rheoliad 9 o'r prif Reoliadau (Tystysgrifau esemptio - gwneud cais amdanynt a'u rhoi) fel a ganlyn.

**(2) Ym mharagraff (1)-**

- (i) permanent fistula (including caecostomy, colostomy, laryngostomy or ileostomy) requiring continuous surgical dressing or an appliance;
  - (ii) the following disorders-
    - forms of hypoadrenalinism (including Addison's disease) for which specific substitution therapy is essential
    - diabetes insipidus and other forms of hypopituitarism
    - diabetes mellitus - except where treatment is by diet alone
    - hypoarathyroidism
    - myasthenia gravis
    - myxoedema
  - (iii) epilepsy requiring continuous anti-convulsive therapy;
  - (iv) a continuing physical disability which prevents the patient from leaving his or her residence without the help of another person;
- or by a person with a valid exemption certificate issued under equivalent arrangements having effect in England, Scotland or Northern Ireland;
- (g) a person with a valid exemption certificate issued by the National Assembly in respect of the supply of drugs and appliances for the treatment of accepted disablement, but in either case only in respect of those supplies to which the certificate relates;
  - (h) a person with a valid pre-payment certificate or with a valid pre-payment certificate granted under equivalent arrangements having effect in England, Scotland or Northern Ireland".

**(3) In paragraph (2)-**

- (a) in sub-paragraph (a) for "in any of sub-paragraphs (a), (b) or (e)" substitute "in any of sub-paragraphs (a) to (d) or (g)";
- (b) in sub-paragraph (b) for "sub-paragraphs (a) to (f)" substitute "sub-paragraphs (a) to (h)".

**(4) In paragraph (3A) for "paragraff (1)(a) or (b)" substitute "paragraff (1)(a) to (d)".**

**Amendment of regulation 9 of the principal Regulations**

**3.-(1)** Regulation 9 of the principal Regulations (Certificates of exemption - application and issue) is amended as follows.

**(2) In paragraph (1)-**

- (b) for "regulation 8(1)(d)" substitute "regulation 8(1)(f)".

(5) In paragraph (4) for "regulation 8(1)(e)" substitute "regulation 8(1)(g)".

- (4) In paragraph 10(a) for "regulation 8(1)(b) to (e)" substitute "regulation 8(1)(d) to (g)".
- (5) In paragraph 14(b)(i) for "regulation 8(1)(b) to (e)" substitute "regulation 8(1)(d) to (g)".
- (6) In paragraph 14(c)(i) for "regulation 8(1)(b) to (e)" substitute "regulation 8(1)(d) to (g)".

## **Amendment of regulation 11 of the principal Regulations**

5. In regulation 11(3) of the principal Regulations (repayment of charges) for "regulation 8(1)(e)" substitute "regulation 8(1)(g)".
