EXPLANATORY NOTE

Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn rhagnodi ffioedd o ran arolygiadau a wneir at ddibenion rhoi awdurdod i ddyroddi pasbortau planhigion (gan gynnwys gwirio cofnodion busnes) o dan naill ai Orchymyn Iechyd Planhigion (Cymru) 2006 (O.S. 2006/1643 (Cy. 158)) neu Orchymyn Iechyd Planhigion (*Phytophthora ramorum*) (Cymru) 2006 (O.S. 2004/1344 (Cy. 134)) ("y Gorchmynion").

These Regulations, which apply in relation to Wales, prescribe fees in respect of inspections carried out for the purpose of conferring authority to issue plant passports (including check of business records) under either the Plant Health (Wales) Order 2006 (S.I. 2006/1643 (W. 158)) or the Plant Health (*Phytophthora ramorum*) (Wales) Order 2006 (S.I. 2004/1344 (W. 134)) ("the Orders").

O dan y Gorchmynion, mae'n ofynnol i blanhigion rhestredig penodol, cynhyrchion planhigion penodol a gwrthrychau eraill gael pasbort planhigion ar gyfer symud o fewn y Gymuned Ewropeaidd gan gynnwys unrhyw fasnachu o fewn y Deyrnas Unedig. Caiff Gweinidogion Cymru awdurdodi cynhyrchwyr, masnachwyr a mewnforwyr deunyddiau o'r fath i ddyroddi pasbortau planhigion. Mae'r broses awdurdodi ddechreuol yn golygu arolygu'r fangre a'r deunydd planhigion rhestredig ac mae'n cynnwys gwirio cofnodion busnes a chaniateir cynnal arolygiadau pellach ar ôl rhoi'r awdurdodiad er mwyn sicrhau cydymffurfedd â gofynion perthnasol.

Under the Orders, certain listed plants, certain plant products and other objects require a plant passport for movement within the European Community including any trade within the United Kingdom. Producers, traders and importers of such material may be authorised to issue plant passports by the Welsh Ministers. The initial authorisation process involves an inspection of premises and the listed plant material and includes a check on business records and further inspections may be carried out subsequent to the grant of authority to ensure compliance with relevant requirements.

Pennir y ffioedd sy'n daladwy o ran y cyfryw arolygiadau yn rheoliad 3(2).

The fees payable in respect of such inspections are specified in regulation 3(2).

Mae rheoliad 4 yn dirymu Rheoliadau Pasbortau Planhigion (Ffioedd Iechyd Planhigion) (Cymru a Lloegr) 1993 (O.S. 1993/1642) a Rheoliadau Pasbortau Planhigion (Ffioedd Iechyd Planhigion) (Cymru a Lloegr) (Diwygio) 1997 (O.S. 1997/1961). Nid oes newid yn lefel y ffioedd a geir yn O.S. 1997/1961 ond maent yn awr yn gymwys hefyd i awdurdodiadau o dan Orchymyn Iechyd Planhigion (*Phytophthora ramorum*) (Cymru) 2006.

Regulation 4 revokes the Plant Passport (Plant Health Fees) (England and Wales) Regulations 1993 (S.I. 1993/1642) and the Plant Passport (Plant Health Fees) (England and Wales) (Amendment) Regulations 1997 (S.I. 1997/1961). The level of fees remains unchanged from S.I. 1997/1961 but now apply also to authorisations under the Plant Health (*Phytophthora ramorum*) (Wales) Order 2006.

Mae Gweinidogion Cymru, gyda chydsyniad y Trysorlys, yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adran 56 o Ddeddf Cyllid 1973(1), ac a freiniwyd bellach ynddynt hwy:

The Welsh Ministers, with the consent of the Treasury, make the following Regulations in exercise of the powers conferred by section 56 of the Finance Act 1973(1) and now vested in them:

Title, commencement and application

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Iechyd Planhigion (Ffioedd Pasbortau Planhigion) (Cymru) 2007.

1.-(1) The title of these Regulations is the Plant Health (Plant Passport Fees) (Wales) Regulations 2007.

(2) Mae'r Rheoliadau hyn yn dod i rym ar 13 Gorffennaf 2007 ac maent yn gymwys o ran Cymru.

(2) These Regulations come into force on 13 July 2007 and apply in relation to Wales.

2. Yn y Rheoliadau hyn-

2. In these Regulations-

ystyr "awdurdodiad" ("*authority*") yw awdurdodiad i ddyroddi pasbortau planhigion a roddir o dan erthygl 8 o Orchymyn Iechyd Planhigion (*Phytophthora ramorum*) (Cymru) 2006(2) neu, yn ôl y digwydd, o dan erthygl 29 o Orchymyn Iechyd Planhigion (Cymru) 2006(3); a

"authority" ("*awdurdodiad*") means an authority to issue plant passports conferred under article 8 of the Plant Health (*Phytophthora ramorum*) (Wales) Order 2006(2) or, as the case may be, under article 29 of the Plant Health (Wales) Order 2006(3); and

3.-(1) Rhaid talu'r ffi a bennir ym mharagraff (2) i Weinidogion Cymru o ran unrhyw arolygiad (gan gynnwys gwiriad o gofnodion busnes) sy'n cael ei gynnal mewn cysylltiad ag-

- (a) cais am awdurdodiad; neu
- (b) sicrhau cydymffurfedd ag unrhyw ofynion a osodir ar ddeiliad awdurdodiad yn rhinwedd erthygl 8 o Orchymyn Iechyd Planhigion (Phytophthora ramorum) (Cymru) 2006 neu erthygl 29 o Orchymyn Iechyd Planhigion (Cymru) 2006.

(2) Y ffi yw £20.25 am bob chwarter awr neu ran o chwarter awr y mae arolygydd yn ei dreulio ar y safle gyda lleiafswm o £40.50 o ran unrhyw ymweliad.

Dirymu

4. Dirymir y Rheoliadau canlynol i'r graddau y maent yn gymwys o ran Cymru-

- (a) Rheoliadau Pasbortau Planhigion (Ffioedd Iechyd Planhigion) (Cymru a Lloegr) 1993(1); a
- (b) Rheoliadau Pasbortau Planhigion (Ffioedd Iechyd Planhigion) (Cymru a Lloegr) (Diwygio) 1997(2).

Fee for inspections for plant passporting purposes

3.-(1) The fee specified in paragraph (2) is to be paid to the Welsh Ministers in respect of any inspection (including a check of business records) carried out in connection with-

- (a) an application for an authority; or
- (b) ensuring compliance with any requirements imposed on the holder of an authority by virtue of article 8 of the Plant Health (Phytophthora ramorum) (Wales) Order 2006 Order or article 29 of the Plant Health (Wales) Order 2006 .

(2) The fee is £20.25 for each quarter of an hour or part thereof spent on site by an inspector with a minimum of £40.50 in respect of any visit.

Revocations

4. The following Regulations are revoked insofar as they apply to Wales-

- (a) the Plant Passport (Plant Health Fees) (England and Wales) Regulations 1993(1); and
- (b) the Plant Passport (Plant Health Fees) (England and Wales) (Amendment) Regulations 1997(2).
