2. Rhoes Rheoliadau Cynhyrchion Buchol (Cyfyngu ar eu Rhoi ar y Farchnad) (Cymru) (Rhif 2) 2005 ei heffalha o ran Cymru i Erthygl 1.1 o Benderfyniad y Comisiwn 205/598/EC sy'n gwahardd rhoi ar y farchnad gynhyrchion sy'n dod o anifeiliaid buchol a anwyd neu a fagwyd o fewn y Deyrnas Unedig cyn 1 Awst 1996 at unrhyw ddiben ac yn esemptio'r anifeiliaid hynny rhag mesurau rheoli a difodi penodol a osodwyd yn Rheoliad (EC) Rhif 999/2001 (OJ Rhif L204, 5.8.2005, t.22). The Bovine Products (Restriction on Placing on the Market) (Wales) (No. 2) (Amendment) Regulations 2007

EXPLANATORY NOTE

(This note is not part of the Regulations)

1. These Regulations amend the Bovine Products (Restriction on Placing on the Market) (Wales) (No. 2) Regulations 2005 (S.I. 2005/3296 W. 254) by-

- (a) updating the definitions of certain Community instruments that are referred to in those Regulations (*regulation 2(2)(a) and (4)*);
- (b) substituting a reference to the Commission Decision that has repealed and replaced an earlier Commission Decision for the reference to that earlier Decision that appears in those Regulations (*regulation 2(2)(b)*); and
- (c) correcting a drafting error in those Regulations (*regulation 2(3)*).

2. The Bovine Products (Restriction on Placing on the Market) (Wales) (No. 2) Regulations 2005 gave effect in relation to Wales to Article 1.1 of Commission Decision 205/598/EC prohibiting the placing on the market of products derived from bovine animals born or reared within the United Kingdom before 1st August 1996 for any purpose and exempting such animals from certain control and eradication measures laid down in Regulation (EC) No. 999/2001 (OJ No. L204, 5.8.2005, p.22). Article 1.1 of Commission Decision 2005/598/EC provided that certain products derived from bovine animals born or reared within the United Kingdom before 1st August 1996 could not be placed on the market.

3. Mae Penderfyniad y Comisiwn 2005/598/EC wedi'i ddiddymu a'i ddisodli bellach gan Benderfyniad y Comisiwn 2007/411/EC sy'n gwahardd rhoi ar y farchnad gynhyrchion sy'n dod o anifeiliaid buchol a anwyd neu a fagwyd o fewn y Deyrnas Unedig cyn 1 Awst 1996 at unrhyw ddiben ac yn esemptio'r anifeiliaid hynny rhag mesurau rheoli a difodi penodol a osodwyd yn Rheoliad (EC) Rhif 999/2001 ac yn diddymu Penderfyniad y Comisiwn 2005/598/EC (OJ Rhif L155, 15.6.2007, t.74).

4. Mae Erthygl 1.1 o Benderfyniad y Comisiwn 2007/411/EC wedi'i mynegi mewn termau sydd yn union yr un fath ag Erthygl 1.1 o Benderfyniad y Comisiwn 2005/598/EC ac mae Rheoliadau Cynhyrchion Buchol (Cyfyngu ar eu Rhoi ar y Farchnad) (Cymru) (Rhif 2) 2005 fel y'u diwygiwyd gan y Rheoliadau hyn yn rhoi ei heffaith o ran Cymru i Erthygl 1.1 o Benderfyniad y Comisiwn 2007/411/EC.

5. Nid oes asesiad effaith rheoleiddiol llawn wedi'i lunio ar gyfer yr offeryn hwn, gan na ragwelir y bydd yr offeryn yn effeithio o gwbl ar y sector preifat na'r sector gwirfoddol.

3. Commission Decision 2005/598/EC has now been repealed and replaced by Commission Decision 2007/411/EC prohibiting the placing on the market of products derived from bovine animals born or reared within the United Kingdom before 1st August 1996 for any purpose and exempting such animals from certain control and eradication measures laid down in Regulation (EC) No. 999/2001 and repealing Commission Decision 2005/598/EC (OJ No. L155, 15.6.2007, p.74).

4. Article 1.1 of Commission Decision 2007/411/EC is in identical terms to Article 1.1 of Commission Decision 2005/598/EC and the Bovine Products (Restrictions on Placing on the Market) (Wales) (No. 2) Regulations 2005 as amended by these Regulations give effect in relation to Wales to Article 1.1 of Commission Decision 2007/411/EC.

5. A full regulatory assessment has not been produced for this instrument as no impact on the private or voluntary sector is foreseen.

The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by section 2(2) of the European Communities Act 1972(1).

The Welsh Ministers have been designated for the purposes of that section in relation to measures in the veterinary field for the protection of public health(2).

Title and commencement

1. The title of these Regulations is the Bovine Products (Restriction on Placing on the Market) (Wales) (No. 2) (Amendment) Regulations 2007 and come into force on 27 June 2007.

2.-(1) The Bovine Products (Restriction on Placing on the Market) (Wales) (No. 2) Regulations 2005(3) are amended in accordance with paragraphs (2) to (4).
