Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, wedi'u gwneud yn unol â'r ddyletswydd yn rheoliad 3(1) o Reoliadau Sŵn Amgylcheddol (Cymru) 2006 (O.S. 2006/2629 (Cy.225)) i nodi'r ffynonellau sŵn y mae'n rhaid eu mapio yn unol â pharagraff cyntaf Erthygl 7 o Gyfarwyddeb 2002/49/EC Senedd Ewrop a'r Cyngor dyddiedig 25 Mehefin 2002 ynglych asesu a thraffod sŵn amgylcheddol (O.J. Rhif L 189, 18.07.2002, t. 12).

Crynodrefi, prif ffyrdd, prif reilffyrdd a phrif feysydd awyr yw'r ffynonellau sŵn sydd i'w nodi. Mae rheoliad 3 o Reoliadau 2006 yn pennu meini prawf y mae'n rhaid i Weinidogion Cymru eu cymhwysu wrth wneud y nodi mewn perthynas â Chymru.

Y maen prawf i'w gymhwysu i brif feysydd awyr yw bod y maes awyr yn faes awyr sifil lle y mae mwy na 50,000 o symudiadau y flwyddyn (ac mae symudiad yn golygu awyren yn codi neu'n glanio), heb gynnwys symudiadau at ddibenion hyfforddiant yn unig ar awyrennau ysgafn. Mae Gweinidogion Cymru wedi penderfynu nad oes unrhyw faes awyr yng Nghymru yn bodloni'r maen prawf hwn: felly nid oes unrhyw brif faes awyr wedi'i nodi yn y Rheoliadau hyn.

Mae'r nodi wedi'i wneud drwy gyfeirio at fapiau: mae'r rhain wedi'u hadneuo yn swyddfeydd Llywodraeth Cynulliad Cymru ym Mharc Cathays, Caerdydd CF10 3NQ lle gellir eu harchwilio yn ystod oriau swyddfa. Mae'r mapiau ar gael hefyd yn y cyfeiriad canlynol ar y we:

The Environmental Noise  
(Identification of Noise Sources)  
(Wales) Regulations 2007

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

These Regulations, which apply in relation to Wales, are made pursuant to the duty in regulation 3(1) of the Environmental Noise (Wales) Regulations 2006 (S.I. 2006/2629 (W.225)) to identify the noise sources that must be mapped pursuant to the first paragraph of Article 7 of Directive 2002/49/EC of the European Parliament and of the Council of 25 June 2002 relating to the assessment and management of environmental noise (O.J. No. L 189, 18.07.2002, p. 12).

The noise sources to be identified are agglomerations, major roads, major railways and major airports. Regulation 3 of the 2006 Regulations specifies criteria which the Welsh Ministers must apply when making identifications in relation to Wales.

The criterion to be applied to major airports is that the airport is a civil airport which has more than 50,000 movements per year (a movement being a take-off or landing), excluding those purely for training purposes on light aircraft. The Welsh Ministers have determined that no airport in Wales meets this criterion: therefore no identification of a major airport is made in these Regulations.

The identifications are made by reference to maps: these have been deposited at the offices of the Welsh Assembly Government at Cathays Park, Cardiff CF10 3NQ where they may be inspected during office hours. The maps are also available at the following web address:

Nid oes asesiad effaith reoleiddiol wedi'i gynnal mewn perthynas â'r Rheoliadau hyn. **Enwi, cychwyn a chymhwysyo**

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Sŵn Amgylcheddol (Nodi Ffynonellau Sŵn) (Cymru) 2007.

(2) Daw'r Rheoliadau hyn i rym ar 9 Ionawr 2008.

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

**Dehongli**

2.—(1) Ystyr "map a adneuwyd" ("deposited map") yw map sydd wedi'i lofnodi ar ran Gweinidogion Cymru ac wedi'i adneuo yn eu swyddfeydd.

The Welsh Ministers are designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to measures relating to the assessment, management and control of environmental noise.

The Welsh Ministers make these Regulations in exercise of the powers conferred by that section.

**Title, commencement and application**

1.—(1) The title of these Regulations is The Environmental Noise (Identification of Noise Sources) (Wales) Regulations 2007.

(2) These Regulations come into force on 9 January 2008.

(3) These Regulations apply in relation to Wales

**Interpretation**

2.—(1) "Deposited map" ("map a adneuwyd") means a map that is signed on behalf of the Welsh Ministers and deposited at their offices.

- (b) ar y map a adneuwyd o'r enw "Swansea/Neath/Port Talbot - First Round Agglomeration - Abertawe/Castell-nedd/Port Talbot - Cylch Cyntaf, Crynodref", dyddiedig 13 Rhagfyr 2007 ac sy'n dwyn y cyfeirnod END\I\W\FRSwansea/Neath/Port Talbot.

## Prif ffyrdd cylch cyntaf

5. Prif ffyrdd cylch cyntaf yw'r rhai a ddynodir—

- (a) ar y map a adneuwyd o'r enw "Wales (North) - First Round Major Roads - Cymru (Gogledd) - Cylch Cyntaf, Prif Ffyrdd", dyddiedig 13 Rhagfyr 2007 ac sy'n dwyn y cyfeirnod END\I\W\FRNRoads; a
- (b) ar y map a adneuwyd o'r enw "Wales (South) - First Round Major Roads - Cymru (De) - Cylch Cyntaf, Prif Ffyrdd", dyddiedig 13 Rhagfyr 2007 ac sy'n dwyn y cyfeirnod END\I\W\FRSRoads.

## Prif reilffyrrdd cylch cyntaf

6. Prif reilffyrrdd cylch cyntaf yw'r rhai a ddynodir ar y map a adneuwyd o'r enw "Wales - First Round Major Railways - Cymru - Cylch Cyntaf, Prif Reilffyrrdd", dyddiedig 13 Rhagfyr 2007 ac sy'n dwyn y cyfeirnod END\I\W\FRRail.

(2) "the 2006 Regulations" ("Rheoliadau 2006") means the Environmental Noise (Wales) Regulations 2006(1).

(3) Words and terms used in these Regulations that are also used in the 2006 Regulations have the same meaning as in the 2006 Regulations.

## Identification of noise sources

3. Regulations 4, 5 and 6 identify first round agglomerations, first round major roads and first round major railways for the purposes of regulation 3(1) of the 2006 Regulations.

## First round agglomerations

- 4. First round agglomerations are those denoted on—
  - (a) the deposited map entitled "Cardiff - First Round Agglomeration - Caerdydd - Cylch Cyntaf, Crynodref", dated 13 December 2007 and bearing the reference number END\I\W\FRCardiff; and
  - (b) the deposited map entitled "Swansea/Neath/Port Talbot - First Round Agglomeration - Abertawe/Castell-nedd/Port Talbot - Cylch Cyntaf, Crynodref", dated 13 December 2007 and bearing the reference number END\I\W\FRSwansea/Neath/Port Talbot.

## First round major roads

- 5. First round major roads are those denoted on—
  - (a) the deposited map entitled "Wales (North) - First Round Major Roads - Cymru (Gogledd) - Cylch Cyntaf, Prif Ffyrdd", dated 13 December 2007 and bearing the reference number END\I\W\FRNRoads; and
  - (b) the deposited map entitled "Wales (South) - First Round Major Roads - Cymru (De) - Cylch Cyntaf, Prif Ffyrdd", dated 13 December 2007 and bearing the reference number END\I\W\FRSRoads.

## First round major railways

6. First round major railways are those denoted on the deposited map entitled "Wales - First Round Major Railways - Cymru - Cylch Cyntaf, Prif Reilffyrrdd", dated 13 December 2007 and bearing the reference number END\I\W\FRRail.
