1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Hylendid Bwyd (Cymru) 2006 (O.S. 2006/31 (Cy.5)) drwy ddiweddarau diffiniadau offerynnau penodol y Gymuned y cyfeirir atynt yn y Rheoliadau hynny.

1. These Regulations amend the Food Hygiene (Wales) Regulations 2006 (S.I. 2006/31 (W.5)) by updating the definitions of certain Community instruments that are referred to in those Regulations.

2. The definitions are updated by-

- (a) rhoi diffiniadau offerynnau penodol y Gymuned yn lle diffiniadau offerynnau penodol y Gymuned sy'n ymddangos ar hyn o bryd ar ôl y diffiniad o "mangre" ym mharagraff (1) o reoliad 2 (dehongli) (rheoliad 2(2)); a
- (b) rhoi Atodlen 1 ddiwygiedig (diffiniadau o ddeddfwriaeth y Gymuned) yn lle'r Atodlen 1 bresennol (rheoliad 2(3)).

- (a) substituting definitions of certain Community instruments for the definitions of the Community instruments that currently appear after the definition of "premises" in paragraph (1) of regulation 2 (interpretation) (regulation 2(2)); and
- (b) substituting a revised Schedule 1 (definitions of Community legislation) for the existing Schedule 1 (regulation 2(3)).
