O dan Ran I o Ddeddf Cyllid Llywodraeth Leol 1992, gostyngir y swm sy'n daladwy o ran y dreth gyngor os yw person sy'n preswyllo mewn annedd yn teilyngu cael ei ddiystyru at ddibenion disgownt. Mae Atodlen 1 i Ddeddf 1992 yn darparu i ddosbarthau o bersonau gymhwyso at ddibenion disgownt. Mae Gorchymyn y Dreth Gyngor (Diystyru Disgownt) 1992 ("Gorchymyn 1992") yn gwneud darpariaeth bellach ynglyn â rhai o'r dosbarthau hynny.

Under Part I of the Local Government Finance Act 1992, the amount payable for council tax is reduced where a person resident in a dwelling falls to be disregarded for the purpose of discount. Schedule 1 to the 1992 Act provides for classes of persons to qualify for the purpose of discount. The Council Tax (Discount Disregards) Order 1992 ("the 1992 Order") makes further provision in relation to certain of those classes.

Mae Erthygl 3 o'r Gorchymyn hwn yn diwygio Rhannau I a II o Atodlen 1 i Orchymyn 1992 o ran prentisiad a myfyrwyr. Mae Erthygl 4 yn diwygio Rhan I o Atodlen 2 i'r Gorchymyn hwnnw o ran sefydliadau ar gyfer myfyrwyr.

Article 3 of this Order amends Parts I and II of Schedule 1 to the 1992 Order in respect of apprentices and students. Article 4 amends Part I of Schedule 2 to that Order in respect of establishments for students.

The National Assembly for Wales, in exercise of the powers conferred upon the Secretary of State under paragraphs 4 and 5 of Schedule 1 to the Local Government Finance Act 1992(1) and now vested in the National Assembly for Wales(2), makes the following Order:

**Title, commencement, application and interpretation**

1.-(1) The title of this Order is the Council Tax (Discount Disregards) (Amendment) (Wales) Order 2007, and it comes into force on 1 April 2007.

(2) This Order applies in relation to Wales.

(3) In this Order "the 1992 Order" ("Gorchymyn 1992") means the Council Tax (Discount Disregards) Order 1992(3).

**Amendment**

2. The 1992 Order is amended in accordance with the following.

(2) The functions of the Secretary of State under these paragraphs were transferred, so far as exercisable in relation to Wales, to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672); see the entry for this Act in Schedule 1 to that Order.

3.-(1) Yn Rhan I (Prentisiaid) o Atodlen 1 (Diffiniad o fyfyrwyr, etc.) i Orchymyn 1992, ym mharagraff 1 diwygier y canlynol-

- (a) Yn is-baragraff (1)(b), yn lle "National Council for Vocational Qualifications" rhodder "National Assembly for Wales or the Qualifications and Curriculum Authority";
- (b) Dileer is-baragraff (1)(c)(i); ac
- (c) Yn is-baragraff (1)(c)(ii), yn lle "no more than £160 per week" rhodder "employed at a salary or in receipt of an allowance or both, which are, in total no more than £195 per week".

(2) Yn Rhan II (Myfyrwyr) o Atodlen 1 i Orchymyn 1992 ym mharagraff 2(a), yn lle "Central Bureau for Educational Visits and Exchanges" rhodder "British Council".

(2) Ym mharagraff 2, o dan y diffiniad o "further education", yn lle "the Education Act 1944" rhodder "section 2 of the Education Act 1996(2)".

3.-(1) In Part I (Apprentices) of Schedule 1 (Definition of students, etc.) to the 1992 Order, in paragraph 1 amend the following-

- (a) In sub-paragraph (1)(b), for the "National Council for Vocational Qualifications" substitute "National Assembly for Wales or the Qualifications and Curriculum Authority";
- (b) Delete sub-paragraph (1)(c)(i); and
- (c) In sub-paragraph (1)(c)(ii), for "no more than £160 per week", substitute "employed at a salary or in receipt of an allowance or both, which are, in total no more than £195 per week".

(2) In Part II (Students) of Schedule 1 to the 1992 Order in paragraph 2(a), for "Central Bureau for Educational Visits and Exchanges" substitute "British Council".

## Schedule 2

4. In Part I (Establishments for students) of Schedule 2 (Prescribed educational establishments) to the 1992 Order-

(1) In paragraph 1, for sub-paragraph (d) substitute "institutions within the higher education sector, as defined in section 91(5) of the Further and Higher Education Act 1992(1)".

(2) In paragraph 2, under the definition of "further education", for "the Education Act 1944" substitute "section 2 of the Education Act 1996(2)".
