EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn pennu'r swm wythnosol y mae awdurdodau lleol i ragdybio, yn niffyg amgylchiadau arbennig, y bydd ar breswylwyr, sydd mewn llety a drefnwyd o dan Ran 3 o Ddeddf Cymorth Gwladol 1948 ("y Ddeddf"), ei angen at eu hanghenion personol. O 7 Ebrill 2008 ymlaen, rhagdybir y bydd ar bob preswlydd o'r fath angen £21.38 yr wythnos.

These Regulations set the weekly sum which local authorities are to assume, in the absence of special circumstances, that residents who are in accommodation arranged under Part 3 of the National Assistance Act 1948 ("the Act"), will need for their personal requirements. From 7 April 2008 all such residents will be assumed to need £21.38 per week.

Yn ail, mae'r Rheoliadau hyn yn gwneud diwygiadau pellach i Reoliadau Cymorth Gwladol (Asesu Adnoddau) 1992 ("y Prif Reoliadau").

Secondly, these Regulations make further amendments to the National Assistance (Assessment of Resources) Regulations 1992 ("the Principal Regulations").

Mae'r Prif Reoliadau'n penderfynu'r ffordd y mae awdurdodau lleol yn asesu gallu person i dalu am y llety a drefnwyd ar ei gyfer o dan y Ddeddf.

The Principal Regulations determine the way that local authorities assess the ability of a person to pay for accommodation arranged for him or her under the Act.

Mae'r diwygiadau yn darparu ar gyfer cynnydd yn y terfyn cyfalaf isaf a chynnydd yn y swm o gredyd cynilion sydd i'w ddiystyru.

The amendments provide for an increase in the lower capital limit and an increase in the amount of savings credit to be disregarded.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 22(4) a (5) o Ddeddf Cymorth Gwladol 1948(1) ac sydd bellach wedi'u breinio ynddynt (2) drwy hyn yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by sections 22(4) and (5) of the National Assistance Act 1948(1) and now vested in them (2) hereby make the following regulations.

Enwi, cychwyn, dehongli a chymhwyso

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cymorth Gwladol (Asesu Adnoddau a Symiau at Anghenion Personol) (Diwygio) (Cymru) 2008.

(2) Daw'r Rheoliadau hyn i rym ar 7 Ebrill 2008.

Title, commencement, interpretation and application

1.—(1) The title of these Regulations is The National Assistance (Assessment of Resources and Sums for Personal Requirements) (Amendment) (Wales) Regulations 2008.

(2) These Regulations come into force on 7 April 2008.

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adran 22(4) a (5) o Ddeddf Cymorth Gwladol 1948 i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac fe'u trosglwyddwyd i Weinidogion Cymru gan baragraff 30 o Atodlen 11 o Ddeddf Llywodraeth Cymru 2006.

(1) 1948 c.29. See sections 35(1) and 64(1) of the National Assistance Act 1948 for the definitions of "the minister" and "prescribed" respectively and article 2 of the Secretary of State for Social Services Order 1968 (S.I. 1968/1699) which transferred all functions of the Minister of Health to the Secretary of State.

(2) The functions of the Secretary of State under sections 22(4) and (5) of the National Assistance Act 1948 were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) and transferred to the Welsh Ministers by paragraph 30 of Schedule 11 of the Government of Wales Act 2006.

(3) Yn y Rheoliadau hyn, ystyr "y Prif Reoliadau" ("*the Principal Regulations*") yw Rheoliadau Cymorth Gwladol (Asesu Adnoddau) 1992(1).

(4) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

Symiau y mae eu hangen at anghenion personol

2. Y swm y mae awdurdod lleol yn rhagdybio y bydd ei angen ar berson at ei anghenion personol o dan adran 22(4) o Ddeddf Cymorth Gwladol 1948(2) yw £21.38 yr wythnos.

Dirymu

3. Mae rheoliadau 2, 3, 4, 5 a 6(2) o Reoliadau Cymorth Gwladol (Asesu Adnoddau a Symiau at Anghenion Personol) (Diwygio) (Cymru) 2007(3) drwy hyn wedi'u dirymu.

Diwygio rheoliad 28A o'r Prif Reoliadau

4. Ym mharagraff (2) o reoliad 28A o'r Prif Reoliadau (cyfrifo incwm tariff o gyfalaf - Cymru) yn lle'r ffigur " £17,250" rhodder y ffigur "£19,000" yn y ddau le y mae'n ymddangos.

Diwygio Atodlen 3 i'r Prif Reoliadau

5. Ym mharagraff 28H—

- (a) yn is-baragraffau (1) a (2) yn lle'r ffigur "£5.25" rhodder y ffigur "£5.45" ym mhob lle y mae'n ymddangos; a
- (b) yn is-baragraffau (3) a (4) yn lle'r ffigur "£7.85" rhodder y ffigur "£8.15" ym mhob lle y mae'n ymddangos.

(3) In these Regulations, "the Principal Regulations" ("*y Prif Reoliadau*") means the National Assistance (Assessment of Resources) Regulations 1992(1).

(4) These Regulations apply in relation to Wales.

Sums needed for personal requirements

2. The sum which a local authority assumes a person to need for his or her personal requirements under section 22(4) of the National Assistance Act 1948(2) is £21.38 per week.

Revocation

3. Regulations 2, 3, 4, 5 and 6(2) of the National Assistance (Assessment of Resources and Sums for Personal Requirements) (Amendment) (Wales) Regulations 2007(3) are hereby revoked.

Amendment of regulation 28A of the Principal Regulations

4. In paragraph (2) of regulation 28A of the Principal Regulations (Calculation of tariff income from capital - Wales) replace the figure "£17,250" with the figure "£19,000" in both places where it appears.

Amendment of Schedule 3 to the Principal Regulations

5. In paragraph 28H—

- (a) in sub-paragraphs (1) and (2) replace the figure "£5.25" with the figure "£5.45" at each place where it appears; and
- (b) in sub-paragraphs (3) and (4) replace the figure of "£7.85" with the figure "£8.15" in each place where it appears.
