Mae rheoliadau 2(2), 2(4), 2(5), 2(10) a 2(11) yn dileu cyfeiriadau at fyfyrwyr addysg bellach yn rheoliadau 2(1) a 3(a) o'r Prif Reoliadau ac yn dirymu rheoliadau 3(b), 7(2)(d), 8, 9 a 10 o'r Rheoliadau hynny. Effaith hyn yw y bydd y Prif Reoliadau yn peidio â gwneud darpariaeth arbennig yngylch yr ardaloedd y dylid trin myfyrwyr addysg bellach fel bod yn perthyn iddynt. Mae Rheoliad 2(11) hefyd yn dirymu rheoliad 11 o'r Prif Reoliadau sy'n gwneud darpariaeth i beri fod Rheoliadau Addysg (Ardaloedd y Perthyn Disgyblion a Myfyrwyr iddynt) 1989(2) yn parhau i fod yn gymwys i daliadau penodedig, gan nad oes ei hangen bellach.

Mae rheoliad 2(3) yn diwygio rheoliad 2 o'r Prif Reoliadau i ddarparu nad yw'r Rheoliadau hynny'n gymwys at ddibenion pennu'r awdurdod addysg sy'n gyfrifol am ddynodi, asesu, am wneud a chynnwl a chadw datganiadau ac am gyflawni swyddogaethau eraill o dan Ran 4 o Ddeddf Addysg 1996 sy'n ymwneud â phlant ag anghenion addysgol arbennig.

EDUCATION, WALES

The Education (Areas to which Pupils and Students Belong) (Amendment) (Wales) Regulations 2009

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Education (Areas to which Pupils and Students Belong) (Amendment) (Wales) Regulations 2009 amend the Education (Areas to which Pupils and Students Belong) Regulations 1996(1) ("the Principal Regulations").

Regulations 2(2), 2(4), 2(5), 2(10) and 2(11) remove references to further education students in regulations 2(1) and 3(a) of the Principal Regulations and revoke regulations 3(b), 7(2)(d), 8, 9 and 10 of those Regulations. The effect of this is that the Principal Regulations will cease to make special provision about the areas to which further education students are to be treated as belonging. Regulation 2(11) also revokes regulation 11 of the Principal Regulations, which makes provision for the Education (Areas to which Pupils and Students Belong) Regulations 1989(2) to continue to apply for specified payments, as it is no longer needed.

Regulation 2(3) amends regulation 2 of the Principal Regulations to provide that those Regulations do not apply for the purpose of determining the education authority responsible for identifying, assessing, making and maintaining statements and performance of other functions under Part 4 of the Education Act 1996 relating to children with special educational needs.

Mae Rheoliadau 2(6) i (8) yn diwygio amryw o reoliadau yn y Prif Reoliadau drwy osod yn lle cyfeiriadau at ddeddfwriaeth nad yw mwyach yn bod gyfeiriadau at ddeddfwriaeth gyfredol.

Mae Rheoliad 2(9) yn diwygio rheoliad 7 o'r Prif Reoliadau i'w gwneud yn glir fod y rheoliad yn gymwys gan gau allan reoliadau eraill yn y Prif Reoliadau yn unig.

Regulations 2(6) to (8) amends various regulations in the Principal Regulations by substituting references to current legislation for references to legislation that is no longer in existence.

Regulation 2(9) amends regulation 7 of the Principal Regulations to make clear that the regulation applies to the exclusion of other regulations in the Principal Regulations only.

The Welsh Ministers, in exercise of the powers conferred on the National Assembly for Wales by sections 569(4) and 579(4) of the Education Act 1996(1) and now vested in them(2) make the following Regulations.

Title, commencement and application

1.—(1) The title of these Regulations is the Education (Areas to which Pupils and Students Belong) (Amendment) (Wales) Regulations 2009 and they come into force on 24 June 2009.

(2) These Regulations apply in relation to Wales.

**Amendment of the Education (Areas to which
Pupils and Students Belong) Regulations 1996(3)**

2.—(1) The Education (Areas to which Pupils and Students Belong) Regulations 1996 are amended as follows.

(2) In regulation 2(1), omit—

"further education student" means a person in respect of whom provision for further education is made;".

(3) In regulation 2, after paragraph (3), insert—

"(4) These Regulations do not apply for the purposes of determining which authority's area a child is in for the purposes of section 321(3)(1) of the Education Act 1996."

(4) In regulation 3(a), omit—

"other than a further education student" and "and".

(5) Paragraph (b) of regulation 3 is omitted.

(6) In each of regulations 4(2)(a), 5(2)(a) and 7(2)(a), for "Part III of the Education Act 1993", substitute "Part 4 of the Education Act 1996".

(7) In regulation 4(2)(b), for "section 50(1) of the Education Act 1944", substitute "section 514(1)(2) of the Education Act 1996".

(8) In each of regulations 6(2)(b) and 7(2)(c), for "section 298(1) of the Education Act 1993", substitute "section 19(1)(3) of the Education Act 1996".

(9) In regulation 7(1), after the words "other regulation", add "in these Regulations".

(10) In regulation 7(2)—

- (a) omit "or" at the end of sub-paragraph (c), and
- (b) omit sub-paragraph (d).

(11) Regulations 8, 9, 10 and 11 are omitted.
