Mae'r Rheoliadau hyn yn darparu ar gyfer gweithredu Cyfarwyddeb y Comisiwn 2009/8/EC sy'n diwygio Atodiad I i Gyfarwyddeb 2002/32/EC Senedd Ewrop a'r Cyngor ynghylch y lefelau uchaf ar gyfer trosglwyddo'n anochel gocsidiostatau neu histomonostatau mewn bwyd anifeiliaid ar gyfer rhywogaethau nad ydynt yn darged (OJ Rhif L40, 11.2.2009, t.19).
