Un o'r gofynion ynghylch y telerau y penodir person i swydd, neu fod person yn dal swydd, yn unol ag adran 9 o Ddeddf Llywodraeth Leol a Thai 1989 (cynorthwywyr i grwpiau gwleidyddol) yw bod cyfradd y tâl blyneddol ar gyfer y swydd yn llai na £13,500 neu'n swm uwch yn ôl yr hyn a bennir drwy Orchymyn a wneir gan Weinidogion Cymru.

One of the requirements relating to the terms on which a person is appointed to, or holds, an appointment in pursuance of section 9 of the Local Government and Housing Act 1989 (assistants for political groups) is that the annual rate of remuneration for the post is less than £13,500 or such higher amount as may be specified by Order made by the Welsh Ministers.

Mae'r Gorchymyn hwn, sy'n gymwys i awdurdodau lleol yng Nghymru yn darparu mai'r gyfradd dâl flynyddol fydd y mwyafswm a bennir o bryd i'w gilydd gan y Cyd-gyngor Cenedlaethol ar gyfer Gwasanaethau Llywodraeth Leol fel yr un sy'n gymwys i bwynt 44 ar y golofn gyflog ar eu graddfeydd cyflog ar gyfer swyddogion llywodraeth leol.

This Order, which applies to local authorities in Wales provides for the annual rate of remuneration to be the maximum amount that is from time to time fixed by the National Joint Council for Local Government Services as that applicable to spinal column point 44 on their salary scales for local government officers.

O ran awdurdodau lleol yng Nghymru, dirymir Gorchymyn Llywodraeth Leol (Cynorthwywyr i Grwpiau Gwleidyddol) (Tâl) 1995.

As respects local authorities in Wales, the Local Government (Assistants for Political Groups) (Remuneration) Order 1995 is revoked.

ystyr "Cynllun y Cyd-gyngor Cenedlaethol" ("*the National Joint Council's Scheme*") yw Cynllun Amodau Gwasanaeth y Cyd-gyngor Cenedlaethol; ac

ystyr "y Ddeddf" ("*the Act*") yw Deddf Llywodraeth Leol a Thai 1989;

The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by section 9(4), 9(4A) of the Local Government and Housing Act 1989(1) and now vested in them(2), make the following Order:

**Title, commencement and application**

1.—(1) The title of this Order is the Local Government (Assistants for Political Groups) (Remuneration) (Wales) Order 2009 and it comes into force on 1 April 2009.

(2) This Order applies in relation to Wales.

**Interpretation**

2. In this Order—

"the Act" ("*y Ddeddf*") means the Local Government and Housing Act 1989;

"the National Joint Council" ("*y Cyd-gyngor Cenedlaethol*") means the National Joint Council for Local Government Services; and

"the National Joint Council's Scheme" ("*Cynllun y Cyd-gyngor Cenedlaethol*") means the National Joint Council's Scheme of Conditions of Service.

3.—(1) Y pwynt a bennir at ddibenion adran 9(4)(a) o'r Ddeddf yw pwynt 44 ar y golofn gyflog ar y graddfeydd cyflog ar gyfer swyddogion awdurdod lleol a ymgorfforir yng Nghynllun y Cyd-gyngor Cenedlaethol.

(2) Y swm sy'n cyfateb i'r pwynt a bennir ym mharagraff (1) yw'r swm hwnnw a gyhoeddir gan y Cyd-gyngor Cenedlaethol o bryd i'w gilydd o ran swyddi llawnamser o dan awdurdod lleol yng Nghymru a Lloegr.

### **Dirymu**

4. I'r graddau y mae'n gymwys i awdurdodau perthnasol yng Nghymru, dirymir Gorchymyn Llywodraeth Leol (Cynorthwywyr i Grwpiau Gwleidyddol) (Tâl)1995(1).

3.—(1) The point specified for the purposes of section 9(4)(a) of the Act is spinal column point 44 of the salary scales for local government officers incorporated in the National Joint Council's Scheme.

(2) The amount which corresponds to the point specified in paragraph (1) is such amount as is published by the National Joint Council from time to time with respect to full-time posts under a local authority in England and Wales.

### **Revocation**

4. In so far as it applies to relevant authorities in Wales, the Local Government (Assistants for Political Groups) (Remuneration) Order 1995(1) is revoked.
