Mae'r Gorchymyn hwn yn diwygio Gorchymynion penodedig er mwyn dileu cyfeiriadau at "Rheolwr Milfeddygol Rhanbarthol" a disodli'r cyfeiriadau hynny â chyfeiriadau at "Gweinidogion Cymru" ac, fel y bo'n briodol, yn dileu cyfeiriadau at "Divisional Veterinary Manager" a disodli'r cyfeiriadau hynny â chyfeiriadau at "Welsh Ministers". Mae'r Gorchymyn hefyd yn dirymu diffiniadau o "Rheolwr Milfeddygol Rhanbarthol" a "Divisional Veterinary Manager" ym mhob Gorchymyn yr effeithir arno.

This Order amends specified Orders to remove references to "Divisional Veterinary Manager" and replace those references with "Welsh Ministers". The Order also revokes definitions of "Divisional Veterinary Manager" in all affected Orders.

The Welsh Ministers, in exercise of the powers conferred by sections 1, 15(4) and 83(2) of the Animal Health Act 1981(1), make the following Order:

1. Enw'r Gorchymyn hwn yw Gorchymyn Iechyd Anifeiliaid (Rheolwyr Milfeddygol Rhanbarthol) (Cymru) 2010; mae'n gymwys o ran Cymru a daw i rym ar 1 Ebrill 2010.

**Title and commencement**

1. The title of this Order is The Animal Health (Divisional Veterinary Managers) (Wales) Order 2010; it applies in relation to Wales and comes into force on 1 April 2010.

2.–(1) Yn y Gorchymynion a bennir yng nghlofn gyntaf Atodlen 1, yn lle'r term "Rheolwr Milfeddygol Rhanbarthol", ym mhob man lle y mae'n ymddangos yn y darpariaethau a bennir yn y drydedd golofn, rhodder "Gweinidogion Cymru" ac, fel y bo'n briodol, yn lle'r term "Divisional Veterinary Manager", ym mhob man lle y mae'n ymddangos yn y darpariaethau a bennir yn y drydedd golofn, rhodder "Welsh Ministers".

2.–(1) In the Orders specified in the first column of Schedule 1, for "Divisional Veterinary Manager", in each place where it occurs in the provisions specified in the third column, substitute "Welsh Ministers".
