Title and interpretation

1. The title of this Order is the Education Act 2002 (Commencement No. 13) (Wales) Order 2010.

2. In this Order, the "2002 Act" ("*Deddf 2002*") means the Education Act 2002.

Appointed day

3. The following provisions of the 2002 Act come into force on 12 April 2010:

- (a) section 19(8) (governing bodies of maintained schools);
- (b) section 20(4) (instruments of government of governing bodies of maintained schools);
- (c) section 24 (federation of schools); and
- (d) section 25 (federations: supplementary provisions).
