EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn rhagnodi'r ffioedd sy'n daladwy gan geiswyr ar gyfer cofrestru a rheolwyr cofrestredig, o dan Ran II o Ddeddf Safonau Gofal 2000 ("y Ddeddf").

These Regulations prescribe the fees that are payable by applicants for registration and registered managers, under Part II of the Care Standards Act 2000 ("the Act").

Mae'r ffioedd yn daladwy—

The fees are payable—

(1) ar gyfer cais am gofrestru (rheoliad 3);

(1) on an application for registration (regulation 3);

(2) ar gyfer cais am amrywio unrhyw amod sydd mewn grym mewn perthynas â chofrestriad (rheoliad 4);

(2) on an application for the variation of any condition in force in relation to a registration (regulation 4);

(3) ar gyfer cais am ddileu unrhyw amod sydd mewn grym mewn perthynas â chofrestriad (rheoliad 5).

(3) on an application for the removal of any condition in force in relation to a registration (regulation 5).

Yn ychwanegol, mae rheoliad 6 yn pennu'r swm sy'n daladwy fel ffi flynyddol sydd i'w thalu mewn cysylltiad â sefydliadau ac asiantaethau o dan adran 16(3) o'r Ddeddf.

In addition, regulation 6 determines the amount payable as an annual fee in respect of establishments and agencies under section 16(3) of the Act.

Mae darpariaethau ar gyfer ad-dalu a chanlyniadau peidio â thalu (rheoliadau 8 a 9).

There are provisions for the refund of fees paid and consequences for non-payment (regulations 8 and 9).

Mae elusennau'n esempt rhag talu ffioedd (rheoliad 10(1)), onibai eu bod yn codi tâl am wasanaethau.

Charities are exempt from the payment of fees (regulation 10(1)), unless they charge for services.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd iddynt gan adrannau 8(4), 12(2), 14(1)(d), 15(3), 16(3), 16(4) a 118(5) i (7) o Ddeddf Safonau Gofal 2000(1), drwy hyn yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred upon them by sections 8(4), 12(2), 14(1)(d), 15(3), 16(3), 16(4) and 118(5) to (7) of the Care Standards Act 2000(1) hereby make the following regulations.

1.–(1) Enw'r Rheoliadau hyn yw Rheoliadau Gofal Iechyd Annibynnol (Ffioedd) (Cymru) 2011.

(2) Daw'r Rheoliadau hyn i rym ar 1 Ebrill 2011.

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

Title, commencement and application

1.–(1) The title of these Regulations is The Independent Health Care (Fees) (Wales) Regulations 2011.

(2) These Regulations come into force on 1 April 2011.

(3) These Regulations apply in relation to Wales.

Dehongli

2.–(1) Yn y Rheoliadau hyn—

mae i'r ymadrodd "asiantaeth feddygol annibynnol" yr un ystyr ag "*independent medical agency*" yn adran 2(5) y Ddeddf;

ystyr "awdurdod cofrestru" ("*registration authority*") yw Gweinidogion Cymru;

ystyr "awdurdod perthnasol" ("*relevant authority*") yw unrhyw Fwrdd Iechyd Lleol a sefydlwyd o dan adran 11 o Ddeddf y Gwasanaeth Iechyd Gwladol

Interpretation

2.–(1) In these Regulations—

"the Act" ("*y Ddeddf*") means the Care Standards Act 2000;

"acute hospital" ("*ysbyty aciwt*") means an independent hospital of the type referred to in section 2(3)(a)(ii) of the Act, not being a hospice or mental health hospital, whether or not it has approved places, in which at least one listed service may be provided and which provides treatment under general anaesthetic or intravenous sedation;

(Cymru) 2006, unrhyw ymddiriedolaeth GIG a sefydlwyd o dan adran 18 o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006(1), ac unrhyw gyngor sir neu gyngor bwrdeistref sirol;

ystyr "ceisydd" ("*applicant*") yw person sy'n ceisio cael ei gofrestru o dan Ddeddf Safonau Gofal 2000;

mae i'r ymadrodd "clinig annibynnol" yr un ystyr ag "*independent clinic*" yn a.2(4) o'r Ddeddf;

ystyr "cofrestredig", "ei gofrestru" ac "ei chofrestru" ("*registered*") yw cofrestredig o dan Ran 2 o'r Ddeddf;

ystyr "cofrestriad" a "cofrestru" ("*registration*") yw cofrestriad neu gofrestru o dan Ran 2 o'r Ddeddf;

mae i "cynnyrch laser Dosbarth 3B neu Ddosbarth 4", ("*Class 3B or Class 4 laser product*"), yr ystyr a roddir i'r diffiniad o "Class 3B or Class 4 laser product" yn Rhan 1 Safon Brydeinig EN 60825 – 1 (Diogelwch ymbelydredd cynhyrchion a systemau laser)(2);

ystyr "chwarter o'r flwyddyn" ("*quarter of the year*") yw cyfnod o dri mis calendr yn olynol;

ystyr "defnyddiwr gwasanaeth" ("*service user*") yw unrhyw berson y darperir llety neu wasanaethau iddo mewn sefydliad ond nid yw'n cynnwys personau cofrestredig na phersonau cyflogedig na phersonau y bwriedir iddynt fod yn gyflogedig mewn sefydliad;

mae "dialysis" ("*dialysis*") yn cynnwys haemodialysis a dialysis peritoneol;

ystyr "dyddiad priodol" ("*due date*") yw naill ai pen blwydd y cofrestriad a ganiatawyd gyntaf i'r darparydd cofrestredig, neu pan fo'r cofrestriad yn gofrestriad newydd, sy'n daladwy o fewn mis ar ôl caniatáu'r cofrestriad ac wedi hynny ar ben blwydd y cofrestriad;

ystyr "y Ddeddf" ("*the Act*") yw Deddf Safonau Gofal 2000;

ystyr "enwaedu gwryw" ("*male circumcision*") yw enwaedu plant gwryw gan broffesiynolyn gofal iechyd, gan gynnwys at ddibenion cadw defodau crefyddol;

ystyr "ffi amrywiad mawr" ("*major variation fee*") yw'r ffi sy'n daladwy mewn cysylltiad â chais i amrywio amod cofrestru pan fo'n angenrheidiol i'r awdurdod cofrestru arolygu;

ystyr "ffi flynyddol" ("*annual fee*") yw swm a ragnodir at ddibenion adran 16(3) o'r Ddeddf;

ystyr "ffi mân amrywiad" ("*minor variation fee*")

"annual fee" ("*ffi flynyddol*") means an amount prescribed for the purposes of section 16(3) of the Act;

"applicant" ("*ceisydd*") means a person seeking to be registered under the Care Standards Act 2000;

"approved places" ("*lleoedd a gymeradwywyd*") means a bed which is available, in accordance with any condition placed upon the registration of any person in respect of the establishment, for the use of a service user at night;

"Class 3B or Class 4 laser product", ("*Cynnyrch laser Dosbarth 3B neu Ddosbarth 4*") has the meaning given in Part 1 of British Standard EN 60825 – 1 (Radiation safety of laser products and systems)(1);

"dental treatment" ("*triniaeth ddeintyddol*") means any dental treatment provided by a dentist, being a person registered in the dentists register under the Dentists Act 1984(2);

"dialysis" ("*dialysis*") includes haemodialysis and peritoneal dialysis;

"due date" ("*dyddiad priodol*") means the anniversary of the date of first registration, or in the first year of registration, a date one month after the date of first registration;

"establishment" ("*sefydliad*") means an independent hospital or independent clinic;

"hospice" ("*hospis*") means an independent hospital the whole or main purpose of which is to provide palliative care;

"hospital providing treatment under local anaesthesia" ("*ysbyty sydd yn darparu triniaeth gan ddefnyddio anaesthesia lleol*") means a hospital by virtue of s.2(3)(a)(ii) of the Act not being an acute hospital and not being an establishment which is excepted from being an independent hospital by virtue of regulation 3(3) of the Independent Health Care (Wales) Regulations 2011 in which medical treatment is provided under local anaesthesia;

"hyperbaric therapy" ("*therapi hyperbarig*") means the administration of oxygen (whether or not combined with one or more other gases) to a service user who is in a sealed chamber which is gradually pressurised with compressed air, where such therapy is carried out by or under the direct supervision or direction of a medical practitioner;

"*in vitro* fertilisation" ("*ffrwythloni in vitro*") means treatment services for which a licence may be granted under paragraph 1 of Schedule 2 to the

yw'r ffi sy'n daladwy mewn cysylltiad â chais i amrywio amod cofrestru pan na fo'n angenrheidiol i'r awdurdod cofrestru ymweld er mwyn arolygu;

ystyr "ffrwythloni *in vitro*" ("*in vitro fertilisation*") yw gwasanaethau triniaeth y caniateir rhoi trwydded ar eu cyfer o dan baragraff 1 o Atodlen 2 i Ddeddf Ffrwythloni Dynol ac Embryoleg 1990(1);

ystyr "golau dwys" ("*intense light*") yw golau band eang anghydlynol a gaiff ei hidlo i gynhyrchu ystod benodedig o donfeddi, ac mae'r ymbelydredd hwnnw wedi ei hidlo yn cael ei gyflenwi i'r corff, gyda'r nod o beri niwed thermol, mecanyddol neu gemegol i strwythurau megis ffoliglau gwallt a namau ar y croen tra bydd yn arbed y meinweoedd o'u hamgylch;

ystyr "hosbis" ("*hospice*") yw ysbyty annibynnol y mae ei holl ddiben neu ei brif ddiben yn golygu darparu gofal lliniarol;

ystyr "lleoedd a gymeradwywyd" ("*approved places*") yw gwely sydd ar gael yn unol ag unrhyw amod a roddwyd ar gofrestrriad unrhyw berson mewn cysylltiad â'r sefydliad, at ddefnydd defnyddiwr gwasanaeth yn ystod y nos;

ystyr "sefydliad" ("*establishment*") yw ysbyty annibynnol neu glinig annibynnol;

ystyr "triniaeth ddeintyddol" ("*dental treatment*") yw person sydd wedi ei gofrestru yng nghofrestr y deintyddion o dan Ddeddf Deintyddion 1984(2);

ystyr "therapi hyperbarig" ("*hyperbaric therapy*") yw rhoi ocsigen (p'un a chaiff ei gyfuno ag un neu ragor o nwyon ai peidio) i glaf sydd mwn siambr wedi ei selio sy'n raddol cael ei wasgeddu ag aer cywasgedig, a phan fo'r therapi hwnnw yn cael ei wneud gan ymarferydd meddygol neu o dan ei oruchwyliaeth neu ei gyfarwyddyd uniongyrchol;

ystyr "ysbyty aciwt" ("*acute hospital*") yw ysbyty annibynnol o'r math y cyfeirir ato yn adran 2(3)(a)(ii) o'r Ddeddf, nad sydd yn hosbis nac yn ysbyty iechyd meddwl, boed ganddo leoedd a gymeradwywyd, y mae o leiaf un gwasanaeth rhestredig yn cael ei ddarparu ynddo ac sy'n darparu triniaeth o dan anesthetig cyffredinol neu lonyddiad mewnwythiennol;

mae i "ysbyty annibynnol" ("*independent hospital*") yr un ystyr ag yn a.2(2) ac a.2(3) o'r Ddeddf;

ystyr "ysbyty iechyd meddwl" ("*mental health hospital*") yw ysbyty annibynnol o'r math y cyfeirir ato yn adran 2(3)(a)(i) neu (b) o'r Ddeddf, sydd â lleoedd a gymeradwywyd a'i brif bwrbas yw rhoddi

Human Fertilisation and Embryology Act 1990(1);

"independent clinic" ("*clinic annibynnol*") has the same meaning as in s.2(4) of the Act;

"independent hospital" ("*ysbyty annibynnol*") has the same meaning as in s.2(2) and s.2(3) of the Act;

"independent medical agency" ("*asiantaeth feddygol annibynnol*") means an independent medical agency, as defined in section 2(5) of the Act;

"intense light" ("*golau dwys*") means broadband non-coherent light which is filtered to produce a specified range of wavelengths, such filtered radiation being delivered to the body, with the aim of causing thermal, mechanical or chemical damage to structures such as hair follicles and skin blemishes while sparing surrounding tissues;

"major variation fee" ("*ffi amrwyiad mawr*") means the fee payable in respect of an application to vary a condition of registration where it is necessary for the registration authority to inspect;

"male circumcision" ("*enwaedu gwryw*") means the circumcision of male children by a health care professional, including for the purpose of religious observance;

"maternity hospital" ("*ysbyty mamolaeth*") means an independent hospital, the main purpose of which (whether or not other services are provided) is to provide obstetric services and medical services in connection with childbirth;

"mental health hospital" ("*ysbyty iechyd meddwl*") means an independent hospital of the type referred to in section 2(3)(a)(i) or (b) of the Act, which has approved places and whose main purpose is to provide medical treatment for mental illness or mental disorder;

"minor variation fee" ("*ffi mân amrwyiad*") means the fee payable in respect of an application to vary a condition of registration where it is not necessary for the registration authority to inspect;

"non-acute hospital" ("*ysbyty nad yw'n aciwt*") means an independent hospital of the type mentioned in section 2(3)(a)(i) of the Act, with approved places, providing medical treatment for illness but which is not a hospice or mental health hospital and does not provide any listed service;

"quarter of the year" ("*chwarter o'r flwyddyn*") means a period of three consecutive calendar months;

"registered" ("*cofrestredig*", "*ei gofrerstru*" ac "*ei chofrestru*") means registered under Part 2 of the Act;

ystyr "ysbyty mamolaeth" ("*maternity hospital*") yw ysbyty annibynnol, a'i phrif ddiben (p'un a ddarperir gwasanaethau eraill ai peidio) yw darparu gwasanaethau obstetrig a gwasanaethau meddygol mewn cysylltiad â geni plant;

ystyr "ysbyty nad yw'n aciwt" ("*non-acute hospital*") yw ysbyty o'r math a grybwyllir yn adran 2(3)(a)(i) o'r Ddeddf, sydd gan leoedd a gymeradwywyd, sy'n darparu triniaeth feddygol ar gyfer salwch ond nad yw'n hosbis nac yn ysbyty iechyd meddwl ac nad yw'n darparu unrhyw wasanaeth rhestredig;

ystyr "ysbyty terfynu beichiogrwydd" ("*termination of pregnancy hospital*") yw ysbyty annibynnol a'i brif ddiben (p'un a ddarperir gwasanaethau eraill ai peidio) yw darparu gwasanaeth sy'n terfynu beichiogrwydd;

ystyr "ysbyty yn darparu triniaeth gan ddefnyddio anaesthesia lleol" ("*hospital providing treatment under local anaesthesia*") yw ysbyty yn rhinwedd a.2(3)(a)(ii) y Ddeddf nad sydd yn ysbyty aciwt ac nad sydd yn sefydliad sydd wedi ei eithrio o fod yn ysbyty annibynnol oherwydd rheoliad 3(3) o Reoliadau Gofal Iechyd Annibynnol (Cymru) 2011, ac sydd yn darparu triniaeth feddygol gan ddefnyddio anaesthesia lleol.

"registration authority" ("*awdurdod cofrestru*") means the Welsh Ministers;

"registration" ("*cofrestriad*" a "*cofrestru*") means registration under Part 2 of the Act;

"relevant authority" ("*awdurdod perthnasol*") means any Local Health Board established under section 11 of the National Health Service (Wales) Act 2006, any NHS trust established under section 18 of the National Health Service (Wales) Act 2006(1), and any county council or county borough council;

"service user" ("*defnyddiwr gwasanaeth*") means any person who is to be provided with accommodation or services in an establishment but excludes registered persons or persons employed or intended to be employed in an establishment;

"termination of pregnancy hospital" ("*ysbyty terfynu beichiogrwydd*") means an independent hospital whose main purpose (whether or not other services are provided) is to provide termination of pregnancy.

Refund of annual fees

8.–(1) Where the registered provider applies to cancel its registration under section 15(1)(b) of the Act, within six months of the due date and the registration authority agrees to grant that application, then a refund of up to 50% of the annual fee will be paid to the registered provider.

11.–(1) Mae Rheoliadau Deddf Safonau Gofal 2000 a Deddf Plant 1989 (Dileu Ffioedd) (Cymru) 2006(2) yn cael eu diwygio yn unol â darpariaethau canlynol y rheoliadau hwn.

(2) Yn lle rheoliad 1(4) rhodder–

"(4) Nid yw'r Rheoliadau hyn yn gymwys i bersonau sy'n darparu gwasanaethau deintyddol, nac i'r personau hynny sy'n gorfod cofrestru mewn perthynas â gweithredu neu reoli y sefydliad neu asiantaethau hynny a ddisgrifir yn adran 2 Ddeddf Safonau Gofal 2000."

(2) The amount of the refund to which a registered provider is entitled is a quarter of the annual fee paid for each complete quarter which remains of the 12 month period for which it is due as at the date the registration authority receives the application to cancel and subject to a maximum refund of 50%.

(3) In calculating how many complete quarters of the year remain, no account is to be taken of the calendar month in which the application to cancel is received.

Non-payment of fee

9. If the annual fee is not paid by the registered provider by the due date, then the registration authority may cancel the registered provider's registration, and recover the fee as a civil debt.

Exemption from payment of fee

10.–(1) Where the provider of any establishment or agency listed above is a charity registered with the Charity Commission, under section 3A of the Charities Act 1993(1), then provided that the only services that charity provides are free, and that the services are not commissioned by a relevant authority, the charity is exempt from payment of a fee under these regulations.

(2) No application fee is payable where a person applies to register as a manager of an establishment or agency and the person is already registered as a manager in respect of a different establishment or agency or was so registered no more than 7 days before the date the application was submitted.

Amendment to the Care Standards Act 2000 and the Children Act 1989 (Abolition of Fees) (Wales) Regulations 2006

11.–(1) The Care Standards Act 2000 and the Children Act 1989 (Abolition of Fees) (Wales) Regulations 2006(2) are amended in accordance with the following provisions of this regulation.

(2) For regulation 1(4) replace with–

"(4) These regulations do not apply to persons who provide dental services, nor to those persons having to register in relation to carrying on or managing those establishment or agencies described in section 2 of the Care Standards Act 2000."
