**The A5 Trunk Road (Maerdy,
Conwy County Borough)
(Temporary Traffic Restrictions &
Prohibition) Order 2011**

Made *3 June 2011*

Coming into force *13 June 2011*

The Welsh Ministers, being the traffic authority for the relevant length of the London – Holyhead Trunk Road (A5) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 13 June 2011 and its title is The A5 Trunk Road (Maerdy, Conwy County Borough) (Temporary Traffic Restrictions & Prohibition) Order 2011.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means that length of the A5 trunk road at Maerdy in the County Borough of Conwy that extends in a westerly direction from a point 100 metres east of the Pont Maerdy river bridge to the centre-point of its junction with the road known as Carreg y Big which leads to Dol-y-Pennau;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 09:00 hours on 13 June 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road.

6. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

7. The maximum duration of this Order shall be 6 months.
