Mae'r Rheoliadau hyn yn diwygio Rheoliadau Timau Integredig Cymorth i Deuluoedd (Swyddogaethau Cymorth i Deuluoedd) (Cymru) 2010 drwy dynnu cyfeiriad at adran 82 o Ddeddf y Gwasanaeth Iechyd Gwladol 2006 yn y rhestr o swyddogaethau awdurdodau lleol sy'n gymwys mewn perthynas â phlant (Tabl 1 o Atodlen 1) ac a ragnodir fel "swyddogaethau cymorth i deuluoedd" at ddibenion adran 58 o Fesur Plant a Theuluoedd (Cymru) 2010.

These Regulations amend the Integrated Family Support Teams (Family Support Functions) (Wales) Regulations 2010 by removing reference to section 82 of the National Health Service Act 2006 in the list of local authority functions which apply in relation to children (Table 1 of Schedule 1) and are prescribed as "family support functions" for the purposes of section 58 of the Children and Families (Wales) Measure 2010.

The Welsh Ministers, in exercise of the powers conferred by section 58(2) of the Children and Families (Wales) Measure 2010(1), make the following regulations.

1.–(1) Enw'r Rheoliadau hyn yw Rheoliadau Timau Integredig Cymorth i Deuluoedd (Swyddogaethau Cymorth i Deuluoedd) (Cymru) (Diwygio) 2011 a deuant i rym ar 1 Mawrth 2011.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

2. Yn Nhabl 1 o Atodlen 1 i Reoliadau Timau Integredig Cymorth i Deuluoedd (Swyddogaethau Cymorth i Deuluoedd) (Cymru) (Diwygio) 2010(2) dileer y geiriau –

"a.82 o Ddeddf y Gwasanaeth Iechyd Gwladol 2006 (Cydweithrediad rhwng cyrff GIG ac awdurdodau lleol)".

Citation, commencement and application

1.–(1) The title of these Regulations is the Integrated Family Support Teams (Family Support Functions) (Wales) (Amendment) Regulations 2011 and they come into force on 1 March 2011.

(2) These Regulations apply in relation to Wales.

2. In Table 1 of Schedule 1 to the Integrated Family Support Teams (Family Support Functions) (Wales) Regulations 2010(2) delete the words –

"s.82 National Health Service Act 2006 (Cooperation between NHS bodies and local authorities)".
