The Welsh Ministers, in exercise of the powers conferred upon them by section 8(1) of the Local Government (Wales) Measure 2009<sup>(1)</sup>, and having consulted those persons they are required, by section 8(3) of that Measure, to consult, hereby make the following Order.

**Title, commencement, and application**

1.—(1) The title of this Order is The Fire and Rescue Authorities (Performance Indicators) (Wales) Order 2011.

(2) This Order applies to fire and rescue authorities in Wales and comes into force on 1 April 2011.

**Performance indicators**

2. The performance indicators by reference to which the performance of each fire and rescue authority in Wales will be measured in exercising their functions are hereby specified in the Schedule.
