1. Mae'r Rheoliadau hyn yn dirymu Rheoliadau Bwyd (Jeli Cwpanau Bach) (Rheolaeth Frys) (Cymru) 2009 (O.S. 2009/3379) (Cy.301)) ("y prif Reoliadau") ynghyd â Rheoliadau Bwyd (Jeli Cwpanau Bach) (Rheolaeth Frys) (Cymru) (Diwygio) 2010 (O.S. 2010/1376 (Cy.121)).

1. These Regulations revoke the Food (Jelly Mini-Cups) (Emergency Control) (Wales) Regulations 2009 (S.I. 2009/3379) (W.301)) ("the principal Regulations") together with the Food (Jelly Mini-Cups) (Emergency Control) (Wales) (Amendment) Regulations 2010 (S.I. 2010/1376 (W.121)).

2. Roedd y prif Reoliadau yn rhoi ar waith, o ran Cymru, Benderfyniad y Comisiwn 2004/374/EC a oedd yn atal dros dro osod ar y farchnad a mewnforio jeli cwpanau bach sy'n cynnwys yr ychwanegion bwyd E400, E401, E402, E403, E404, E405, E406, E407, E407a, E410, E412, E413, E414, E415, E417 ac/neu E418 (OJ Rhif L118, 23.4.2004, t.70) ("Penderfyniad y Comisiwn 2004/374/EC"). Mae Penderfyniad y Comisiwn 2004/374/EC wedi ei ddiddymu gan Gyfarwyddeb y Comisiwn 2010/69/EU sy'n diwygio'r Atodiadau i Gyfarwyddeb Senedd Ewrop a'r Cyngor 95/2/EC ar ychwanegion bwyd ac eithrio lliwiau a melysuddion (OJ Rhif L279, 23.10.2010, t.22).

2. The principal Regulations implemented in relation to Wales Commission Decision 2004/374/EC suspending the placing on the market and import of jelly mini-cups containing the food additives E400, E401, E402, E403, E404, E405, E406, E407, E407a, E410, E412, E413, E414, E415, E417 and/or E418 (OJ No. L118, 23.4.2004, p.70) ("Commission Decision 2004/374/EC"). Commission Decision 2004/374/EC has been repealed by Commission Directive 2010/69/EU amending the Annexes to European Parliament and Council Directive 95/2/EC on food additives other than colours and sweeteners (OJ No. L279, 23.10.2010, p.22).

The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by section 2(2) of the European Communities Act 1972(1).

The Welsh Ministers have been designated for the purposes of section 2(2) of the European Communities Act 1972 in relation to measures relating to food (including drink)(2).

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Title and commencement

1. The title of these Regulations is the Food (Jelly Mini-Cups) (Emergency Control) (Wales) (Revocation) Regulations 2011 and they come into force on 31 March 2011.
