**The A487 Trunk Road
(Rhydypennau to Pwll-glâs,
Ceredigion) (Temporary Traffic
Restrictions and Prohibition) Order
2012**

Made 25 May 2012

Coming into force 6 June 2012

The Welsh Ministers, being the traffic authority for the relevant length of the Fishguard – Bangor Trunk Road (A487) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 6 June 2012. The title to this Order is The A487 Trunk Road (Rhydypennau to Pwll-glâs, Ceredigion) (Temporary Traffic Restrictions and Prohibition) Order 2012.

2. —1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the A487 trunk road in the County of Ceredigion which extends from a point 460 metres south-west of the centre-point of its junction with the B4353, near Rhydypennau, to a point 1540 metres north-east of the centre-point of its junction with the B4353, at Pwll-glâs.

“works period,” (“*cyfnod y gwaith*”) means that period commencing at 07.30 hours on 6 June 2012 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

6. Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road, during such times as the restriction referred to in article 5 is in operation.

7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restriction and prohibition referred to therein is indicated by traffic signs.

8. The provisions of The A487 Trunk Road (Rhydypennau, Ceredigion) (Restricted Road and 40 MPH Speed Limit) Order 2003(3) are hereby suspended in respect of the length of the trunk road specified in article 2 during such times as the restrictions specified in articles 3, 4 and 5 are in operation.

9. The maximum duration for this Order shall be 6 months.
