EXPLANATORY NOTE

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2000 ("Gorchymyn 2000"), o ganlyniad i Ddeddf Addysg 2011 ("Deddf 2011") sy'n darparu ar gyfer diddymu Cyngor Addysgu Cyffredinol Lloegr ("CACLI") ac yn darparu mewn perthynas â gwahardd personau rhag cyflawni gwaith addysgu.

This Order amends the General Teaching Council for Wales (Additional Functions) Order 2000 ("the 2000 Order"), as a consequence of the Education Act 2011 ("the 2011 Act") which provides for the abolition of the General Teaching Council for England ("the GTCE") and makes provision in relation to the prohibition of persons from carrying out teaching work.

Mae erthygl 2(2) yn diwygio Rhan II o'r Atodlen i Orchymyn 2000 drwy ychwanegu paragraff 22B newydd sy'n darparu y bydd Cyngor Addysgu Cyffredinol Cymru ("y Cyngor") yn cynnwys yn ei gofnodion delerau unrhyw orchymyn gwahardd sydd wedi'i wneud gan yr Ysgrifennydd Gwladol o dan adran 141B o Ddeddf Addysg 2002 ("Deddf 2002") yn gwahardd person rhag cyflawni gwaith addysgu. Mewnosodir adran 141B yn Neddf 2002 gan Ddeddf 2011.

Article 2(2) amends Part II of the Schedule to the 2000 Order by adding a new paragraph 22B which provides that the General Teaching Council for Wales ("the Council") will include in its records the terms of any prohibition order made by the Secretary of State under section 141B of the Education Act 2002 ("the 2002 Act") prohibiting a person from carrying out teaching work. Section 141B is inserted into the 2002 Act by the 2011 Act.

Mae erthygl 2(2) hefyd yn diwygio paragraffau 23A a 23B o Ran II o'r Atodlen er mwyn dileu cyfeiriadau at CACLI.

Article 2(2) also amends paragraphs 23A and 23B of Part II of the Schedule to remove references to the GTCE.

The Welsh Ministers make the following Order in exercise of the powers conferred upon the Secretary of State by sections 7(1) and (4) and 42(6) and (7) of the Teaching and Higher Education Act 1998(1) and now vested in them(2), being of the opinion that the General Teaching Council for Wales may, having regard to their general objectives, appropriately discharge the additional functions conferred in this Order and, in accordance with section 7(2), having carried out such consultation as appears to them to be appropriate:

Title and commencement

1.—(1) The title of this Order is the General Teaching Council for Wales (Additional Functions) (Amendment) Order 2012.

(2) Article 2(2)(b) and (c) of this Order comes into force on the day that section 7 of the Education Act 2011(3) comes into force and article 2(2)(a) comes into force on the day that section 8 of that Act comes into force.

2.—(1) Diwygir Gorchymyn Cyngor Addysgu Cyffredinol Cymru (Swyddogaethau Ychwanegol) 2000(1) fel a ganlyn.

(2) Yn Rhan II o'r Atodlen,

(a) ar ôl paragraff 22A, mewnosoder y canlynol—
"22B

Telerau unrhyw orchymyn gwahardd sydd mewn grym am y tro mewn perthynas â'r person ac sydd wedi'i wneud gan yr Ysgrifennydd Gwladol o dan adran 141B o Ddeddf Addysg 2002."

- (b) ym mharagraff 23A, hepgorer y geiriau "neu gan Gyngor Addysgu Cyffredinol Lloegr".
- (c) ym mharagraff 23B, hepgorer y geiriau "neu gan Gyngor Addysgu Cyffredinol Lloegr".

Amendment of the General Teaching Council for Wales (Additional Functions) Order 2000

2.—(1) The General Teaching Council for Wales (Additional Functions) Order 2000(1) is amended as follows.

(2) In Part II of the Schedule,

(a) after paragraph 22A insert the following—
"22B

The terms of any prohibition order for the time being in force in relation to the person made by the Secretary of State under section 141B of the Education Act 2002."

- (b) in paragraph 23A omit the words "or the General Teaching Council for England".
- (c) in paragraph 23B omit the words "or the General Teaching Council for England".
