The A470 Trunk Road (Navigation Park to Abercynon Roundabout, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2012

Made 3 July 2012

Coming into force 16 July 2012

The Welsh Ministers, as the traffic authority for the Cardiff - Llangurig Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 16 July 2012 and its title is The A470 Trunk Road (Navigation Park to Abercynon Roundabout, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2012.

2.—1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the main northbound carriageway of the trunk road, in the County Borough of Rhondda Cynon Taf, which extends from a point at the start of the physical nosing of the northbound off slip road at Navigation Park to a point at its junction with the circulatory carriageway of Abercynon Roundabout:

"works period" ("cyfnod y gwaith") means that period commencing at 20:00 hours on 16 July 2012 and ending when the temporary traffic signs have been removed:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order.

- (2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- **3.** Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the specified length of the trunk road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as the application of prohibition referred to therein is indicated by traffic signs.
- **5.** The maximum duration for this Order shall be 12 months.
