ROAD TRAFFIC, WALES

The A55 Trunk Road (Junction 23, Llanddulas, Conwy) (Temporary Traffic Prohibitions and Restriction) Order 2012

Made 1 August 2012

Coming into force 9 August 2012

The Welsh Ministers, being the traffic authority for the relevant lengths of the Chester–Bangor Trunk Road (A55) (hereinafter referred to as "the trunk road") are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon:

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers, hereby make the following Order (2):

1. This Order comes into force on 9 August 2012 and its title is the A55 Trunk Road (Junction 23, Llanddulas, Conwy) (Temporary Traffic Prohibitions and Restriction) Order 2012.

2. (1) In this Order:

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means those lengths of the trunk road specified in the Schedules to this Order;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

"works period" ("cyfnod y gwaith") means the period commencing from 19:00 hours on 9 August 2012 and ending when the temporary traffic signs are removed

- (2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.
- 3. Subject to the provisions of article 7, no person shall, during the works period, drive, cause or permit to be driven any vehicle, other than an exempted vehicle, in the lengths of the trunk road specified in Schedule 1.
- 4. Subject to the provisions of article 7, no person shall, during the works period, drive, cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 40 miles per hour in the lengths of the trunk road specified in Schedule 2.
- 5. Subject to the provisions of article 7, no person shall, during the works period, cause or permit to be ridden, any pedal cycle in the length of the trunk road specified in Schedule 1.
- 6. Subject to the provisions of article 7, no pedestrian shall, during the works period, proceed in the length of the trunk road specified in Schedule 3.
- The provisions of articles 3, 4, 5, and 6 shall apply only at such times and to such extent as the application of the prohibitions and restriction referred to therein are indicated by traffic signs.
- 8. The provisions of The Special Road (A55) (Llanddulas to Colwyn Bay) Regulations 1984(3) are hereby suspended, insofar as they relate to the relevant lengths of the trunk road specified in Schedule 2 to this Order during such times as the restriction specified in article 4 is in operation.
- 9. The maximum duration for this Order shall be 6 months.

SCHEDULES

SCHEDULE 1

Prohibition of vehicles and cyclists

- i. The entire length of the westbound on slip road at Junction 23, Llanddulas;
- ii. The entire length of the westbound off slip road at Junction 23, Llanddulas;
- iii. The entire length of the eastbound on slip road at Junction 23, Llanddulas;
- iv. The entire length of the eastbound off slip road at Junction 23, Llanddulas.

SCHEDULE 2

Limits of the 40mph restriction

- i. That length of the eastbound trunk road from a point 2,000 metres west of Junction 23 eastbound splitter island to a point 1,000 metres east of splitter island.
- ii. That length of the westbound trunk road from a point 2,000 metres east of Junction 23 westbound splitter island to a point 1,000 metres west of splitter island.

SCHEDULE 3

Prohibition of pedestrians

The entire length of the westbound off slip road at Junction 23, Llanddulas.
