**EXPLANATORY NOTE**

1. Mae'r Rheoliadau hyn yn diwygio Rheoliadau Hylendid Bwyd (Cymru) 2006 (O.S. 2006/31 (Cy.5), fel y'i diwygiwyd eisoes) er mwyn-

1. These Regulations amend the Food Hygiene (Wales) Regulations 2006 (S.I. 2006/31 (W.5), as already amended) so as to-

- (a) caniatáu i hysbysiad camau cywiro gael ei gyflwyno mewn perthynas â sefydliad nad yw'n ddarostyngedig i gymeradwyaeth o dan ddeddfwriaeth hylendid bwyd Ewropeaidd (rheoliad 2(2)); a
- (b) darparu i ddioglediad fod yn daladwy pan fo'r gweithredydd busnes bwyd yn cael colled drwy gydymffurfio â hysbysiad camau cywiro sydd, ar apêl i'r llys, yn cael ei ganslo wedyn (rheoliad 2(3)).

- (a) permit the service of a remedial action notice in relation to an establishment not subject to approval under European food hygiene legislation (regulation 2(2)); and
- (b) provide for compensation to be payable where a food business operator suffers loss by complying with a remedial action notice which, on appeal to the court, is subsequently cancelled (regulation 2(3)).

2. Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar wneud Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, paratowyd asesiad effaith rheoleiddiol o'r costau a'r buddiannau sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. 2. The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. **The Food Hygiene (Wales)  
(Amendment) Regulations 2012**

*Made* 28 March 2012  
*Laid before the National  
Assembly for Wales* 30 March 2012  
*Coming into force* 1 May 2012

The Welsh Ministers make the following Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972(1).

The Welsh Ministers are designated for the purposes of that section in relation to measures in respect of food (including drink) including the primary production of food(2).

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3) there has been open and transparent public consultation during the preparation of the following Regulations.

**Title and commencement**

1. The title of these Regulations is the Food Hygiene (Wales) (Amendment) Regulations 2012 and they come into force on 1 May 2012.

## Diwygio Rheoliadau Hylendid Bwyd (Cymru) 2006

2.—(1) Mae Rheoliadau Hylendid Bwyd (Cymru) 2006(1) wedi eu diwygio yn unol â'r paragraffau canlynol.

(2) Ym mharagraff (1) o reoliad 9 (hysbysiadau camau cywiro a hysbysiadau cadw), hepgorer y geiriau "sy'n ddarostyngedig i gymeradwyaeth o dan Erthygl 4(2) o Reoliad 853/2004".

(3) Ar ôl paragraff (3) o reoliad 22 (apelau yn erbyn hysbysiadau gwella hylendid a hysbysiadau camau cywiro), ychwaneger y canlynol fel paragraff (4) newydd—

"(4) Pan fo llys, ar apêl yn erbyn hysbysiad camau cywiro o dan baragraff (1), yn canslo'r hysbysiad, rhaid i'r awdurdod gorfodi ddiogledu'r gweithredydd busnes bwyd a ddygodd yr apêl mewn cysylltiad ag unrhyw golled a gafwyd oherwydd bod y gweithredydd busnes bwyd wedi cydymffurfio â'r hysbysiad, a bydd unrhyw gwestiwn dadleuol ynglŷn â'r hawl i gael unrhyw iawndal sy'n daladwy o dan y paragraff hwn neu swm yr iawndal hwnnw yn cael ei benderfynu drwy gymrodeddu."

## Amendment of the Food Hygiene (Wales) Regulations 2006

2.—(1) The Food Hygiene (Wales) Regulations 2006(1) are amended in accordance with the following paragraphs.

(2) In paragraph (1) of regulation 9 (remedial action notices and detention notices) omit the words "subject to approval under Article 4(2) of Regulation 853/2004".

(3) After paragraph (3) of regulation 22 (appeals against hygiene improvement notices and remedial action notices), as new paragraph (4) add the following—

"(4) Where on appeal against a remedial action notice under paragraph (1) a court cancels the notice, the enforcement authority must compensate the food business operator who brought the appeal in respect of any loss suffered by reason of the food business operator's compliance with the notice, and any disputed question as to the right to or the amount of any compensation payable under this paragraph will be determined by arbitration."
