**ROAD TRAFFIC, WALES**

**The A55 Trunk Road (Junction 8  
(Ael-y-Bowl), Isle of Anglesey to  
Junction 9 (Treborth), Gwynedd)  
(Temporary Prohibition of Vehicles)  
Order 2013**

*Made* 25 July 2013

*Coming into force* 4 August 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the London – Holyhead Trunk Road (A55) (hereinafter referred to as the “trunk road”), are satisfied that traffic in specified lengths of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984<sup>(1)</sup> and of all other enabling powers<sup>(2)</sup>, make this Order.

**Title, Interpretation and Commencement**

**1.** This Order shall come into force on 4 August 2013 and its title is The A55 Trunk Road (Junction 8 (Ael-y-Bowl), Isle of Anglesey to Junction 9 (Treborth), Gwynedd) (Temporary Prohibition of Vehicles) Order 2013.

**2.** (1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the lengths of the trunk road” (“*y darnau o’r gefnffordd*”) means those lengths of the trunk road between Junction 8 (Ael-y-Bowl) on the Isle of Anglesey and Junction 9 (Treborth) in the County of Gwynedd specified in the Schedule to this Order;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 00:01 hours on 4 August 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

### **Prohibition**

3. Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to be driven in the lengths of the trunk road specified in the Schedule.

### **Application**

4. The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

### **Duration of this Order**

5. The maximum duration for this Order shall be 6 months.

## **SCHEDULE**

### **Temporary Prohibition of Vehicles**

The length of the eastbound carriageway of the trunk road that extends from the nosing of the eastbound exit slip road at Junction 8 (Ael-y-Bowl) to the nosing of the eastbound entry slip road at Junction 9 (Treborth).

The length of the westbound carriageway of the trunk road that extends from the nosing of the westbound exit slip road at Junction 9 (Treborth) to the nosing of the westbound entry slip road at Junction 8 (Ael-y-Bowl).

The entire length of the eastbound entry slip road at Junction 8 (Ael-y-Bowl).

The entire length of the eastbound entry slip road at Junction 8A (Carreg Bran).

The entire length of the westbound entry slip road at Junction 9 (Treborth).
