**ROAD TRAFFIC, WALES**

**The A494 Trunk Road  
(Gwyddelwern, Denbighshire)  
(Temporary Traffic Restriction &  
Prohibitions) Order 2013**

*Made* 1 February 2013

*Coming into force* 11 February 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau – South of Birkenhead Trunk Road (A494) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

1. This Order comes into force on 11 February 2013 and its title is The A494 Trunk Road (Gwyddelwern, Denbighshire) (Temporary Traffic Restriction & Prohibitions) Order 2013.

2.—(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means that length of the A494 trunk road in the County of Denbighshire which extends in a southerly direction from a point 100 metres north of the permanent 30 mph speed restriction to the north of Gwyddelwern to a point 240 metres north of the property known as Ty’n y Rhos, south of Gwyddelwern;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 07:30 hours on 11 February 2013 and

ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Restrictions and Prohibitions**

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

### **Application**

6. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restriction and prohibitions referred to therein is indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration of this Order shall be 12 months.
