Interpretation

2.— $[^{F1}(1)]$ In these Regulations— $_{F2}$

"Regulation 1379/2013" ("*Rheoliad* > 1379/2013") means Regulation (EU) No 1379/2013 of the European Parliament and of the Council on the common organisation of the markets in fishery and aquaculture products.]
