EXPLANATORY NOTE

(This note is not part of the Order)

This Order establishes a further education corporation called "Coleg Cambria" under section 16(1)(a) of the Further and Higher Education Act 1992 ("the Act") for the purpose of conducting the educational institution of the same name. The Order also provides for the appointment of 1 August 2013 as the operative date for the purposes of Part 1 of the Act, being the date from which Coleg Cambria is to conduct the educational institution of the same name.

A draft and summary of this Order have been published in accordance with section 16A of the Act and the Further Education Corporations (Publication of Draft Orders) (Wales) Regulations 2007.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Coleg Cambria (Corffori) 2013 a daw i rym ar 26 Mawrth 2013.

Diwygiwyd adran 17 o Ddeddf Addysg Bellach ac Uwch 1992 gan baragraff 7 o Atodlen 3 i Ddeddf Addysgu ac Addysg Uwch 1998 (p.30) a chan baragraffau 1 a 2 o Atodlen 8 i Ddeddf Prentisiaethau, Sgiliau, Plant a Dysgu 2009 (p.22).

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan adrannau 16(1)(a) a 17 o Ddeddf Addysg Bellach ac Uwch 1992 i Gymulliad Cenedlaethol Cymru yn rhinwedd ethylg 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac Atodlen 1 iddo. Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru wedi hymny i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p.32).

This Order is made in exercise of the powers conferred on the Secretary of State by sections 16(1)(a) and 17 of the Further and Higher Education Act 1992(1) and now exercisable by the Welsh Ministers(2).

The Welsh Ministers have published a draft and summary of this Order in accordance with section 16A of the Further and Higher Education Act 1992 and the Further Education Corporations (Publication of Draft Orders) (Wales) Regulations 2007(3).

Accordingly, the Welsh Ministers make the following Order:

Title and commencement

1. The title of this Order is the Coleg Cambria (Incorporation) Order 2013 and it comes into force on 26 March 2013.

(1) 1992 c.13; section 16 of the Further and Higher Education Act 1992 was amended by section 140(3) of and Schedule 31 to the Schools Standards and Framework Act 1998 (c.31); by section 111(1) of the Learning and Skills Act 2000 (c.21) and by the Local Education Authorities and Children's Services Authorities (Integration of Functions) Order 2010 (S.I. 2010/1158). Section 17 of the Further and Higher Education Act 1992 was amended by paragraph 7 of Schedule 3 to the Teaching and Higher Education Act 1998 (c.30) and by paragraphs 1 and 2 of Schedule 8 to the Apprenticeships, Skills, Children and Learning Act 2009 (c.22).

(2) The functions of the Secretary of State under sections 16(1)(a) and 17 of the Further and Higher Education Act 1992 were transferred to the National Assembly for Wales by virtue of article 2 of and Schedule 1 to the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672). The functions of the National Assembly for Wales were subsequently transferred to the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32).

Corfforaeth Newydd

2. Ar 26 Mawrth 2013 mae corff corfforaethol o'r enw Coleg Cambria i'w sefydlu, at ddiben sefydlu a rhedeg, o'r dyddiad gweithredu ymlaen, sefydliad addysgol o'r un enw.

Dyddiad gweithredu

3. Y dyddiad gweithredu a bennir mewn perthynas â Choleg Cambria yw 1 Awst 2013, a bydd y gorfforaeth yn rhedeg y sefydliad addysgol Coleg Cambria o'r dyddiad hwnnw ymlaen.

New Corporation

2. On 26 March 2013 a body corporate called Coleg Cambria is to be established, for the purpose of establishing and conducting from the operative date an educational institution of the same name.

Operative date

3. The operative date appointed in relation to Coleg Cambria is 1 August 2013, and the corporation is to conduct the educational institution of Coleg Cambria from that date.
