**EXPLANATORY NOTE**

*(This note is not part of the Order)*

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Iechyd Planhigion (Cymru) 2006 (O.S. 2006/1643 (Cy.158)) ("y prif Orchymyn").

This Order amends the Plant Health (Wales) Order 2006 (S.I. 2006/1643 (W.158)) ("the principal Order").

Mae erthygl 3(1) yn gwneud darpariaeth i wahardd person rhag glanio planhigion *Ulmus* L. yng Nghymru, a fwriedir ar gyfer eu plannu, sydd wedi eu tyfu neu yr amheuir eu bod wedi eu tyfu mewn Aelod-wladwriaeth arall neu yn y Swistir, oni hysbyswyd arolygydd awdurdodedig mewn ysgrifen ymlaen llaw.

Article 3(1) makes provision to prohibit a person from landing in Wales plants of *Ulmus* L. intended for planting, which have been grown or are suspected to have been grown in another member State or in Switzerland, unless prior written notification has been given to an authorised inspector.

Mae erthygl 3(2) yn gwneud darpariaeth i'r hysbysiad mewn ysgrifen sy'n ofynnol o dan erthygl 19(7) o'r prif Orchymyn gynnwys enw'r wlad y mae'r planhigion wedi eu hanfon, neu i'w hanfon, ohoni.

Article 3(2) makes provision for the written notification required under article 19(7) of the principal Order to include the name of the country from which the plants have been, or are to be, consigned.

Mae erthygl 4 yn dileu'r darpariaethau yn y prif Orchymyn ynglŷn â'r organeb *Diabrotica virgifera virgifera* Le Conte er mwyn rhoi'r canlynol ar waith—

Article 4 removes the provisions in the principal Order in relation to the organism *Diabrotica virgifera virgifera* Le Conte so as to implement—

- (a) Cyfarwyddeb Gweithredu'r Comisiwn 2014/19/EU sy'n diwygio Atodiad I i Gyfarwyddeb y Cyngor 2000/29/EC ynghylch mesurau diogelu yn erbyn dod ag organebau i'r Gymuned sy'n niweidiol i blanhigion neu gynhyrchion planhigion ac yn erbyn eu lledaenu yn y Gymuned (OJ Rhif L 38, 7.2.2014, t.30); a
- (b) Penderfyniad Gweithredu'r Comisiwn 2014/62/EU sy'n dirymu Penderfyniad 2003/766/EC ynghylch mesurau brys i atal *Diabrotica virgifera virgifera* Le Conte rhag lledaenu yn y Gymuned (OJ Rhif L 38, 7.2.2014, t.45).

- (a) Commission Implementing Directive 2014/19/EU amending Annex I to Council Directive 2000/29/EC on protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community (OJ No L 38, 7.2.2014, p.30); and
- (b) Commission Implementing Decision 2014/62/EU repealing Decision 2003/766/EC on emergency measures to prevent the spread within the Community of *Diabrotica virgifera virgifera* Le Conte (OJ No L 38, 7.2.2014, p.45).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar wneud Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, barnwyd nad oedd yn angenrheidiol gwneud asesiad effaith rheoleiddiol o'r costau a'r buddion sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The Welsh Ministers, make the following Order in exercise of the powers conferred by sections 2 and 3(1) of the Plant Health Act 1967(1).

**Title, commencement and application**

1.—(1) The title of this Order is the Plant Health (Wales) (Amendment) (No. 2) Order 2014.

(2) This Order comes into force on 31 May 2014.

(3) This Order applies in relation to Wales.

**Amendment of the Plant Health (Wales) Order  
2006**

2. The Plant Health (Wales) Order 2006(2) is amended as follows.

(1) 1967 p. 8. Diwygiwyd adran 1(2) gan Orchymyn Corff Adnoddau Naturiol Cymru (Swyddogaethau) 2013/755 (Cy. 90), Atodlen 2, paragraff 43. Diwygiwyd adrannau 2(1) a 3(1) gan Ddeddf y Cymunedau Ewropeaidd 1972 (p. 68), Atodlen 4, paragraff 8. Rhoddir y pwerau yn adrannau 2 a 3 i "competent authority", a ddiffinnir yn adran 1(2), o ran Cymru, fel Gweinidogion Cymru.  
(2) O.S. 2006/1643 (Cy. 158); offerynnau diwygio perthnasol yw O.S. 2008/2781 (Cy. 248), O.S. 2009/1376 (Cy. 137), O.S. 2013/2939 (Cy. 287) ac O.S. 2014/521 (Cy. 62).

### Erthygl 19 (gwahardd glanio plâu planhigion a deunydd perthnasol)

3.—(1) Yn lle paragraff (6) o erthygl 19(1), rhodder—

“(6) Paragraph (7) applies to—

- (a) plants of *Castanea* Mill., *Fraxinus* L., *Pinus* L., *Platanus* L., *Quercus* L. or *Ulmus* L. intended for planting, which have been grown or are suspected to have been grown in another member State; or
- (b) plants of *Castanea* Mill., *Pinus* L., *Platanus* L., *Quercus* L. or *Ulmus* L. intended for planting, which have been grown or are suspected to have been grown in Switzerland and to which the requirements of article 6 do not apply.”

(2) Yn lle paragraff (8) o erthygl 19(2), rhodder—

“(8) The matters are—

- (a) the intended date of introduction of the plants;
- (b) their intended destination;
- (c) the quantity of the plants;
- (d) their genus and species;
- (e) the producer’s identification number; and
- (f) the country from which they have been, or are to be, consigned.”

### *Diabrotica virgifera virgifera* Le Conte

4.—(1) Hepgorer Rhan 7A(3) (parthau rheoli at ddibenion iechyd planhigion).

(2) Yn Rhan B (plâu planhigion y gwyddys eu bod yn digwydd yn yr Undeb Ewropeaidd) o Atodlen 1(4), hepgorer eitem 1a o dan y pennawd “Insects, mites and nematodes”.

### Article 19 (prohibitions on landing plant pests and relevant material)

3.—(1) For paragraph (6) of article 19(1), substitute—

“(6) Paragraph (7) applies to—

- (a) plants of *Castanea* Mill., *Fraxinus* L., *Pinus* L., *Platanus* L., *Quercus* L. or *Ulmus* L. intended for planting, which have been grown or are suspected to have been grown in another member State; or
- (b) plants of *Castanea* Mill., *Pinus* L., *Platanus* L., *Quercus* L. or *Ulmus* L. intended for planting, which have been grown or are suspected to have been grown in Switzerland and to which the requirements of article 6 do not apply.”

(2) For paragraph (8) of article 19(2), substitute—

“(8) The matters are—

- (a) the intended date of introduction of the plants;
- (b) their intended destination;
- (c) the quantity of the plants;
- (d) their genus and species;
- (e) the producer’s identification number; and
- (f) the country from which they have been, or are to be, consigned.”

### *Diabrotica virgifera virgifera* Le Conte

4.—(1) Omit Part 7A(3) (management zones for plant health purposes).

(2) In Part B (plant pests known to occur in the European Union) of Schedule 1(4), omit item 1a under the heading “Insects, mites and nematodes”.
