Mae'r Gorchymyn hwn yn rhoi effaith i adran 11(3), (4) ac adran 70 o Fesur Plant a Theuluoedd (Cymru) 2010 ("y Mesur").

Mae gweddill adran 11 eisoes mewn grym. Mae is-adran (3) yn gosod dyletswydd ar awdurdod lleol i sicrhau cyfleoedd chwarae digonol i blant yn ei ardal i'r graddau y mae'n rhesymol ymarferol gan roi sylw i'w asesiad a gwblhawyd yn unol â'i ddyletswydd o dan adran 11(1) o'r Mesur. Mae is-adran (4) yn ei gwneud yn ofynnol i awdurdodau lleol gyhoeddi gwybodaeth am gyfleoedd chwarae yn eu hardal a diweddarau'r wybodaeth hon.

Mae adran 70 yn nodi darpariaethau penodol mewn cysylltiad â chanllawiau a ddyroddir gan Weinidogion Cymru o dan y Mesur i gyrff y mae rhaid iddynt roi sylw i'r canllawiau. Mae adran 70(2)(a) yn darparu y caiff Gweinidogion Cymru roi canllawiau i gyrff yn gyffredinol neu i un corff penodol neu i gyrff penodol. Mae adran 70(2)(b) yn darparu y caniateir i ganllawiau gwahanol gael eu dyroddi i gyrff gwahanol neu mewn perthynas â hwy. Mae adran 70(2)(c) yn datgan bod rhaid i Weinidogion Cymru, cyn iddynt ddyroddi canllawiau, ymgynghori â'r gyrff hynny y mae rhaid iddynt roi sylw i'r canllawiau. Mae adran 70(2)(d) yn ei gwneud yn ofynnol i'r canllawiau gael eu cyhoeddi.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order brings into effect section 11(3), (4) and section 70 of the Children and Families (Wales) Measure 2010 ("the Measure").

The remainder of section 11 is already in force. Subsection (3) places a duty on a local authority to secure sufficient play opportunities in its area for children as far as reasonably practicable having regard to its assessment completed in accordance with its duty under section 11(1) of the Measure. Subsection (4) requires local authorities to publish information about play opportunities in their area and to keep this information up-to-date.

Section 70 sets out certain provisions in respect of guidance issued by the Welsh Ministers under the Measure to bodies that must have regard to it. Section 70(2)(a) provides that the Welsh Ministers may give guidance to bodies generally, or to one or more particular bodies. Section 70(2)(b) provides that different guidance may be issued to or in respect of different bodies. Section 70(2)(c) states that, before guidance is issued, the Welsh Ministers must consult the bodies that must have regard to the guidance. Section 70(2)(d) requires the guidance to be published.
