The Welsh Ministers, in exercise of the power conferred by section 241(3) of the Planning Act 2008<sup>(1)</sup>, make the following Order:

**Title**

1. The title of this Order is the Planning Act 2008 (Commencement No. 2) (Wales) Order 2014.

**Provisions coming into force on 8 August 2014 in relation to Wales**

2. The following provisions of the Planning Act 2008 (so far as they are not yet in force) come into force in relation to Wales on 8 August 2014—
  - (a) section 185; and
  - (b) section 199.
