**The M4 Motorway (Junction 34,
Miskin, Rhondda Cynon Taf and
the Vale of Glamorgan) (Temporary
Prohibition of Vehicles) Order 2014**

Made 15 July 2014

Coming into force 19 July 2014

The Welsh Ministers, being the traffic authority for the relevant lengths of the London – South Wales Motorway (M4) (hereinafter referred to as “the motorway”), are satisfied that traffic in specified lengths of the motorway should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984⁽¹⁾ and of all other enabling powers⁽²⁾, make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 19 July 2014. Its title is The M4 Motorway (Junction 34, Miskin, Rhondda Cynon Taf and the Vale of Glamorgan) (Temporary Prohibition of Vehicles) Order 2014.

2. —(1) In this Order:

“the lengths of the motorway” (“*y darnau o’r draffordd*”) means the entire lengths of the eastbound off slip road and westbound on slip road of the motorway at Junction 34, Miskin in the County Borough of Rhondda Cynon Taf and the County of the Vale of Glamorgan;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 22:30 hours on 19 July 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. Subject to the provisions of article 4, no person shall, during the works period, drive any vehicle or cause or permit any vehicle to proceed in the lengths of the motorway.

Application

4. The provisions of article 3 apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order shall be 6 months.
