Mae'r Gorchymyn hwn yn diwygio Gorchymyn Cynllunio Gwlad a Thref (Datblygu Cyffredinol a Ganiateir) 1995 (O.S. 1995/418) ("Gorchymyn 1995") mewn perthynas â Chymru. Mae erthygl 3 o Orchymyn 1995 ac Atodlen 2 iddo yn rhoi hawliau datblygu a ganiateir mewn perthynas â datblygu penodol. Nid oes angen gwneud cais penodol am ganiatâd cynllunio pan fo'r hawliau hyn yn gymwys.

Mae erthygl 2 yn diwygio Rhan 24 (datblygu gan weithredwyr cod cyfathrebu electronig (Cymru)) o Atodlen 2 i Orchymyn 1995.

Mae Dosbarth A o Ran 24 yn caniatáu datblygu penodol gan weithredwyr cod cyfathrebu electronig ar yr amod nad yw'n dod o fewn A.1 (datblygu nas caniateir) ac yn ddarostyngedig i unrhyw amodau a chyfyngiadau perthnasol yn A.2 ac A.3.

Mae erthygl 2(2) o'r Gorchymyn hwn yn diweddu'r cyfeiriad at drwydded gweithredwr i adlewyrchu newidiadau yn Neddf Cyfathrebiadau 2003.

The Town and Country Planning (General Permitted Development) (Amendment) (Wales) (No. 2) Order 2014

EXPLANATORY NOTE

(*This note is not part of the Order*)

This Order amends the Town and Country Planning (General Permitted Development) Order 1995 (S.I. 1995/418) ("the 1995 Order") in relation to Wales. Article 3 of and Schedule 2 to the 1995 Order confer permitted development rights in respect of certain development. Where such rights apply, no specific application for planning permission is required.

Article 2 amends Part 24 (development by electronic communications code operators (Wales)) of Schedule 2 to the 1995 Order.

Class A of Part 24 permits certain development by electronic communications code operators provided it does not fall within A.1 (development not permitted) and subject to any relevant conditions and limitations in A.2 and A.3.

Article 2(2) of this Order updates the reference to an operator's licence to reflect changes in the Communications Act 2003.

Mae cyfyngiadau ac amodau ar roi caniatâd cynllunio yn cynnwys, er enghraifft, eithrio'r caniatâd Dosbarth A rhag bod yn gymwys i dir gwarchodedig mewn rhai achosion. Mae tir gwarchodedig yn cynnwys safleoedd o ddiddordeb gwyddonol arbennig a chategorïau o dir a nodir yn erthygl 1(5) o Orchymyn 1995 a Rhan 2 o Atodlen 1 iddo (Parciau Cenedlaethol, ardaloedd o harddwch naturiol eithriadol, ardaloedd cadwraeth, ardaloedd o harddwch naturiol ac amwynder yng nghefn gwlad). Mae'n bosibl y bydd mathau eraill o ganiatâd yn ddarostyngedig i gymeradwyaeth yr awdurdod cynllunio lleol o ran lleoliad ac ymddangosiad. Cyfeirir at y broses hon fel "cymeradwyaeth ymlaen llaw".

Mae erthygl 2(3) yn mewnosod darpariaeth newydd er mwyn caniatâu addasu neu amnewid mastiau presennol sy'n sefyll ar eu traed eu hunain i ddod yn fastiau hyd at 20 o fetrau o uchder a hyd at draean yn lletach na'r mast presennol. Nid yw hyn yn gymwys ar dir erthygl 1(5) nac ar safle o ddiddordeb gwyddonol arbennig, ac mae'n ddarostyngedig i gymeradwyaeth ymlaen llaw ar dir arall yn rhinwedd paragraff A.2(4) o Ddosbarth A. O ran lled, ar unrhyw uchder penodol, ni chaff y mast newydd neu'r mast a uwchraddiwyd fod yn fwy na thraean yn lletach na'r mast gwreiddiol ar yr un uchder.

Mae erthygl 2(4) yn dileu antena cell fach o baragraff A.1(g)(i). Mae hyn yn golygu nad yw'r cyfyngiad yn y paragraff hwnnw'n gymwys i antena cell fach.

Mae erthygl 2(5) i (8) yn diwygio darpariaethau yn Nosbarth A er mwyn caniatâu i faint pob antena dysgl gyda'i gilydd fod yn fwy, ac i ragor o systemau antena gael eu gosod ar rai adeiladau a strwythurau. Mae'r rheolau newydd yn amrywio yn ôl uchder yr adeilad neu'r strwythur, gan ganiatâu rhagor o systemau antena, a chaniatâu i faint y dysglau gyda'i gilydd fod yn fwy, uwchlaw 15 o fetrau.

Mae erthygl 2(9) yn gwneud darpariaeth ganlyniadol i erthygl 2(10) a (13).

Mae erthygl 2(10) yn mewnosod darpariaeth newydd er mwyn caniatâu gosod hyd at dri antena dysgl ychwanegol a thri antena ychwanegol nad ydynt yn rhai dysgl, yn ddarostyngedig i gyfyngiadau maint, ar gyfarpar cyfathrebiadau electronig presennol sydd wedi eu gosod ar adeiladau neu strwythurau (gan gynnwys mastiau) ar dir erthygl 1(5). Mae diffiniad a ychwanegwyd gan erthygl 2(19)(c) yn egluro bod rhaid i'r cyfarpar eisoes fod yn anfon ac yn derbyn cyfathrebiadau. Mae'r hawl datblygu a ganiateir newydd hon wedi ei heithrio o baragraff A.1(i) o

Limitations and conditions on the grant of planning permission include, for example, excluding the Class A permission from application to protected land in certain cases. Protected land comprises sites of special scientific interest and categories of land identified in article 1(5) of, and Part 2 of Schedule 1 to, the 1995 Order (National Parks, areas of outstanding natural beauty, conservation areas, countryside areas of natural beauty and amenity). Other permissions may be subject to the approval of the local planning authority on siting and appearance, a process referred to as "prior approval".

Article 2(3) inserts a new provision to allow existing freestanding masts to be altered or replaced to become masts up to 20 metres high and up to a third wider than the existing mast. This does not apply on article 1(5) land nor on a site of special scientific interest, and is subject to prior approval on other land by virtue of paragraph A.2(4) of Class A. On width, at any given height, the new or upgraded mast may be no more than a third wider than the original mast at the same height.

Article 2(4) removes small cell antenna from paragraph A.1(g)(i). This means that the limitation in that paragraph does not apply to small cell antenna.

Article 2(5) to (8) amends provisions in Class A to allow larger aggregate sizes of all dish antennas and more antenna systems to be attached to certain buildings and structures. The new rules vary according to the height of the building or structure, with larger aggregate sizes for dishes and more antenna systems allowed above 15 metres.

Article 2(9) makes provision consequential on article 2(10) and (13).

Article 2(10) inserts a new provision to permit up to three additional dish antennas and three non-dish antennas, subject to size limits, to be attached to existing electronic communications apparatus attached to buildings or structures (including masts) on article 1(5) land. A definition added by article 2(19)(c) clarifies that the apparatus must already be sending and receiving communications. This new permitted development right is excepted from paragraph A.1(i)

Ddosbarth A sydd fel arall yn cyfyngu'n sylweddol ar ddatblygu antena ar dir erthygl 1(5).

Mae erthygl 2(11) a (12) yn diwygio darpariaethau i egluro bod y cyfyngiadau presennol o ran maint unedau cartrefu offer radio mewn un achos yn gronol ac mewn achos arall yn gymwys i gynigion datblygu unigol. Mae erthygl 2(14) yn cynnwys diwygiad canlyniadol i baragraff A.2(4) o Ddosbarth A.

Mae erthygl 2(13) yn mewnosod darpariaeth newydd er mwyn caniatáu gosod hyd at ddau o fath newydd o antena ("antena cell fach") ar adeiladau a strwythurau eraill (ac eithrio tai anedd neu o fewn cwrtiwl tŷ anedd), ar yr amod nad ydynt ar safle o ddiddordeb gwyddonol arbennig. Caiff y datblygiad hwn ei ganiatáu ar dir erthygl 1(5) yn rhinwedd eithriad i'r rheol gyffredinol ym mharagraff A.1(i) o Ddosbarth A, ond yn ddarostyngedig i gymeradwyaeth ymlaen llaw yn rhinwedd paragraff A.2(4)(a) o Ddosbarth A. Mae erthygl 2(19)(c) yn mewnosod diffiniad newydd o "antena cell fach" ("*small cell antenna*"), sy'n cynnwys cyfyngiadau o ran maint.

Mae erthygl 2(14) yn mewnosod fersiwn newydd o baragraff A.2(4) o Ddosbarth A. Mae'r newidiadau yn cynnwys: cynyddu'r uchder y mae'n ofynnol i antenau a osodir ar adeiladau neu strwythurau (heblaw am fastiau) fynd drwy'r broses cymeradwyaeth ymlaen llaw; egluro mai dim ond pan fo cyfaint unrhyw ddatblygiad unigol o uned gartrefu offer radio yn fwy na 2.5 o fetrau ciwbig y mae angen cymeradwyaeth ymlaen llaw; a dileu'r angen am gymeradwyaeth ymlaen llaw ar gyfer datblygiad sy'n atodol i uned gartrefu offer radio.

Mae erthygl 2(15) yn darparu, mewn perthynas â thir erthygl 1(5), na fydd angen cymeradwyaeth ymlaen llaw o dan baragraff A.3 o Ran 24 ar gyfer adeiladu, gosod nac amnewid polion, cabinetau na llinellau telegraff ar gyfer gwasanaethau band eang llinell sefydlog. Er mwyn dibynnu ar y newid hwn i'r hawliau datblygu a ganiateir, rhaid cwblhau'r gwaith datblygu cyn 30 Mai 2018 a rhaid cydymffurfio â'r amodau a gyflwynir gan erthygl 2(15). Dyma'r amodau:

- yn achos datblygu mewn Parciau Cenedlaethol ac ardaloedd o harddwch naturiol eithriadol, rhaid rhoi un mis o rybudd o'r datblygiad arfaethedig i Gorff Adnoddau Naturiol Cymru, ac os yw unrhyw ran o'r datblygiad mewn Parc Cenedlaethol, i'r cyngor sir neu'r cyngor bwrdeistref sirol ar gyfer yr ardal;
- rhaid i cabinetau fod yn ddu (nid du disglein), yn wyrdd neu'n lliw arall a gymeradwywyd gan yr awdurdod cynllunio lleol;

of Class A which otherwise substantially limits the development of antenna on article 1(5) land.

Article 2(11) and (12) amend provisions to clarify that current size limits for radio equipment housing are in one case cumulative and in another case applicable to single development proposals. Article 2(14) includes a consequential amendment to paragraph A.2(4) of Class A.

Article 2(13) inserts a new provision to allow up to two of a new sort of antenna ("small cell antenna") to be attached to buildings and other structures (other than dwellinghouses or within the curtilage of a dwellinghouse), as long as they are not on a site of special scientific interest. This development is permitted on article 1(5) land by virtue of an exception to the general rule at paragraph A.1(i) of Class A, but subject to prior approval by virtue of paragraph A.2(4)(a) of Class A. Article 2(19)(c) inserts a new definition of "small cell antenna", which includes size restrictions.

Article 2(14) inserts a new version of paragraph A.2(4) of Class A. Changes include: increasing the height at which antennas attached to buildings or structures (other than masts) are required to go through the prior approval process; clarifying that prior approval is only required when any single development of radio equipment housing has a volume in excess of 2.5 cubic metres; and removing the need for prior approval for development ancillary to radio equipment housing.

Article 2(15) provides that, in relation to article 1(5) land, the construction, installation or replacement of telegraph poles, cabinets or lines for fixed-line broadband services will not require prior approval under paragraph A.3 of Part 24. In order to rely on this change to the permitted development rights, development must be completed before 30 May 2018 and the conditions introduced by article 2(15) must be complied with. The conditions are:

- in the case of development in National Parks and areas of outstanding natural beauty, one month's notice of the proposed development is to be given to the Natural Resources Body for Wales and where any part of the development is in a National Park, to the county or county borough council for the area;
- cabinets must be black (not matt black), green or another colour approved by the local planning authority;

Caiff diffiniadau newydd sy'n ymwneud â'r ddarpariaeth hon eu mewnosod yn erthygl 2(19).

Mae erthygl 2(16) yn mewnosod gofyniad i gyflwyno manylion cyswllt y datblygwr gyda chais am gymeradwyaeth ymlaen llaw.

Mae erthygl 2(17) yn eithrio datblygiad sy'n cynnwys antenau cell fach rhag y gofyniad presennol ar ddatblygwr i gyflwyno datganiad ysgrifenedig ei fod yn cydymffurfio â chanllawiau'r Comisiwn Rhyngwladol ar Ddiogelu rhag Pelydredd nad yw'n lloineiddio gyda chais am gymeradwyaeth ymlaen llaw o dan Ddosbarth A.3(4).

Mae erthygl 2(18) yn mewnosod darpariaeth newydd i'r gweithdrefnau cymeradwyaeth ymlaen llaw ym mharagraff A.3 o Ddosbarth A, i egluro nad yw cais newydd am gymeradwyaeth ymlaen llaw yn ofynnol os yw'r datblygwr a'r awdurdod cynllunio lleol yn cytuno ar fân ddiwygiadau i ddatblygiad a gynigiwyd mewn cais am gymeradwyaeth ymlaen llaw.

Mae erthygl 2(19) yn mewnosod diffiniadau newydd ac yn gwneud diwygiadau canlyniadol iddynt.

Pan fo Dosbarth A yn rhoi caniatâd cynllunio i ddatblygu cyfarpar cyfathrebiadau electronig, mae erthygl 2(20) yn mewnosod darpariaeth newydd sy'n egluro bod y caniatâd hwnnw'n cynnwys datblygiad penodol sy'n atodol i'r cyfarpar, ac sy'n rhesymol o'fynnol at ei ddiben. Mae'r prawf "rhesymol o'fynnol" ("reasonably required") yn sicrhau bod unrhyw ddatblygiad atodol o'r fath yn ymwneud â'r cyfarpar penodol sy'n cael ei ddatblygu ac nad yw at ddiben datblygiad a ragwelir yn y dyfodol. Nid yw'r ddarpariaeth ddehongli hon yn cynnwys datblygiad ar safle o ddiddordeb gwyddonol arbennig.

— telegraph poles must match the nearest existing telegraph pole which has planning permission unless otherwise approved by the local planning authority.

New definitions relating to this provision are inserted in article 2(19).

Article 2(16) inserts a requirement for developer contact details to be submitted with an application for prior approval.

Article 2(17) excepts development comprising small cell antennas from the existing requirement on a developer to submit a written declaration of compliance with guidelines of the International Commission on Non-ionising Radiation Protection with an application for prior approval under Class A.3(4).

Article 2(18) inserts a new provision into the prior approval procedures at paragraph A.3 of Class A, to clarify that where minor amendments to development proposed in a prior approval application are agreed between the developer and the local planning authority, a new application for prior approval is not required.

Article 2(19) inserts new, and makes consequential amendments to, definitions.

Article 2(20) inserts a new provision which clarifies that where Class A gives planning permission for the development of electronic communications apparatus, that permission extends to certain development ancillary to and reasonably required for the purpose of that apparatus. The "reasonably required" test ensures that such ancillary development relates to the particular apparatus being developed and is not for the purpose of future anticipated development. This interpretative provision does not extend to development on a site of special scientific interest.

The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 59, 60, 61 and 333 of the Town and Country Planning Act 1990(1) and now exercisable by them(2), make the following Order:

Title, commencement and application

1.—(1) The title of this Order is the Town and Country Planning (General Permitted Development) (Amendment) (Wales) (No. 2) Order 2014 and it comes into force on 7 November 2014.

(2) This Order applies in relation to Wales.

Amendments in relation to development by electronic communications code operators

2.—(1) Part 24 of Schedule 2 to the Town and Country Planning (General Permitted Development) Order 1995⁽¹⁾ (development by electronic communications code operators (Wales)) is amended as follows.

(2) In paragraph A (permitted development), for “in accordance with the operator’s licence”, substitute “in accordance with the electronic communications code”.

(3) For paragraph A.1(b) (alteration or replacement of apparatus other than on a building or other structure) substitute—

- “(b) in the case of the alteration or replacement of apparatus already installed, (other than on a building or structure)—
 - (i) where the apparatus is a mast which is not on article 1(5) land or on any land which is, or is within, a site of special scientific interest—
 - (aa) the mast, excluding any antenna, would when altered or replaced either exceed a height of 20 metres above ground level or at any given height exceed the width of the existing mast at the same height by more than one third; or
 - (bb) where antenna support structures are altered or replaced, the combined width of the mast and any antenna support structures would exceed the combined width of the existing mast and any antenna support structures by more than one third;
 - (ii) in all other cases, the apparatus, excluding any antenna, would, when altered or replaced exceed the greater of—
 - (aa) the height of the existing apparatus; or
