# ROAD TRAFFIC, WALES

The M4 Motorway (Eastbound Carriageway between Junction 28 (Tredegar Park) & Junction 24 (Coldra), Newport) (Temporary Prohibition of Vehicles) Order 2014

Made 7 November 2014

Coming into force 13 November 2014

The Welsh Ministers, being the traffic authority for the relevant length of the London – South Wales Motorway (M4) ("the motorway"), are satisfied that traffic in a specified length of the motorway should be prohibited because of works proposed on or near the motorway.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

### **Title, Interpretation and Commencement**

**1.** This Order comes into force on 13 November 2014 and its title is The M4 Motorway (Eastbound Carriageway between Junction 28 (Tredegar Park) & Junction 24 (Coldra), Newport) (Temporary Prohibition of Vehicles) Order 2014.

#### **2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the motorway" ("y darn o'r draffordd") means the length of the eastbound carriageway of the motorway in the City of Newport that extends from the nosing of the eastbound exit slip road at Junction 28 (Tredegar Park) to the nosing of the eastbound entry slip road at Junction 24 (Coldra);

"works period" ("cyfnod y gwaith") means that period commencing at 21:00 hours on 13 November 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibition**

**3.** Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the motorway.

## **Application**

**4.** The provisions of article 3 apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

#### **Duration of this Order**

**5.** The maximum duration for this Order shall be 6 months.
