**The A458 Trunk Road (Church
Street, Welshpool, Powys)
(Temporary Prohibition of Vehicles
& Cyclists) Order 2015**

Made 11 May 2015

Coming into force 18 May 2015

The Welsh Ministers, being the traffic authority for the relevant length of the Shrewsbury – Dolgellau Trunk Road (A458) (“the trunk road”), are satisfied that traffic in a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984⁽¹⁾ and of all other enabling powers⁽²⁾, make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 18 May 2015 and its title is The A458 Trunk Road (Church Street, Welshpool, Powys) (Temporary Prohibition of Vehicles & Cyclists) Order 2015.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the trunk road known as Church Street at Welshpool in the County of Powys that extends from its junction with Mill Lane to its junction with The Cross;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 08:00 hours on 18 May 2015 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions

3. Subject to the provisions of article 5, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road.

4. Subject to the provisions of article 5, no person shall, during the works period, ride, or cause or permit any pedal cycle to be ridden in the length of the trunk road.

Application

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as the application of the prohibitions referred to therein is indicated by traffic signs.

Duration of this Order

6. The maximum duration for this Order shall be 6 months.
