Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) 1997 ("y Rheoliadau Optegol") sy'n darparu ar gyfer taliadau i'w gwneud drwy system dalebau mewn cysylltiad â'r costau yr eir iddynt gan gategoriâu penodol o bersonau mewn cysylltiad â phroffion golwg a chyflenwi, amnewid a thrwsio teclynnau optegol.

Mae rheoliad 2 yn diwygio rheoliad 1 o'r Rheoliadau Optegol er mwyn cyfeirio at gynnydd o 1% yn y ffi ar gyfer prawf golwg y GIG.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the National Health Service (Optical Charges and Payments) Regulations 1997 ("the Optical Regulations") which provide for payments to be made by means of a voucher system in respect of costs incurred by certain categories of persons in connection with sight tests and the supply, replacement and repair of optical appliances.

Regulation 2 amends regulation 1 of the Optical Regulations so as to make reference to an increase in the NHS sight test fee of 1%.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Title, commencement, application and interpretation

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Ffioedd a Thaliadau Optegol) (Diwygio) (Cymru) (Rhif 2) 2015.

1.—(1) The title of these Regulations is the National Health Service (Optical Charges and Payments) (Amendment) (Wales) (No.2) Regulations 2015.
